

## **LIMITED JURISDICTION COURTS**

### **Narrative Summary**

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) increased 1.6% in FY 2005, from 2,289,179 last year to 2,325,396. Traffic cases comprised the majority (68.1%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) increased by 1.1%, from 1,566,638 last year to 1,583,538 in FY 2005. Criminal filings (misdemeanors and felonies) increased by 0.7%, from 378,500 in FY 2004 to 380,968 in FY 2005.

Breaking a six year trend, petitions for orders of protection in domestic violence cases decreased from 24,421 in FY 2004 to 23,694 in FY 2005, a decrease of 3.0%. Petitions for injunctions against harassment increased, from 19,515 in FY 2004 to 20,331 in FY 2005, an increase of 4.2%.

Total dispositions (including transfers) increased by .7%, from 2,286,559 last year to 2,302,613 in FY 2005. Traffic dispositions (criminal and civil) decreased by 0.1% while criminal dispositions (misdemeanor and felony) increased by 1.8 % from last year. Only 14.6% of the orders of protection and 24.4% of the harassment petitions ruled upon were denied.

Total end of year pending cases decreased from 1,479,491 in FY 2004 to 1,450,631 in FY 2005, a decrease of 2.0%. Most of the decrease was in the civil and criminal traffic category, which decreased from 696,683 in FY 2004 to 649,607 in FY 2005, a decrease of 6.8%.

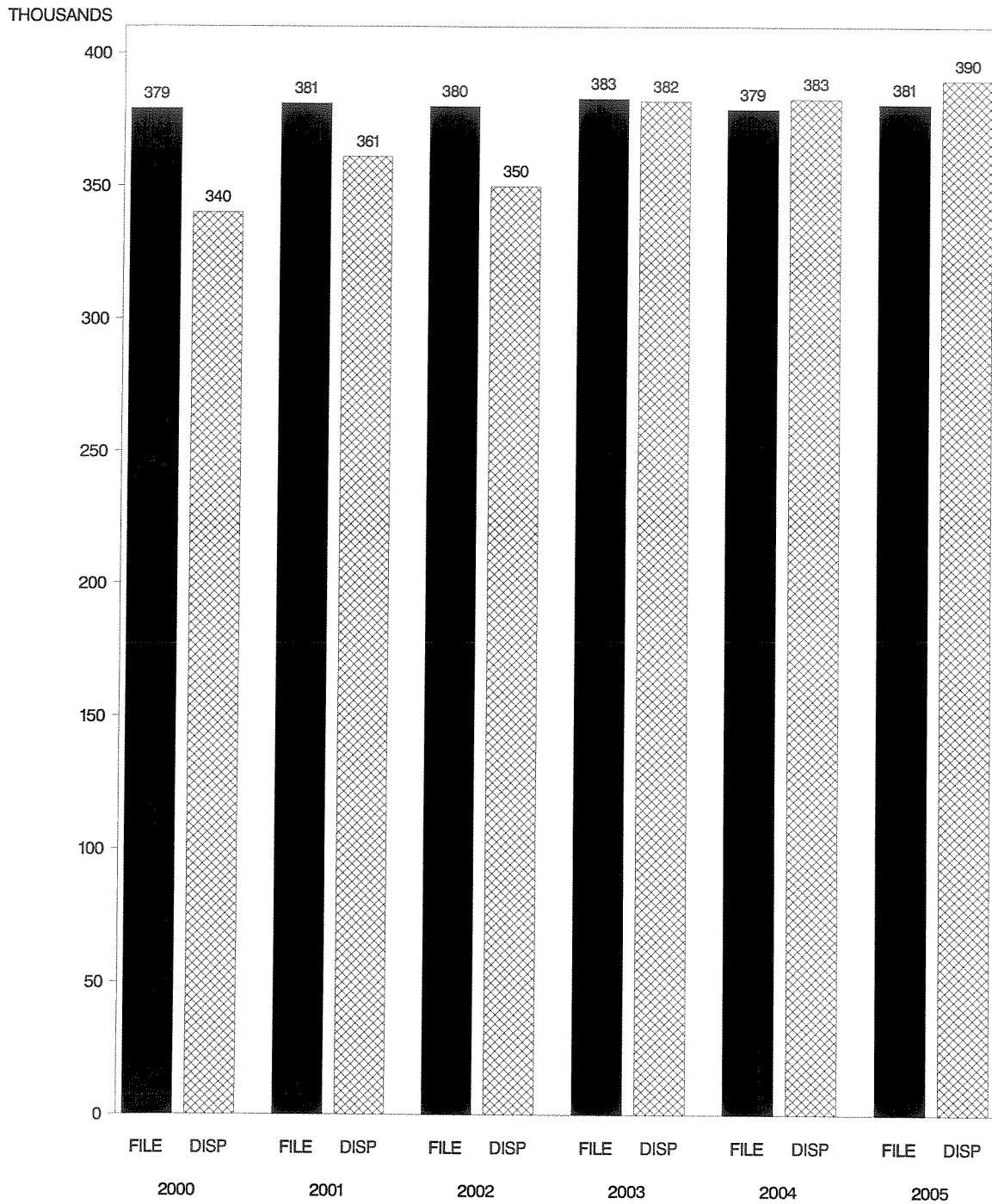

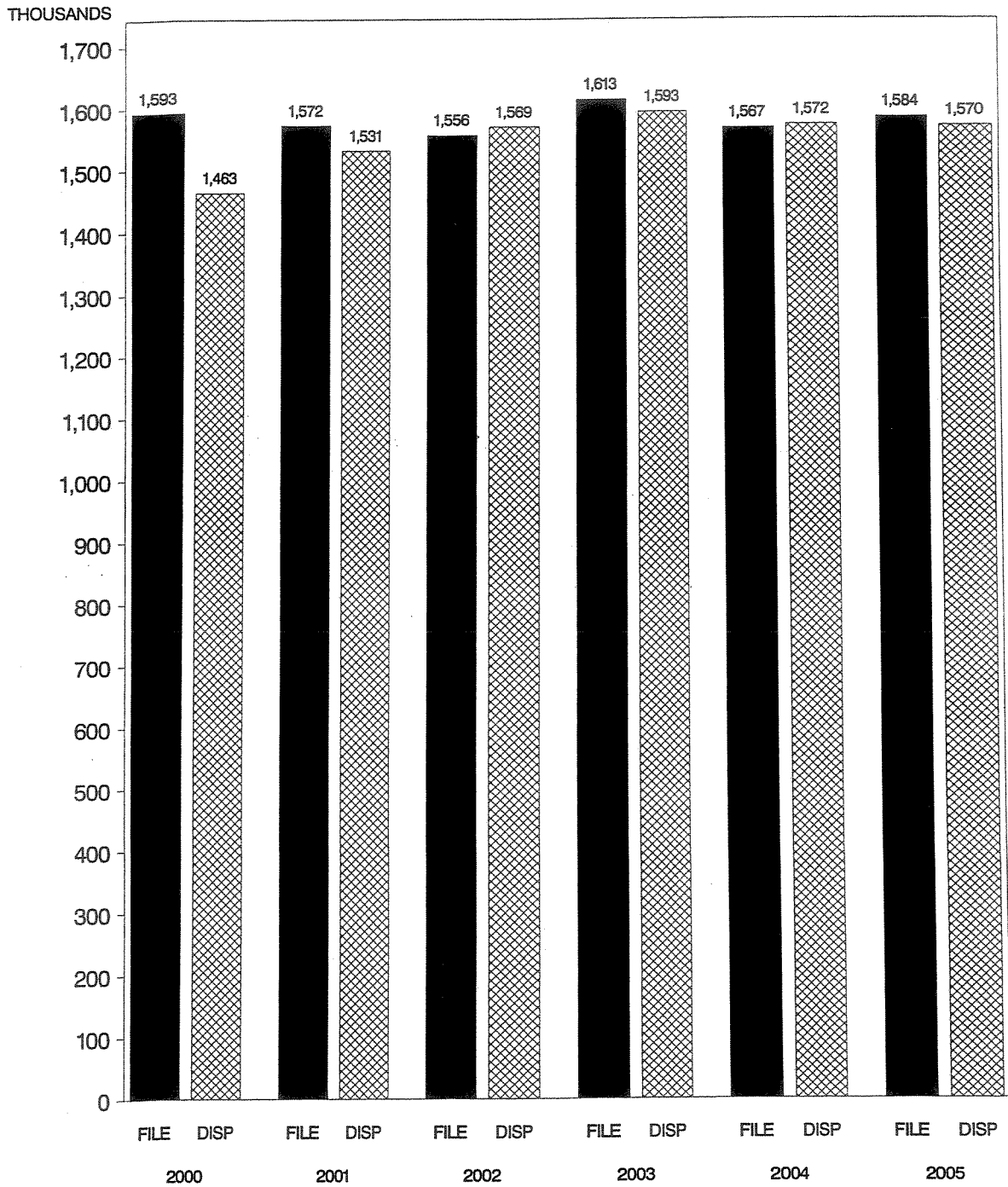

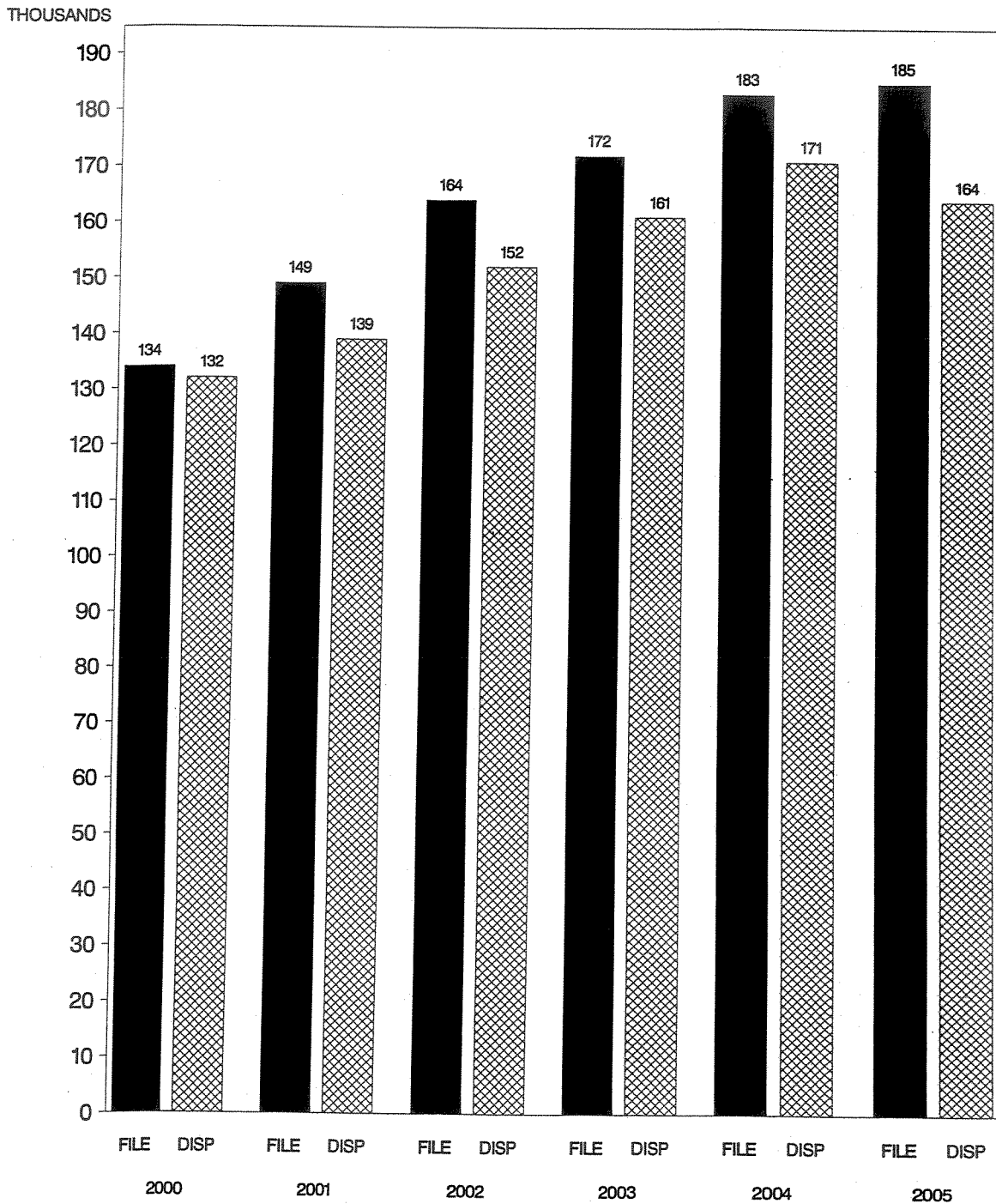

CASES FILED AND DISPOSED



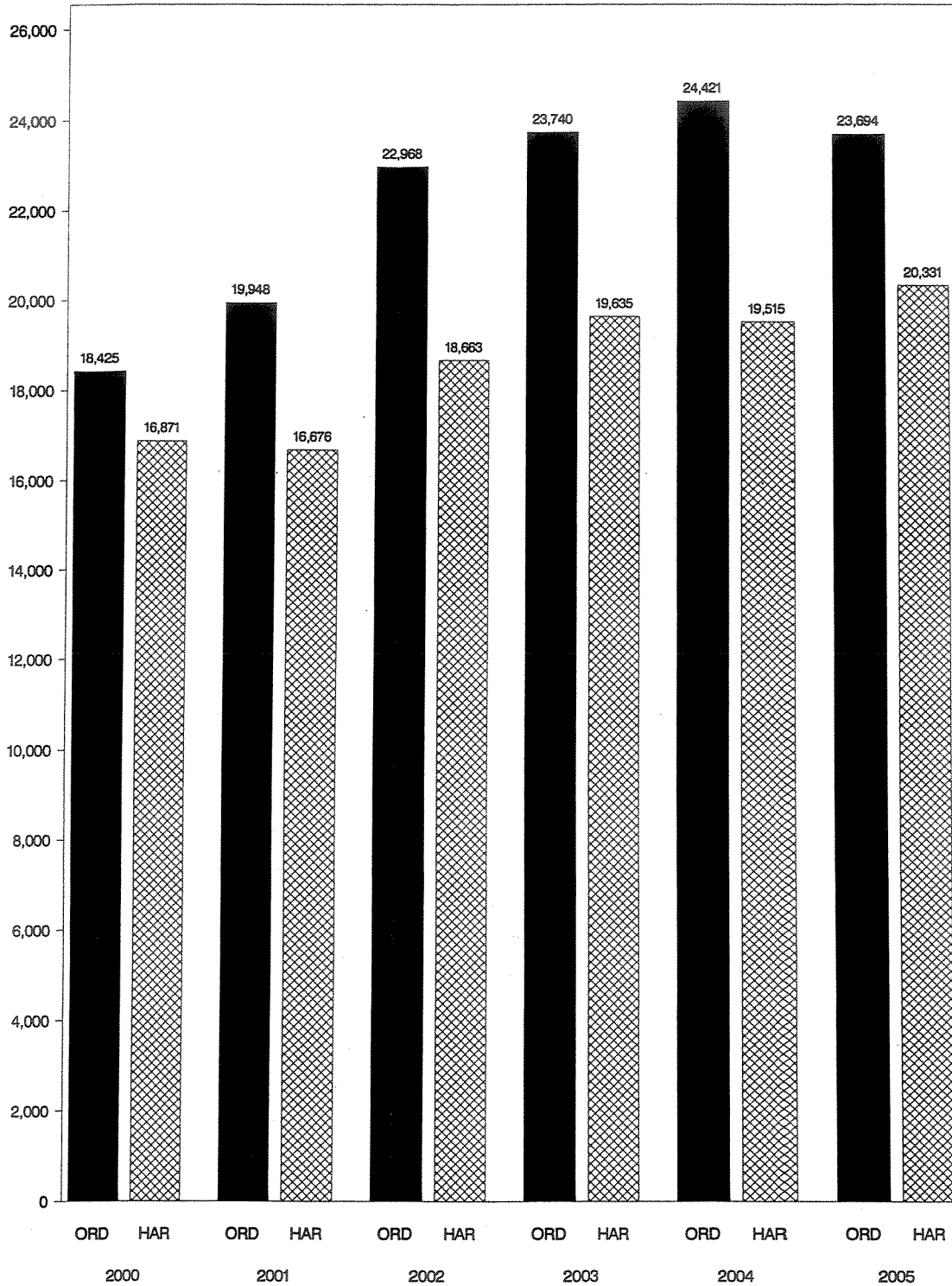
