

## ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive) Case Activity**, the second covers **Standard Adult Probation** alone, and the third only **Intensive Adult Probation**. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second table concerns **Probationers with Petitions to Revoke**, and the third table summarizes **Additional Probation Activity**.

There were a total of 36,459 individuals added to the active **standard and intensive probation** population and 12,438 added to the absconder population during FY 2004. As of the end of FY 2004, there were 36,803 active standard and intensive probationers and 12,317 absconders in Arizona, a total of 49,120 individuals. A total of 9,168 petitions to revoke were filed during the fiscal year, and 8,268 absconders were apprehended and brought back before the court. Of all the probation violation matters brought back before the court in FY 2004, dispositions were achieved in 16,949 cases and there were 2,888 petitions to revoke pending at the end of the fiscal year. Additionally, probationers completed 1,429,005 community service hours in FY 2004 (9.4% less than FY 2003) and probation officers completed 32,379 presentence reports (up 4.5% over FY 2003). Standard and intensive probationers paid \$36,769,212 in restitution, reimbursement, fines, surcharges and fees (7.5% increase over FY 2003) and intensive probationers paid \$1,686,075 in state and federal income taxes.

There were 31,205 individuals added to the active **standard** probation population and 11,299 added to the standard absconder population in FY 2004. During the fiscal year, 30,404 individuals were terminated from standard probation and 10,415 absconder warrants were closed. On June 30, 2004, there were 33,880 active standard probationers and 11,233 standard probation absconders. A total of 7,598 petitions to revoke were filed on standard probationers during FY 2004, and 7,368 absconders were apprehended and brought back before the court. Of all the standard probation violation matters brought back before the court, dispositions were achieved in 14,538 cases, leaving 2,475 petitions to revoke pending at the end of the fiscal year. Standard probationers completed 813,823 community service hours and paid a total of \$34,483,007 in court ordered penalties.

During FY 2004, 5,254 individuals were added to the active **intensive** probation population and 1,139 added to the intensive absconder population. Over the course of the year, 4,730 individuals were terminated from intensive probation and 1,007 absconder warrants were closed. At the close of the fiscal year there were 2,923 active intensive probationers and 1,084 intensive probation absconders. A total of 1,570 petitions to revoke were filed on intensive probationers during FY 2004 and 900 absconders were apprehended and brought back before the court. Of all the intensive probation violation matters brought back before the court, 2,411 reached disposition, leaving 413 intensive petitions to revoke pending at the end of the fiscal year. Intensive probationers completed 615,182 hours of community service and paid \$3,972,265 in fines, restitution and other monies.
