

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were up by 0.4%, from 177,722 in FY 2000 to 178,470 this year. Superior Court's largest category, domestic relations, experienced a slight decrease of .5%, from 49,656 in FY 2000 to 49,388 in FY 2001. The next largest category, criminal, increased by 11.0%, from 42,688 in FY 2000 to 47,380 in FY 2001. Total civil filings decreased by 8.5%, from 44,844 in FY 2000 to 41,025 in FY 2001. These three categories account for 77.2% of the Superior Court total filings.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2001, these petitions together increased by 14.4%, from 5,449 in FY 2000 to 6,236 in FY 2001. Separately, orders of protection were up by 16.9% from FY 2000 and injunctions against harassment increased by 5.5% in FY 2001. Juvenile delinquent and incorrigible filings decreased slightly, from 21,328 to 21,155 or 0.4%.

Total dispositions (including transfers) were up from 161,707 in FY 2000 to 176,606 in FY 2001, an increase of 9.2%. Domestic relations dispositions experienced a large increase of 11.0%, from 45,653 in FY 2000 to 50,668 in FY 2001. Civil dispositions increased 10.8%, from 45,357 in FY 2000 to 50,565 in FY 2001. Criminal dispositions increased the most in FY2001, from 38,589 in FY 2000 to 45,111 in FY 2001, an increase of 16.9%. These three categories account for 82.9% of the dispositions in Superior Court.

Total end of year pending cases showed an increase of 2,566 or 1.4%, from 186,104 in FY 2000 to 188,670 in FY 2001.

**In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.**

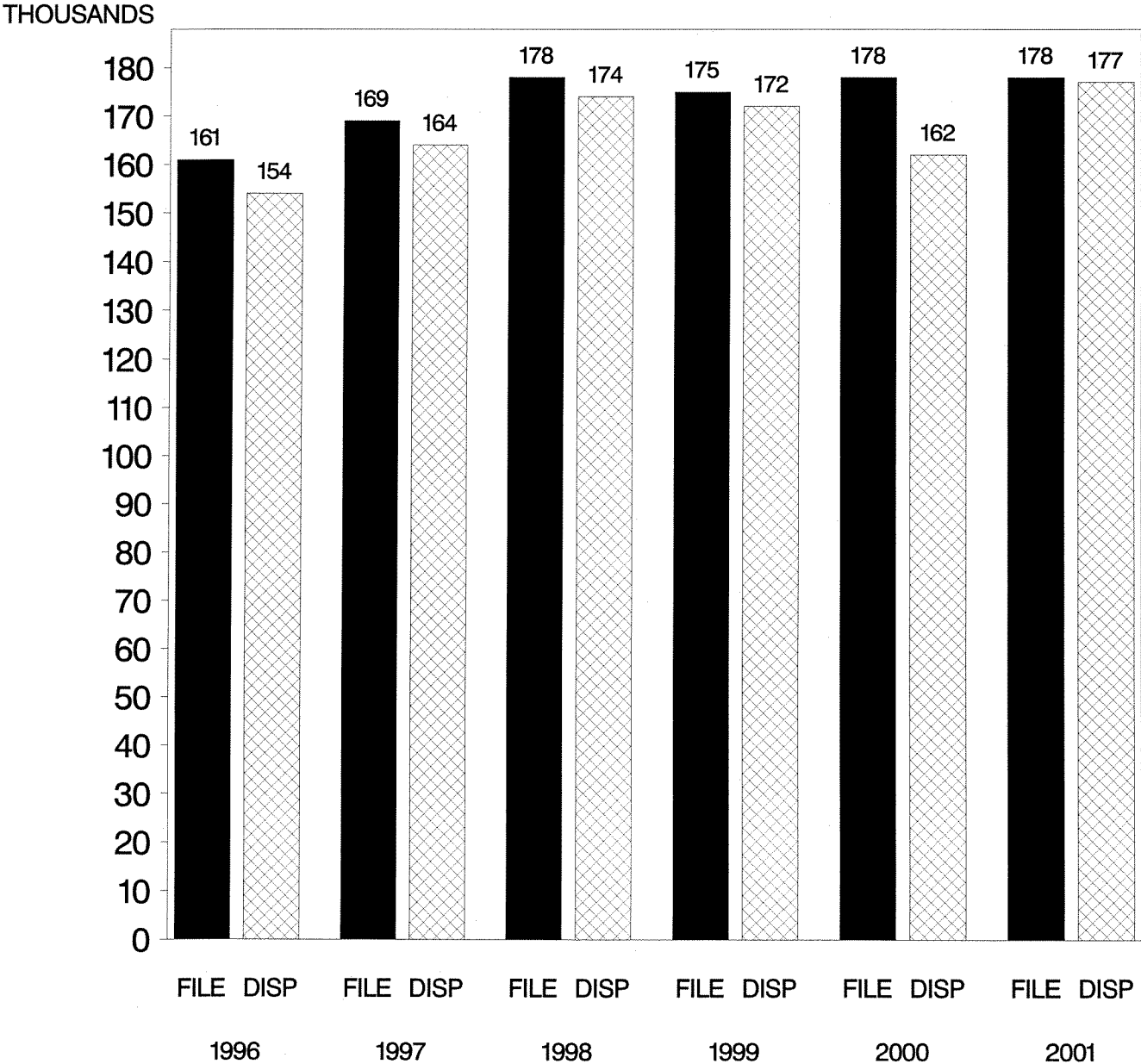

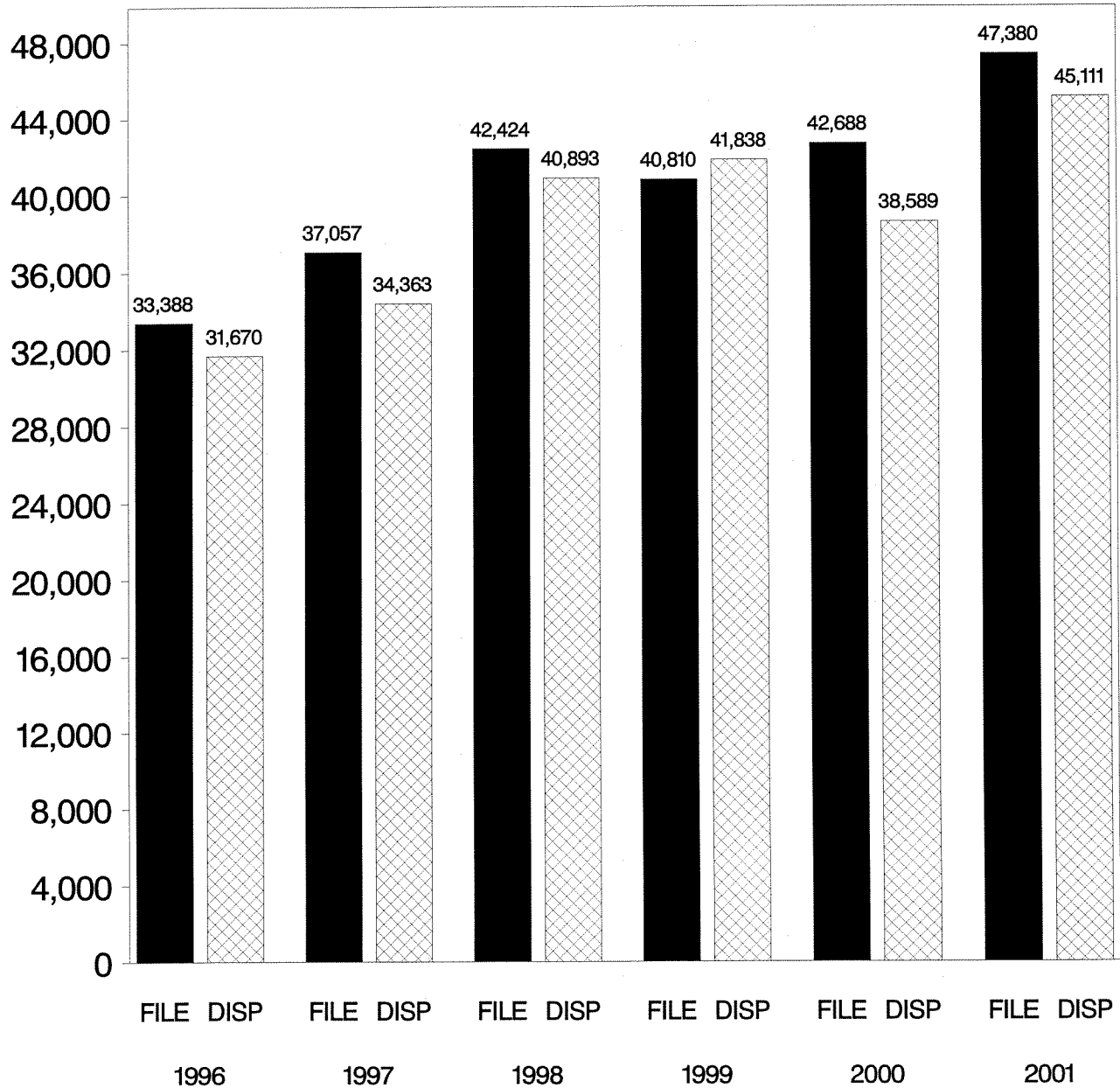
## ANNUAL CASE ACTIVITY, FY 1996–2001 CASES FILED AND DISPOSED

## CRIMINAL CASE ACTIVITY, FY 1996 – 2001 CASES FILED AND DISPOSED

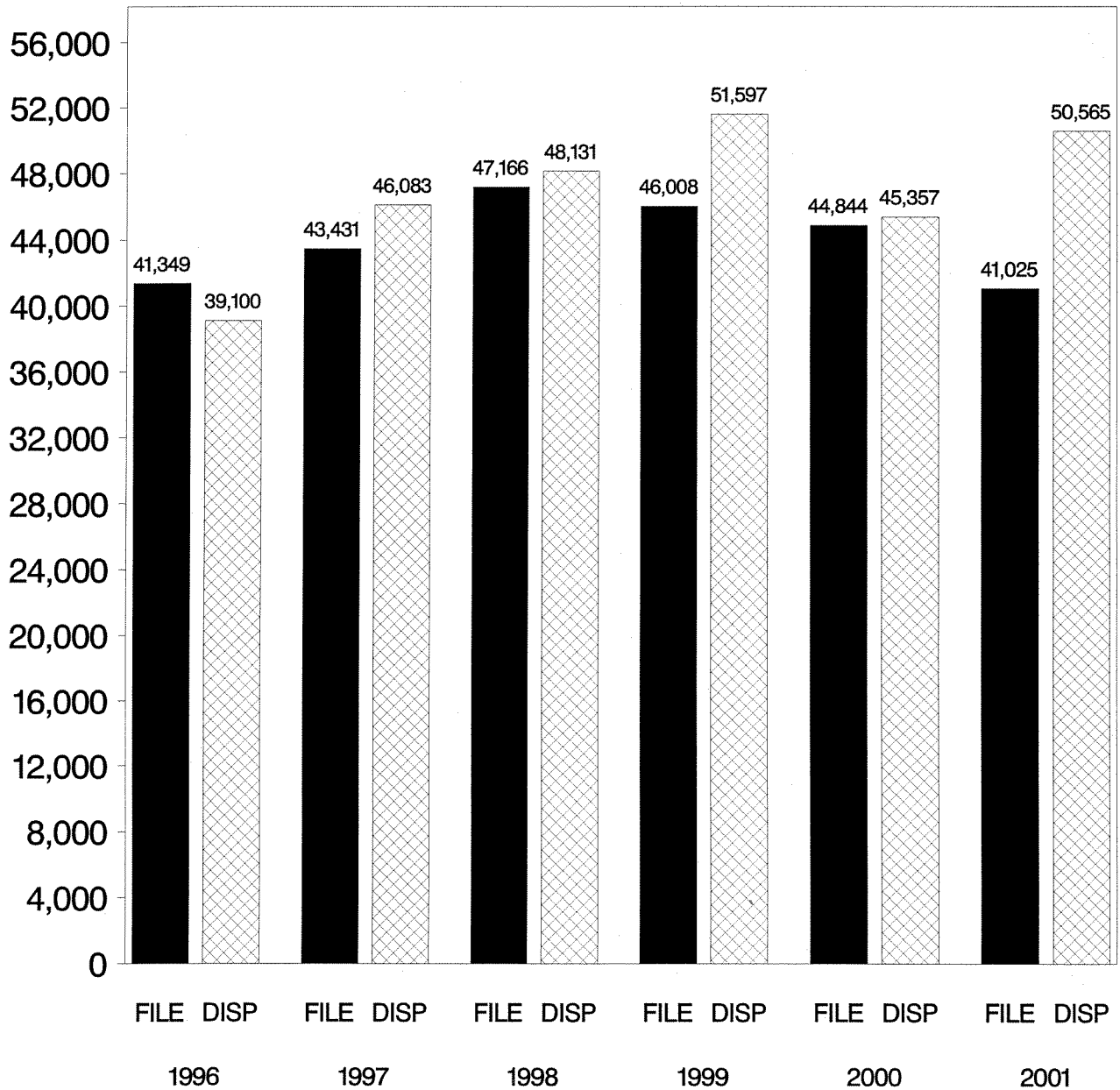

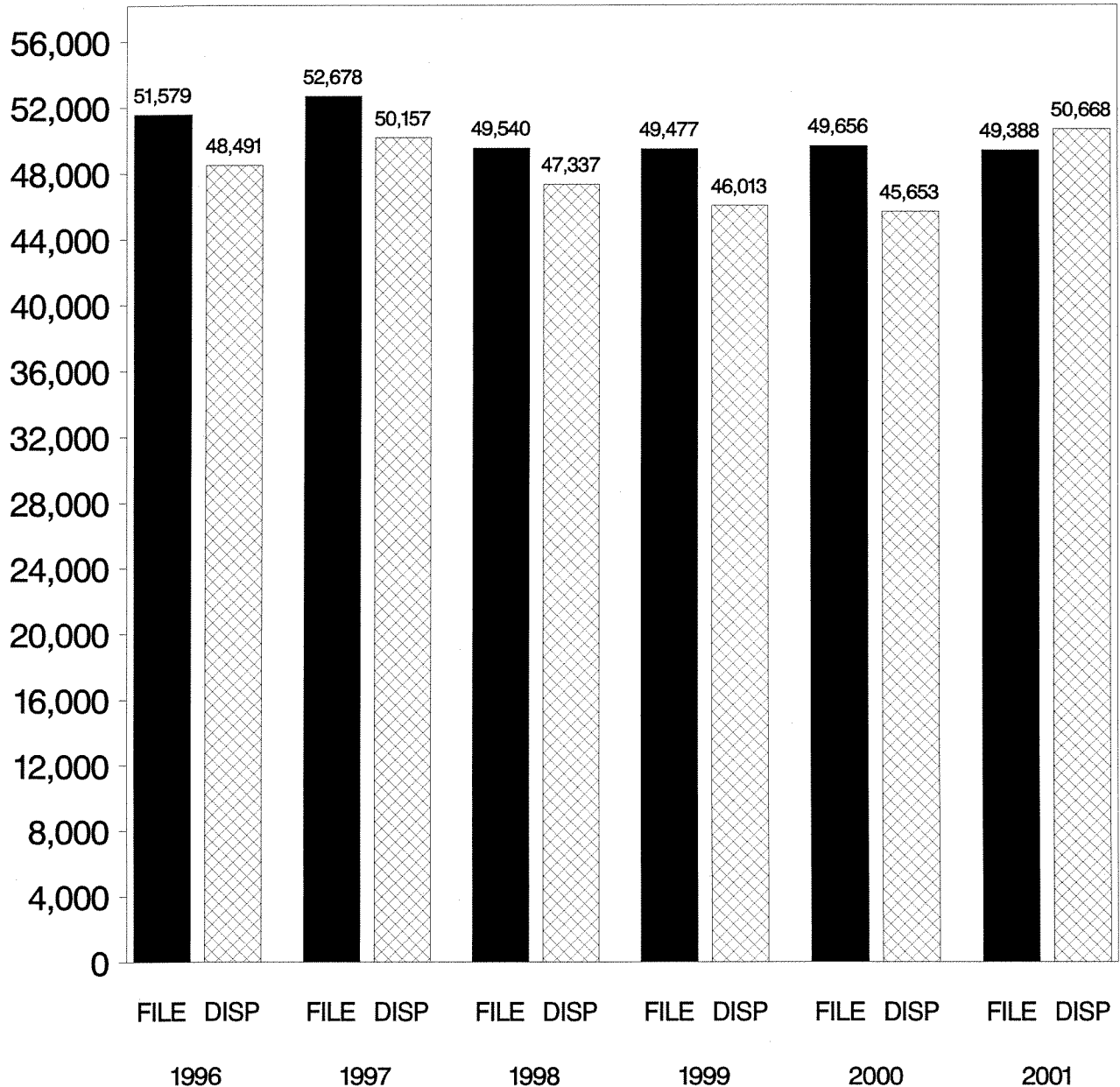
### CASES FILED AND DISPOSED
