

SUPERIOR COURT Narrative Summary

Total filings (including transfers in) were up by 0.4%, from 204,681 in FY 2004 to 205,516 this fiscal year. Superior Court's largest category, criminal filings, experienced an increase of 0.5%, from 56,078 in FY 2004 to 56,359 in FY 2005. The next largest category, domestic relations increased by 1.2%, from 53,434 in FY 2004 to 54,093 in FY 2005. Civil case filings increased by 0.7%, from 52,523 in FY 2004 to 52,885 in FY 2005. These three categories account for 79.5% of the Superior Court total filings.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2005, these petitions together increased by 9.8 %, from 9,660 in FY 2004 to 10,609 in FY 2005. Separately, orders of protection were up by 12.2% from FY 2004 while injunctions against harassment increased by 1.9% in FY 2005. Juvenile delinquent and incorrigible filings decreased, from 19,434 to 19,092 or 1.8%.

Total dispositions (including transfers) were down from 207,485 in FY 2004 to 196,318 in FY 2005, a decrease of 5.4%. Domestic relations dispositions experienced an increase of 6.1%, from 52,884 in FY 2004 to 56,104 in FY 2005. Civil dispositions decreased by 8.8%, from 55,114 in FY 2004 to 50,285 in FY 2005. Criminal dispositions increased in FY 2005, from 49,248 in FY 2004 to 52,271 in FY 2005, an increase of 6.1%. These three categories account for 80.8% of the dispositions in Superior Court.

Total end of year pending cases showed an increase of 3,737 or 1.7%, from 214,609 in FY 2004 to 218,346 in FY 2005.

A third page contains information regarding the disposition of criminal defendants and appeals from Limited Jurisdiction Courts.

In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.

Some of the FY 2004 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

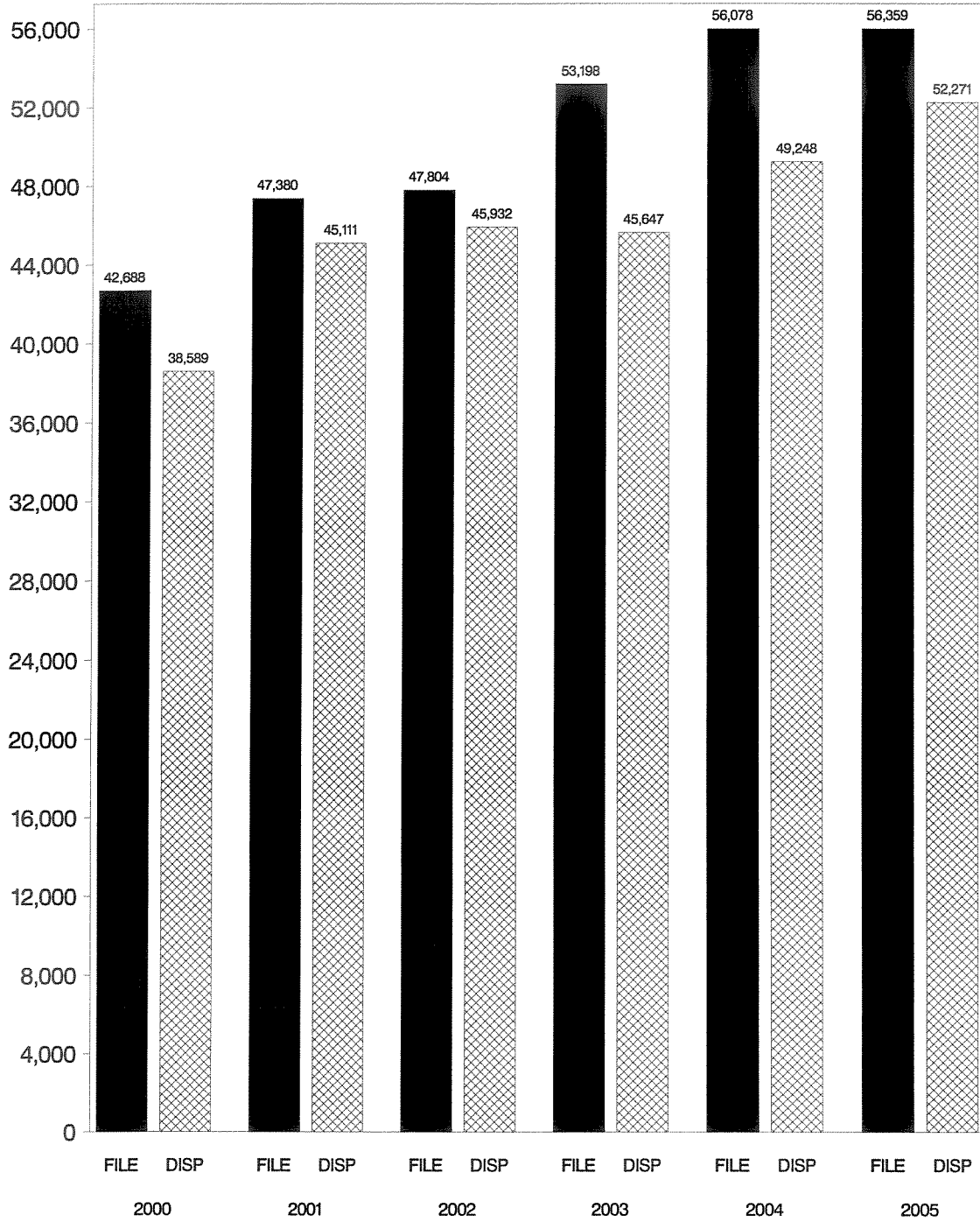

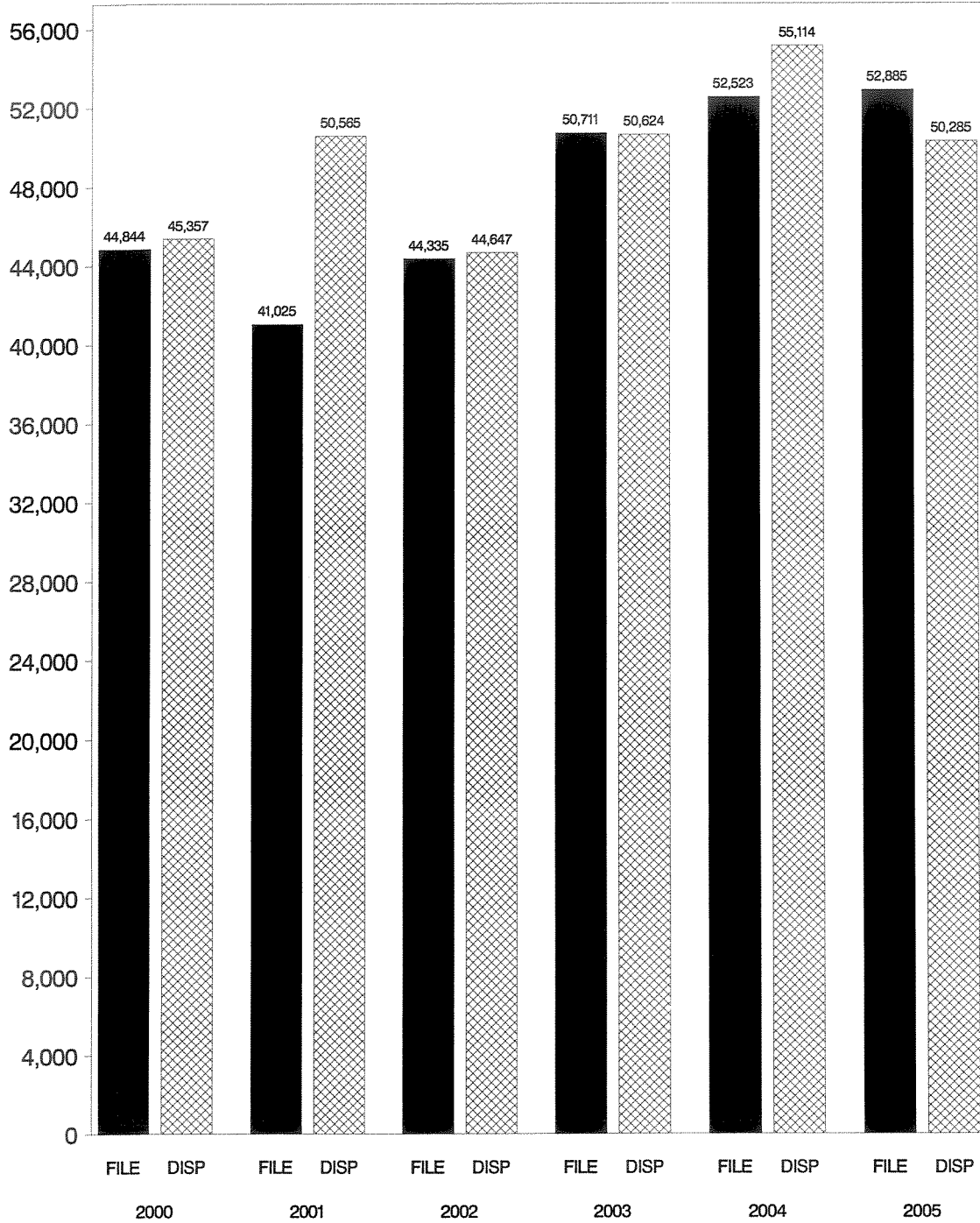

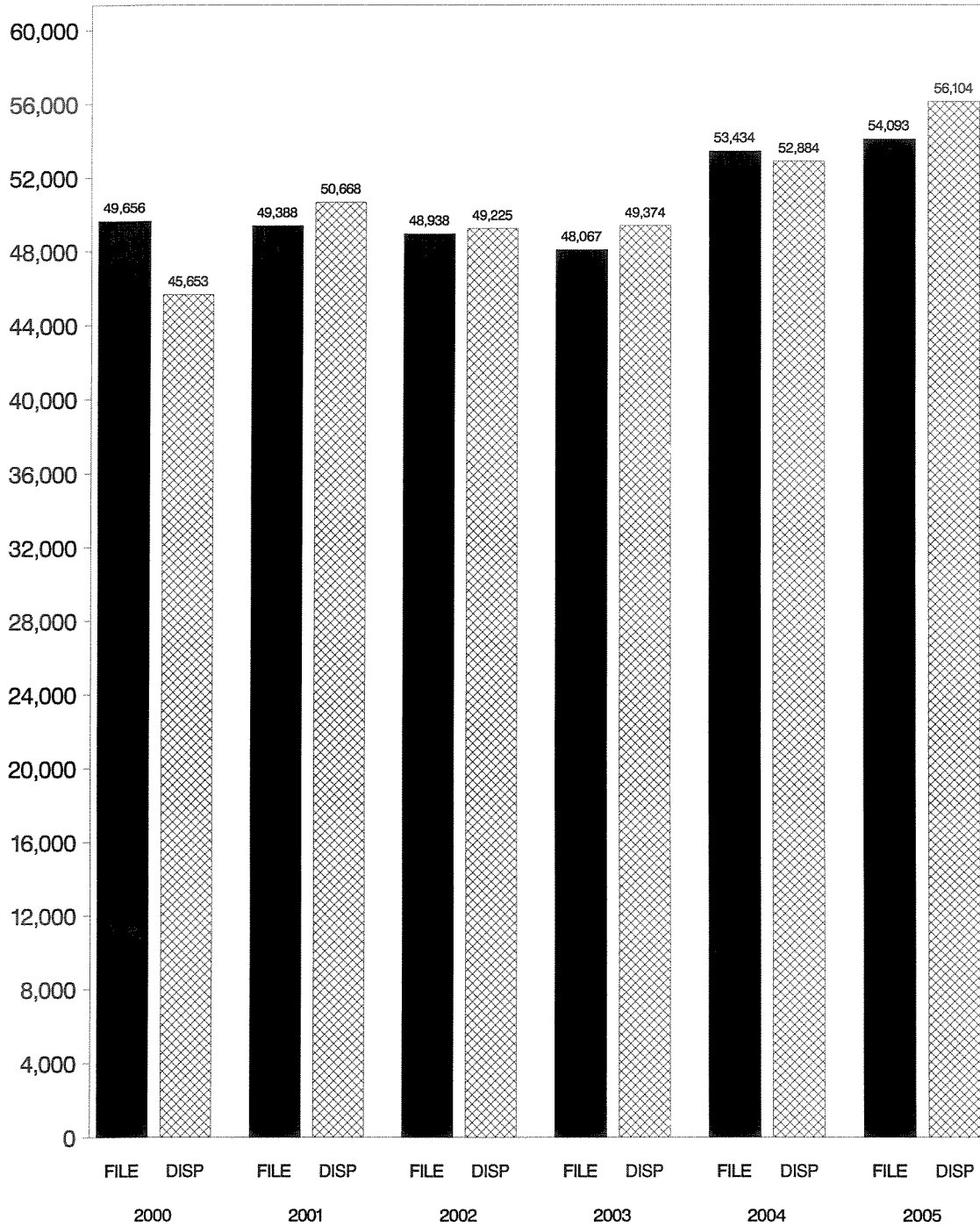
