**STATE BAR'S NOTICE OF  
NONCOMPLIANCE WITH  
TERMS OF PROBATION**

[State Bar No. 21-1310-N]

The State Bar of Arizona, by undersigned Bar Counsel, pursuant to Rule 60(a)(5)(C), Ariz. R. Sup. Ct., hereby gives notice to the Presiding Disciplinary Judge of the Supreme Court of Arizona (PDJ) that Respondent has committed a material violation of the terms of probation entered by the Presiding Disciplinary Judge.

On December 16, 2020, Respondent was reinstated to the practice of law. The Order of Reinstatement contained the following language: "Ms. Sodaro shall contact the State Bar Compliance Monitor at (602) 340-7258, within ten (10) days

from the date of this Order of Reinstatement, to schedule an assessment. *The Compliance Monitor shall develop terms and conditions of participation if the results of the assessment so indicate and the terms, including reporting requirements, shall be incorporated herein.* [Emphasis added]. Ms. Sodaro shall be responsible for any costs associated with participation with compliance.” (Exhibit A).

In January 2021, Respondent informed the Bar she was having issues scheduling the evaluation as ordered. The Bar agreed to allow Respondent to find her own provider and gave Respondent until January 31, 2021, to schedule the assessment. (Exhibit B) On January 20, 2021, the Bar approved Respondent’s request to have the evaluation completed by Dr. Lavit, instead of Dr. Phillip Lett, the provider normally used by the Bar. (Exhibit C).

Respondent failed to schedule the evaluation with Dr. Lavit by January 31, 2021. On February 24, 2021, SBA Compliance Monitor Yvette Penar emailed Respondent about her failure to comply. Respondent stated that she would update Ms. Penar when the appointment was scheduled. (Exhibit D). Respondent again failed to schedule the evaluation.

On April 22, 2021, Ms. Penar emailed Respondent again to remind her of her obligations. (Exhibit E). Respondent scheduled her evaluation for May 11, 2021, with Dr. Lavit. (Exhibit F). Respondent then cancelled her appointment with Dr. Lavit and scheduled with Dr. Lett for May 19, 2021. (Exhibit G).

Respondent attended her evaluation on May 19, 2021. Dr. Lett authored a report and directed Respondent to: (1) undergo medical monitoring a treatment for mental health and insomnia for at least one year, (2) undergo psychotherapy twice a month for six months, and (3) direct her providers to supply the Bar with progress reports. (Exhibit H at 5). Ms. Penar sent Respondent her terms of probation on June 2, 2021. (Exhibit I). Respondent then refused to sign the terms and refused to participate in probation. (Exhibit J).

Yvette Penar's Declaration is attached as Exhibit K.

Based upon the foregoing, and pursuant to Rule 60(a)(5)(C), Ariz. R. Sup. Ct., the State Bar moves the PDJ to set a hearing date within 30 days of the filing of this Notice of Noncompliance to determine whether Respondent has failed to comply with the terms of probation and, if so, whether additional sanctions should be imposed. A proposed order setting a hearing date is attached hereto as Exhibit L.

Thank you for your email.

I am 69 years old and my husband is 70. Since COVID is raging in this state, and we have the highest number of cases in the country, as of today, I cannot risk my health by spending 6 hours with Dr. Lett, even if masks are used.

Our doctors have advised both of us that we are very high risk.

I am very vulnerable to respiratory infections and have been taking all reasonable precautions.

We spoke of Dr. Lett since he is the only therapist who is charging \$100.00 per hour. His assistant did not give a Zoom evaluation as an option.

Otherwise, I will need time to accumulate the funds needed to pay for this evaluation.

Since I have not been able to work since March, that is a problem.

Hello: I have forwarded the information I could find on an independent examiner, since the judge has ordered an "evaluation".

If you review the form, you should conclude, as I do, that the kind of evaluations normally conducted are often related to family custody, divorce, and other serious matters.

There is absolutely no evidence in my record which suggest that I have any conditions which would necessitate the kind of exam such as this independent expert would do.

It should be within your common knowledge that approximately ½ of the people in this state will refuse the vaccination or not be vaccinated. You seem to be disregarding the fact that we are still in the middle of a pandemic. A pandemic which did NOT EXIST at the time I was compelled to agree to your settlement or face a year of suspension. I am sure that you also know that my lack of ability to pay more attorney fees that would be sought by Mr. Rhodes made it necessary for me to meet your demands.

My doctor will verify for you that my health issues make me especially vulnerable to this infection and jeopardize my life.

I don't know why you are concerned because the judge's order which requires me to only practice in the area of in person bankruptcy hearings, which no longer exist, should satisfy your goals in this prosecution.

If you wish me to take an MMPI evaluation at your expense and I can do it on-line, I will do that.

Otherwise, my probation will not expire until December 15, 2022. If you can wait until the time before that expiration for your desired evaluation, perhaps my financial resources will permit an evaluation and the pandemic may be under control.

I am asking you to be reasonable under these extraordinary circumstances.

This is not too much to ask.

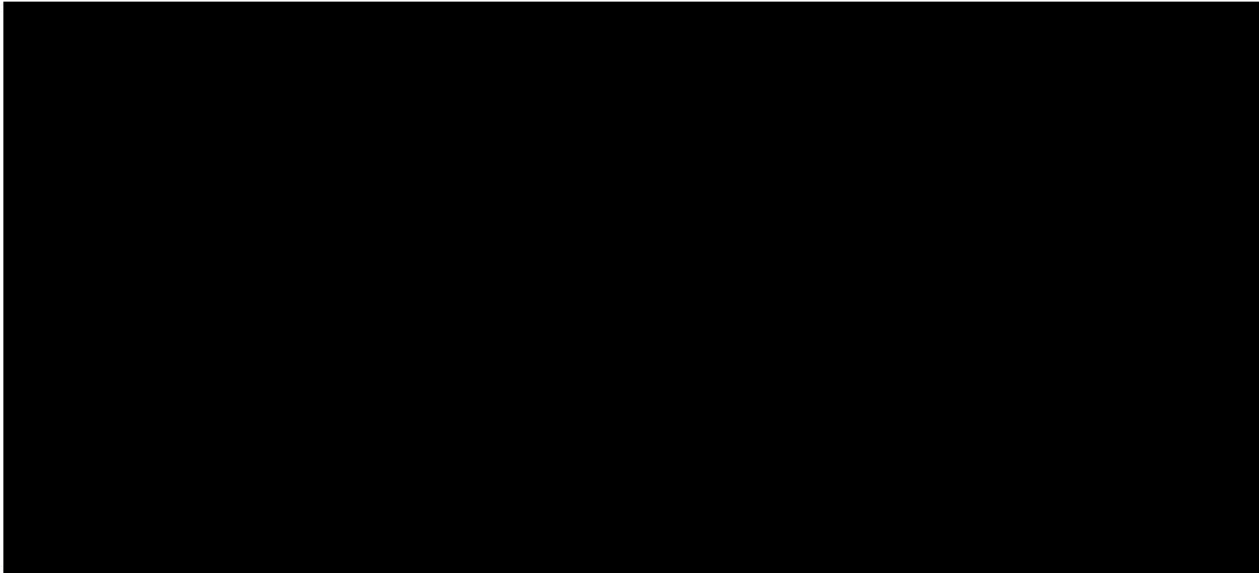

I have reviewed the documents you forwarded to me concerning my probationary status.

Per your direction, I submitted to a day long Psychological Examination by Dr. Phillip Lett. His report expressly states that the purpose of the Independent Exam was for the purpose of Assessment, **not treatment**. Therefore, your office, not being medical professionals, have no right to dictate future medical treatment for me.

His entire report clearly reveals that I have:

1. No relevant legal, economic, or criminal history whatsoever.
2. That I have no significant change in energy or social issues.
3. That there are no reports or signs of alcohol or substance abuse.
4. That my affect is appropriate, speech normal and fluent and that I have no problems with attention or memory, nor any unusual behaviors.
5. The doctor stated that I have remarkable strength in verbal comprehension and functioning.
6. That other testing revealed that my behaviors fall within the normal range compared to peers of my age group.
7. Also, that there are no indications of severe personality disorder or clinical psychopathology, nor are there any cognitive concerns.

8. Dr. Lett pointed out that my depression is stable and/or in remission.

And then, as I assume was pursuant to your direction, or someone in your office, I am presented with a variety of treatment requirements, reports and expenses that are neither justified nor within your authority to mandate.

When I agreed to the initial discipline settlement, after being advised by Mr. Rhodes, I was told that I would have to undergo an evaluation. That is all.

What you propose to impose upon me is entirely without basis and is punitive in nature.

I also consider such a demand to be a violation of my rights under HIPA, and perhaps other civil rights protections that I have.

In conclusion, the order entered by Judge O' Neil is not only punitive but unjustified. The Arizona Supreme Court states that discipline is for corrective purposes and should not be punitive.

I have complied with all of my required conditions and will not be disclosing any further medical information to your office.

Judge O'Neil's order was entered before the pandemic and all that followed.

He refused to amend his order after I informed him that the legal work that I was ordered to limit my practice to, for the next two years NO LONGER EXISTS and will not likely ever exist in the future.

Therefore, the effect of this judge's order is that I am prevented from pursuing my profession for 2 and ½ years. That is not what I agreed to, nor is it justified in any way. 

VIOLATION AND IMPOSING TERM  
OF SUSPENSION**

The State Bar filed a Notice of Noncompliance with Terms of Probation on June 10, 2021. Respondent Jennifer Prager Sodaro filed a response on June 22, 2021. An evidentiary hearing was held before Presiding Disciplinary Judge (PDJ) Margaret H. Downie on June 28, 2021, at which exhibits were introduced into evidence and the following witnesses testified:

- Jennifer Prager Sodaro
- Yvette Penar

Ms. Sodaro appeared on her own behalf. The State Bar was represented by Bradley F. Perry. Having considered the matters presented, the PDJ issues the following findings of fact, conclusions of law, and order.

**FINDINGS OF FACT**

1. On April 29, 2020, Ms. Sodaro, her then-counsel (J. Scott Rhodes), and Bar Counsel Bradley Perry signed and filed an Agreement for Discipline by Consent that resolved a four-count formal complaint the State Bar had filed against Ms. Sodaro in PDJ no. 2019-9098.

2. Pursuant to the consent agreement, Ms. Sodaro agreed to a six-month suspension from the practice of law based on admitted violations of Rule 42, Ariz. R. Sup. Ct., ERs 1.1, 1.3, 1.7(a)(2), 1.15, 4.2, 4.3, and 8.4(d) and Rule 43. The consent agreement also provided that Ms. Sodaro would serve two years of probation upon reinstatement, with enumerated terms. As relevant here, the agreement stated:

Respondent and the State Bar of Arizona agree that based on the facts and circumstances of this matter, as set forth above, the following sanctions are appropriate: Suspension of six (6) months, and two (2) years of probation upon Reinstatement, the terms of probation will consist of:

LRO MAP: Respondent shall contact the State Bar Compliance Monitor at (602) 340-7258, within ten (10) days from the date of service of an Order of Reinstatement, to schedule an assessment. The Compliance Monitor shall develop terms and conditions of participation if the results of the assessment so indicate and the terms, including reporting requirements, shall be incorporated herein. Respondent will be responsible for any costs associated with participation with compliance.

3. PDJ William J. O' Neil accepted the consent agreement, and Ms. Sodaro thereafter served a six-month term of suspension.

4. At the conclusion of her suspension term, Ms. Sodaro applied for reinstatement, which the State Bar did not oppose. By order dated December 16, 2020, Judge O'Neil granted Ms. Sodaro's application. As contemplated by the consent agreement, the order of reinstatement included the following language:

**IT IS FURTHER ORDERED** Ms. Sodaro shall be placed on probation for a period of two (2) years with the State Bar's Member Assistance Program (MAP) as follows:

a) LRO MAP: Ms. Sodaro shall contact the State Bar Compliance Monitor at (602) 340-7258, within ten (10) days from the date of this Order of Reinstatement, to schedule an assessment. The Compliance Monitor shall develop terms and conditions of participation if the results of the

assessment so indicate and the terms, including reporting requirements, shall be incorporated herein. Ms. Sodaro shall be responsible for any costs associated with participating and compliance of MAP.

5. In January of 2021, Ms. Sodaro advised Yvette Penar, the State Bar's Compliance Monitor, that she was searching for an evaluator who could conduct the required assessment virtually. Ms. Penar responded: "The order requires the evaluation to be scheduled with[in] 10 days of the reinstatement order. We are past that date however, I will give you until January 31, 2021 to find an alternative provider or schedule the evaluation with Dr. Lett."

6. Ms. Penar followed up with Ms. Sodaro on February 24, 2021. Ms. Sodaro advised she was waiting to hear back from Dr. Lavit (whom she preferred to use for the assessment), and she agreed to notify Ms. Penar once the appointment was scheduled.

7. Having heard nothing further, Ms. Penar emailed Ms. Sodaro on April 22, 2021 to remind her of her obligations. Ms. Penar further advised: "If, you do not get an evaluation scheduled in the next few weeks, we are required per Rule 60(a)(5)(C) to file a violation with the PDJ."

8. On April 26, 2021, Ms. Sodaro wrote to Ms. Penar and Bar Counsel, stating, in pertinent part: "I will not submit to an examination by the expert of your choice, who will be biased in your favor and could pose a risk to my health." However, on May 9, 2021, Ms. Sodaro advised Ms. Penar she had "reconsidered about how to comply with the probation conditions" and stated she would meet with Dr. Lett "as long as his costs are \$600." Ms. Penar confirmed the \$600 fee, and Ms. Sodaro scheduled the assessment with Dr. Lett for May 19, 2021.

9. After conducting the assessment of Ms. Sodaro on May 19, 2021, Dr. Lett made the following recommendations:

- Psychiatric consultation
- Continued medical monitoring and treatment for mental health, including sleep, for at least one year
- Psychotherapy at least twice a month for six months to address the issues identified in the evaluation

Dr. Lett further recommended that Ms. Sodaro's medical/mental health providers submit periodic reports to the State Bar regarding her progress.

10. On June 2, 2021, Ms. Penar sent Ms. Sodaro terms of probation that incorporated Dr. Lett's recommendations. She asked Ms. Sodaro to sign and return the terms of probation by June 9, 2021.

11. Ms. Sodaro responded to Ms. Penar on June 3, 2021, stating, in pertinent part:

Per your direction, I submitted to a day long Psychological Examination by Dr. Phillip Lett. His report expressly states that the purpose of the Independent Exam was for the purpose of Assessment, **not treatment**. Therefore, your office, not being medical professionals, have no right to dictate future medical treatment for me.

When I agreed to the initial discipline settlement, after being advised by Mr. Rhodes, I was told that I would have to undergo an evaluation. That is all.

12. Ms. Sodaro confirmed at the evidentiary hearing that she will not sign the terms of probation.

### CONCLUSIONS OF LAW

1. The sole issue is whether the State Bar proved by a preponderance of the evidence that Ms. Sodaro violated her terms of probation. In these proceedings, Ms. Sodaro may not collaterally attack the consent agreement she signed or the order Judge O'Neil entered upon her reinstatement.

2. Ms. Sodaro's refusal to sign or agree to terms of probation is in violation of the December 16, 2020 order placing her on probation.

3. Violation of a condition of probation constitutes grounds for discipline and subjects the respondent lawyer to an additional sanction. *See* Rules 54(e) and 60(a)(5)(C), Ariz. R. Sup. Ct.

### DISCUSSION

The State Bar requests that Ms. Sodaro be suspended from the practice of law for six months and one day. Ms. Sodaro's position is that she should be permitted to resign from the State Bar of Arizona, with an indication she has served her suspension and

complied with the terms of her reinstatement order. *But see* Rule 32(c)(12) (only members in good standing may resign).

Although the PDJ encouraged Ms. Sodaro to identify specific terms of probation that might be modified to gain her compliance, she did not do so, instead insisting she should never have been placed on probation in the first instance. Of course, it was her own agreement to probation, as well as her agreement to the terms at issue here, that resulted in her probationary status and the State Bar's requirement that she sign terms of probation. Under the circumstances, no viable alternative to suspension exists. Ms. Sodaro's refusal to comply with probation demonstrates that any future application for reinstatement should proceed under Rules 64(e)(1) and 65.

#### **ORDER**

For the reasons stated,

**IT IS ORDERED** that Jennifer Prager Sodaro is in violation of probation.

**IT IS FURTHER ORDERED** suspending Jennifer Prager Sodaro from the practice of law in Arizona for six months and one day, effective immediately.
