

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both justice and municipal courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice and municipal courts are examined individually in subsequent sections.

Total filings (including transfers in) increased 0.9% in FY 99, from 2,219,727 last year to 2,238,824. Traffic cases comprised the majority (69.6%) of the filings in limited jurisdiction courts. Total traffic filings (criminal and civil) decreased 1.5%, from 1,583,336 last year to 1,559,156 in FY 99. Criminal filings (misdemeanors and felonies) decreased by 991 cases, from 394,099 in FY 98 to 393,108 in FY 99.

Continuing the upward trend from last year, petitions for orders of protection in domestic violence increased from 18,072 in FY 98 to 18,305 in FY 99, an increase of 1.3%. Petitions for injunctions against harassment increased by 2.4%, from 16,043 in FY 98 to 16,423 in FY 99.

Total dispositions (including transfers) increased slightly by 0.2%, from 2,129,988 last year to 2,135,061 in FY 99. Traffic dispositions (criminal and civil) decreased by 0.5% while criminal dispositions (misdemeanor and felony) declined by 0.1% from last year. Only 7.3% of the orders of protection and 11.1% of the harassment petitions ruled upon were denied.

Total end of year pending cases increased from 1,155,064 in FY98 to 1,245,666 in FY99, an increase of 7.8%. Most of the increase was in misdemeanors which increased from 453,662 in FY98 to 491,866 in FY 99, an increase of 8.4%.

Court trial statistics for some courts may not be comparable to previous years due to differences in data collection techniques.

Some of the FY 98 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

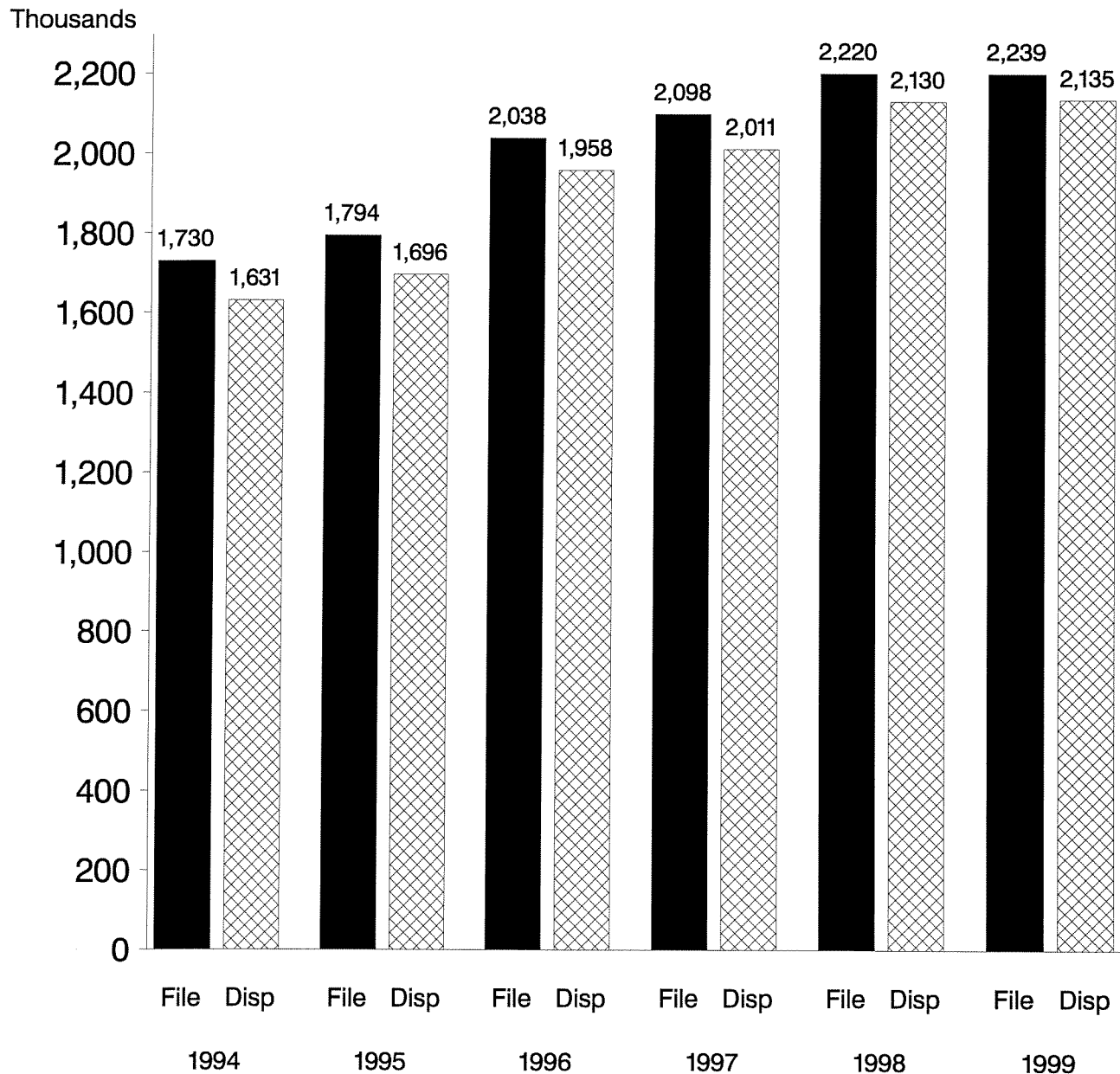

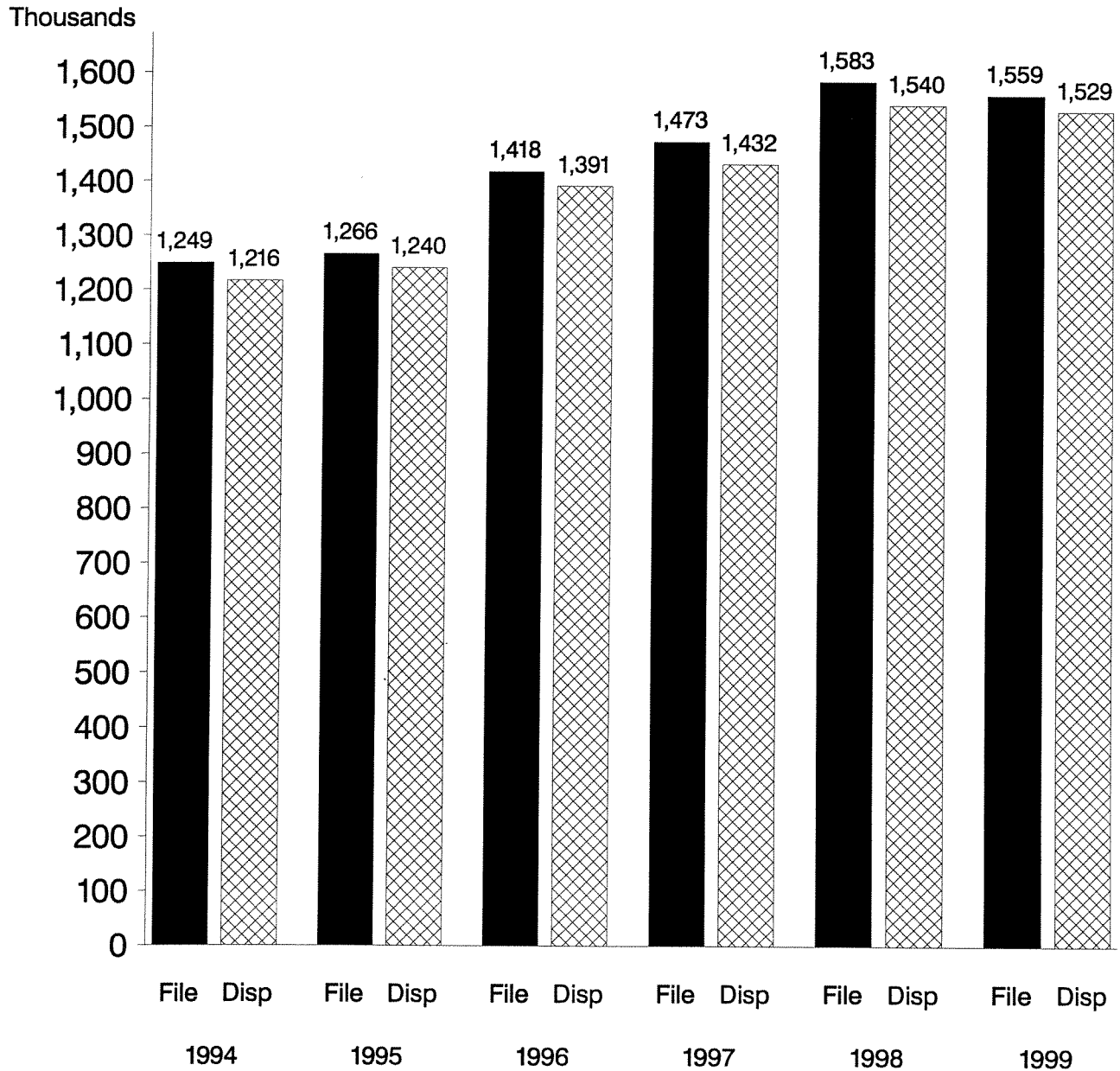

Combined Traffic Case Activity, FY 1994 – 99

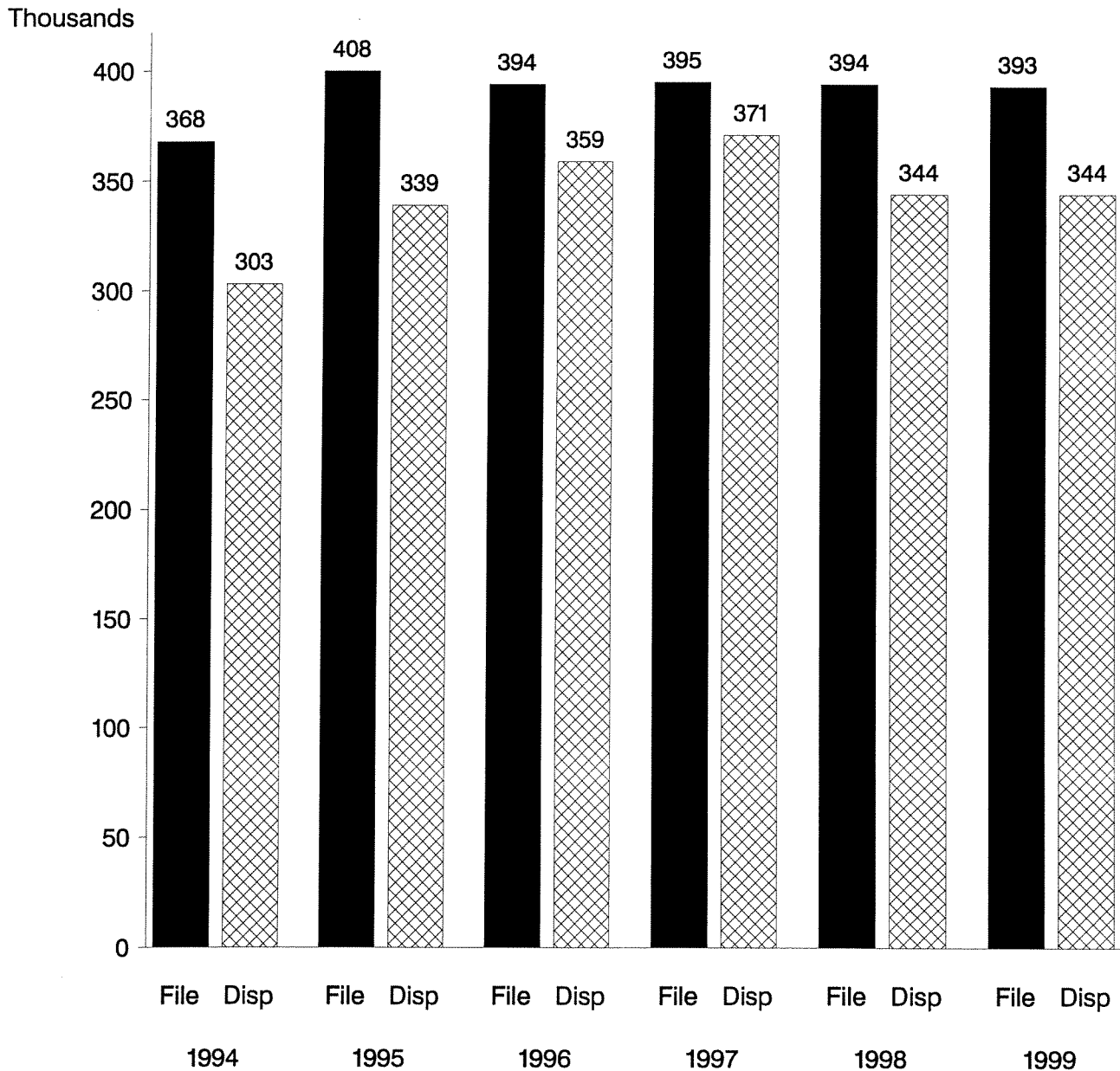

Combined Criminal Case Activity, FY 1994 – 99 Cases Filed and Disposed

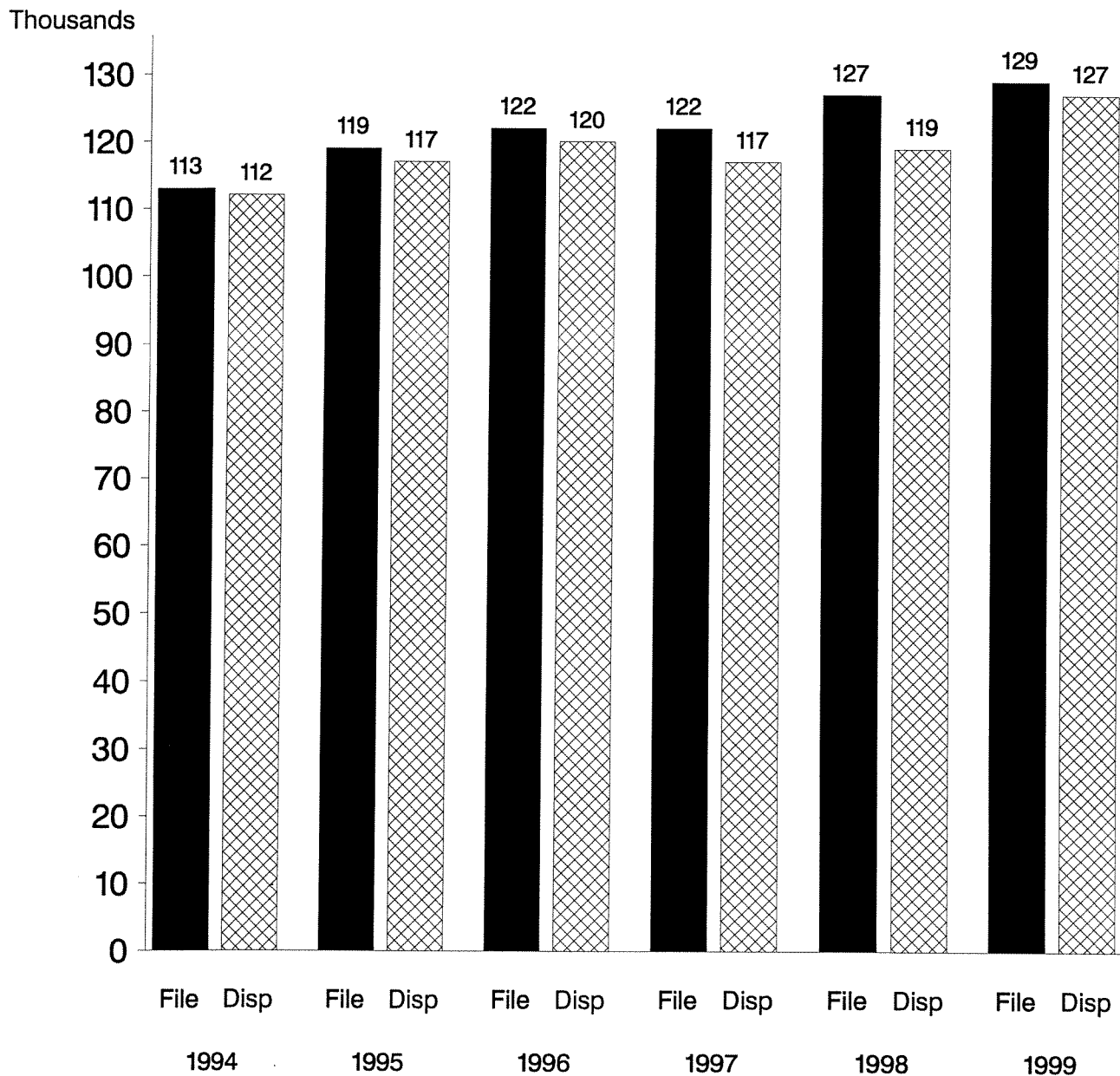

Combined Civil Case Activity, FY 1994 – 99

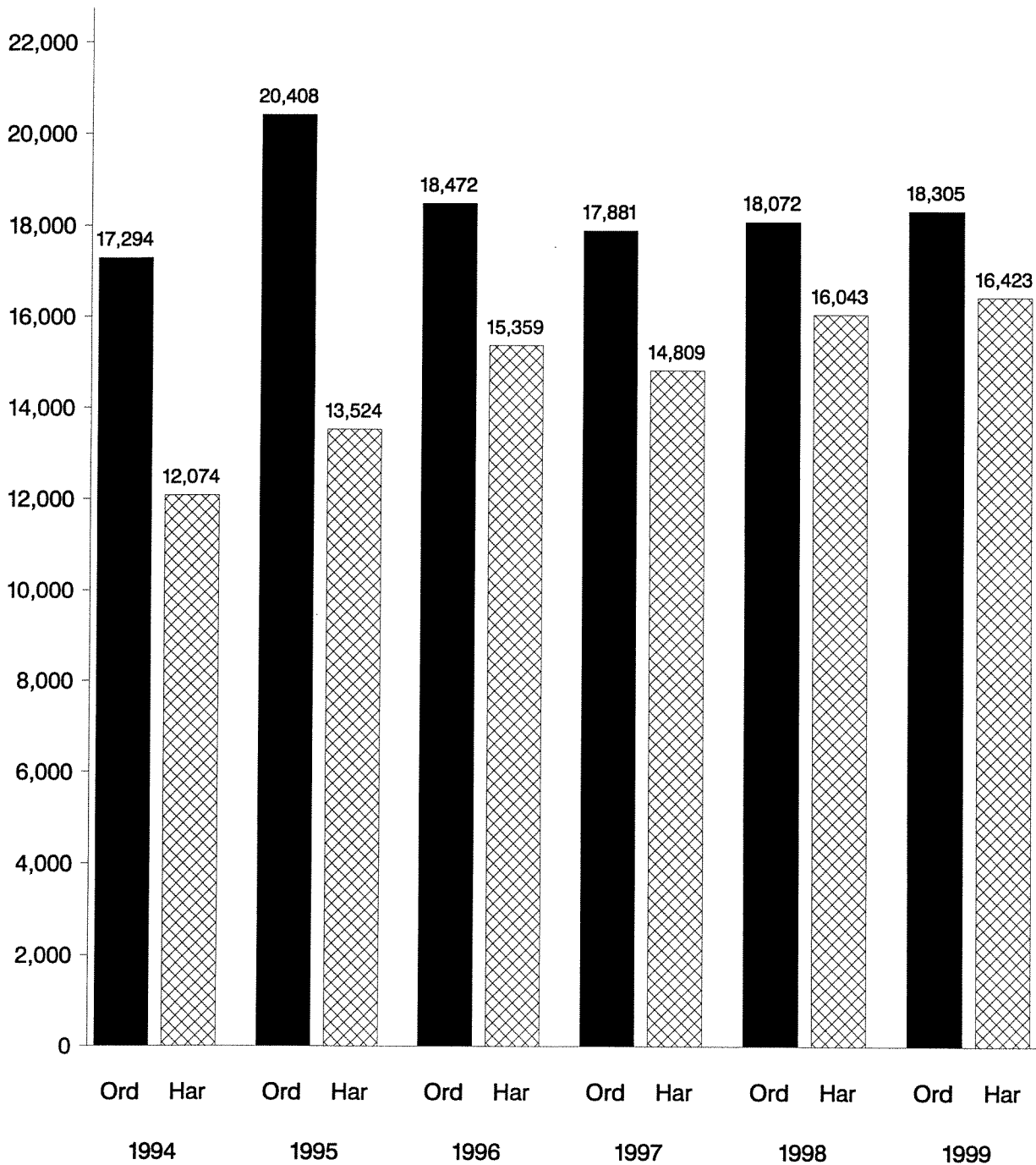
Cases Filed and Disposed
