

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) increased 4.2% in FY 2003, from 2,237,252 last year to 2,331,276. Traffic cases comprised the majority (69.2%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) increased by 3.7%, from 1,556,083 last year to 1,613,092 in FY 2003. Criminal filings (misdemeanors and felonies) increased by 0.7%, from 379,706 in FY 2002 to 382,607 in FY 2003.

Continuing the upward trend from the last five years, petitions for orders of protection in domestic violence cases increased from 22,968 in FY 2002 to 23,740 in FY 2003, an increase of 3.4%. Petitions for injunctions against harassment increased moderately, from 18,663 in FY 2002 to 19,635 in FY 2003, an increase of 5.2%.

Total dispositions (including transfers) increased by 3.0%, from 2,213,764 last year to 2,279,900 in FY 2003. Traffic dispositions (criminal and civil) increased by 1.6% while criminal dispositions (misdemeanor and felony) increased sharply by 9.2% from last year. Only 11.0% of the orders of protection and 16.1% of the harassment petitions ruled upon were denied.

Total end of year pending cases increased from 1,471,999 in FY 2002 to 1,491,095 in FY 2003, an increase of 13.0%. Most of the increase was in the non-criminal ordinance case category, which increased from 117,325 in FY 2002 to 136,613 in FY 2003, an increase of 16.4%.

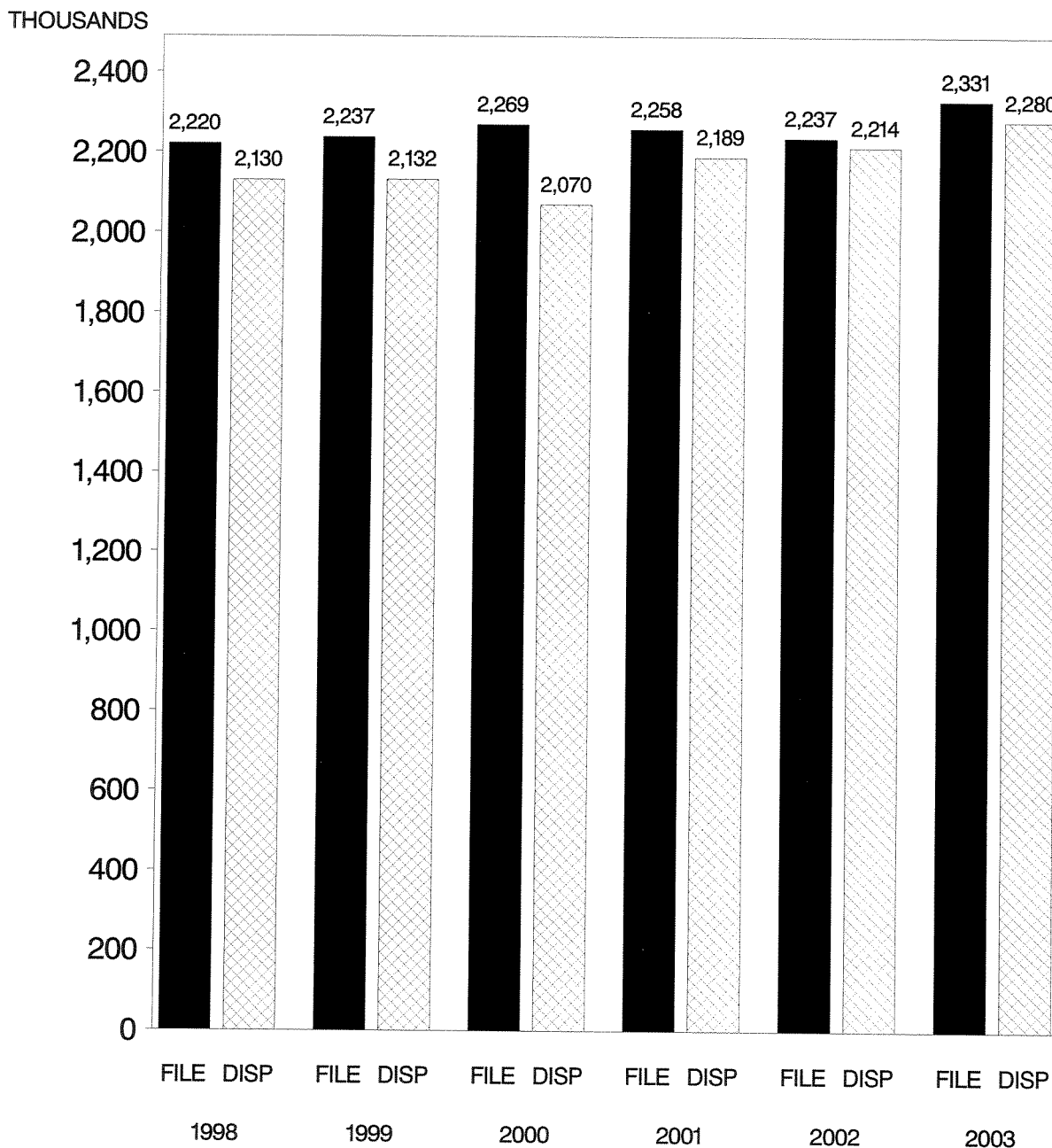

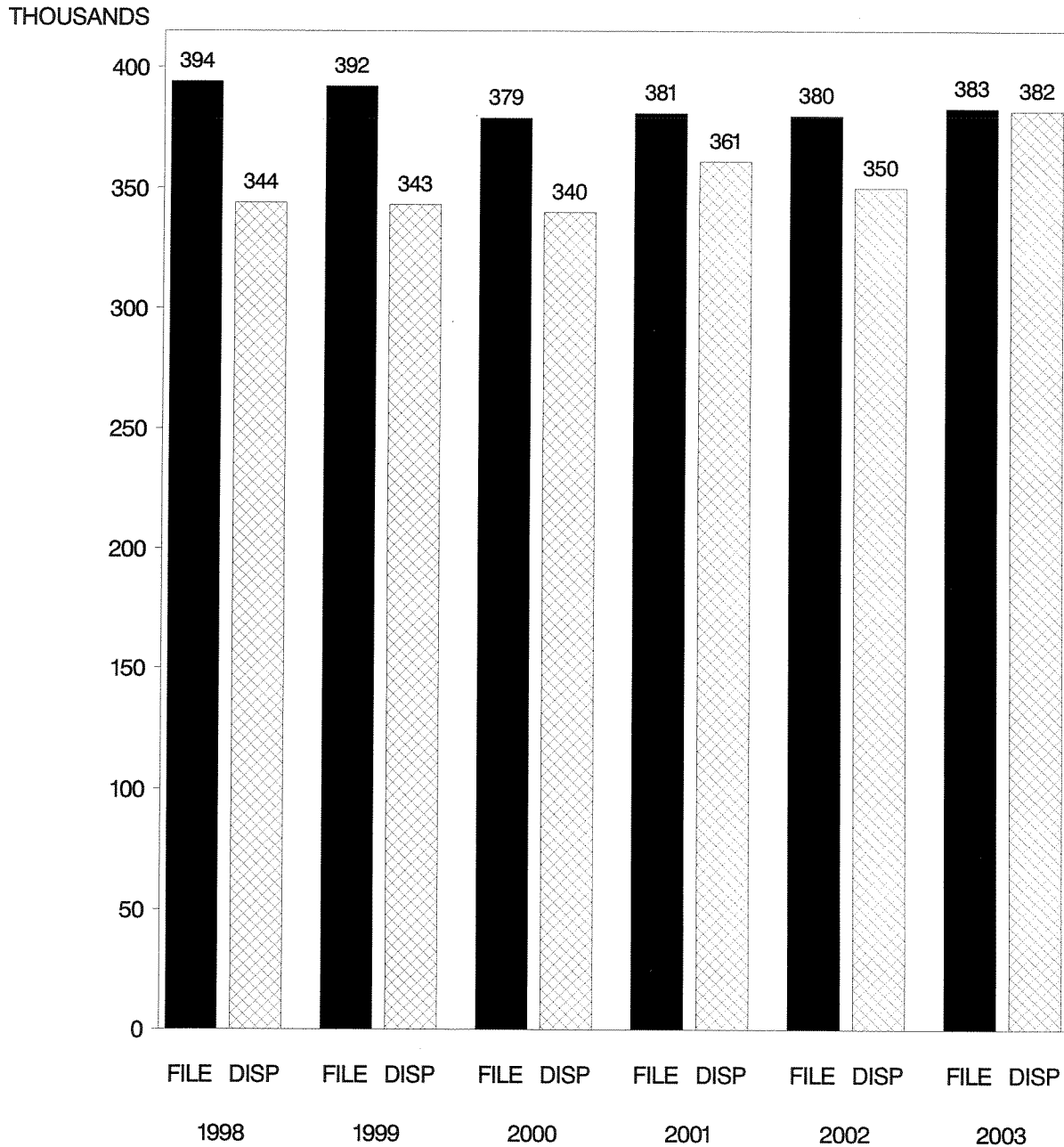

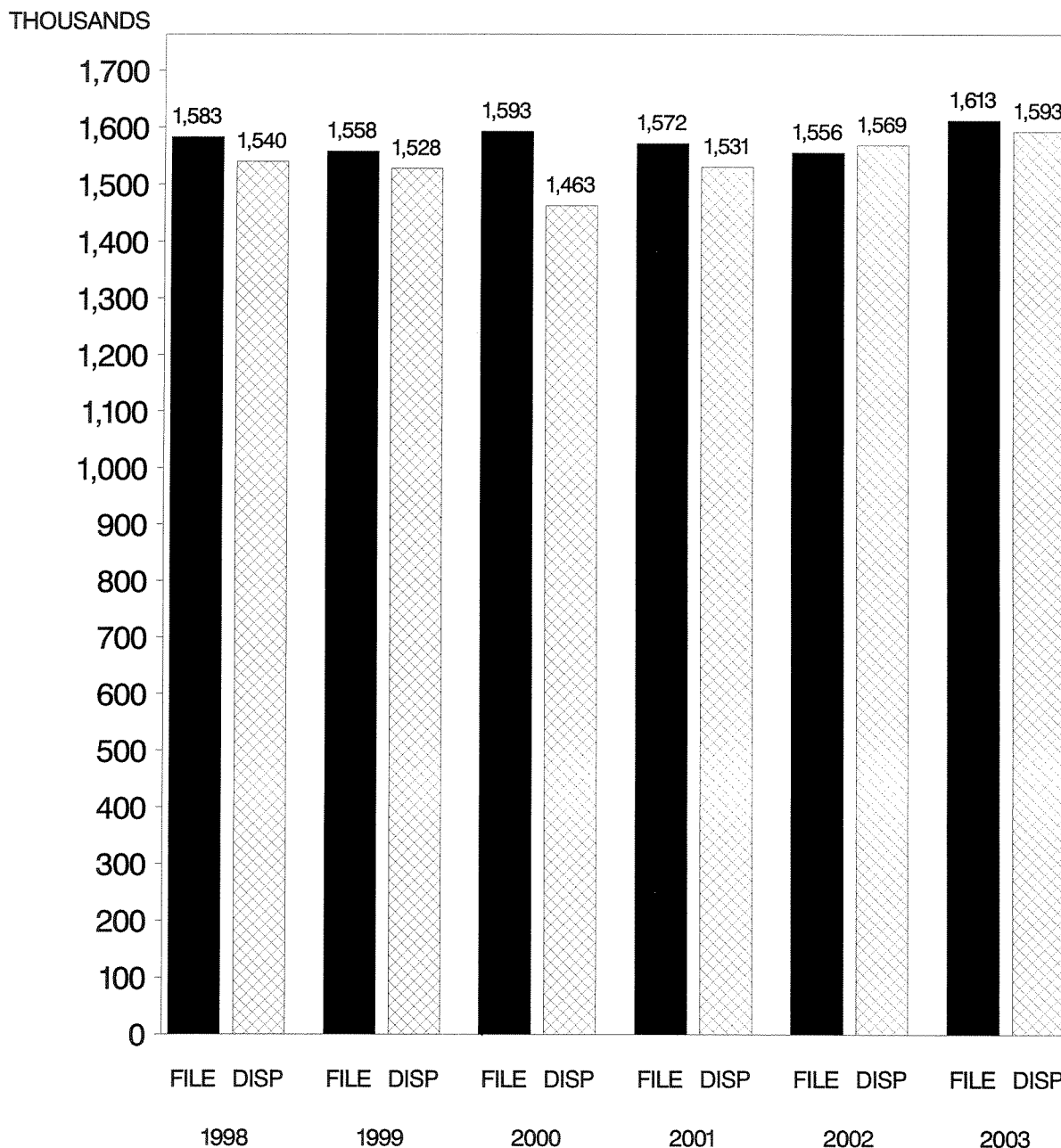

COMBINED TRAFFIC CASE ACTIVITY, FY 1998 – 2003

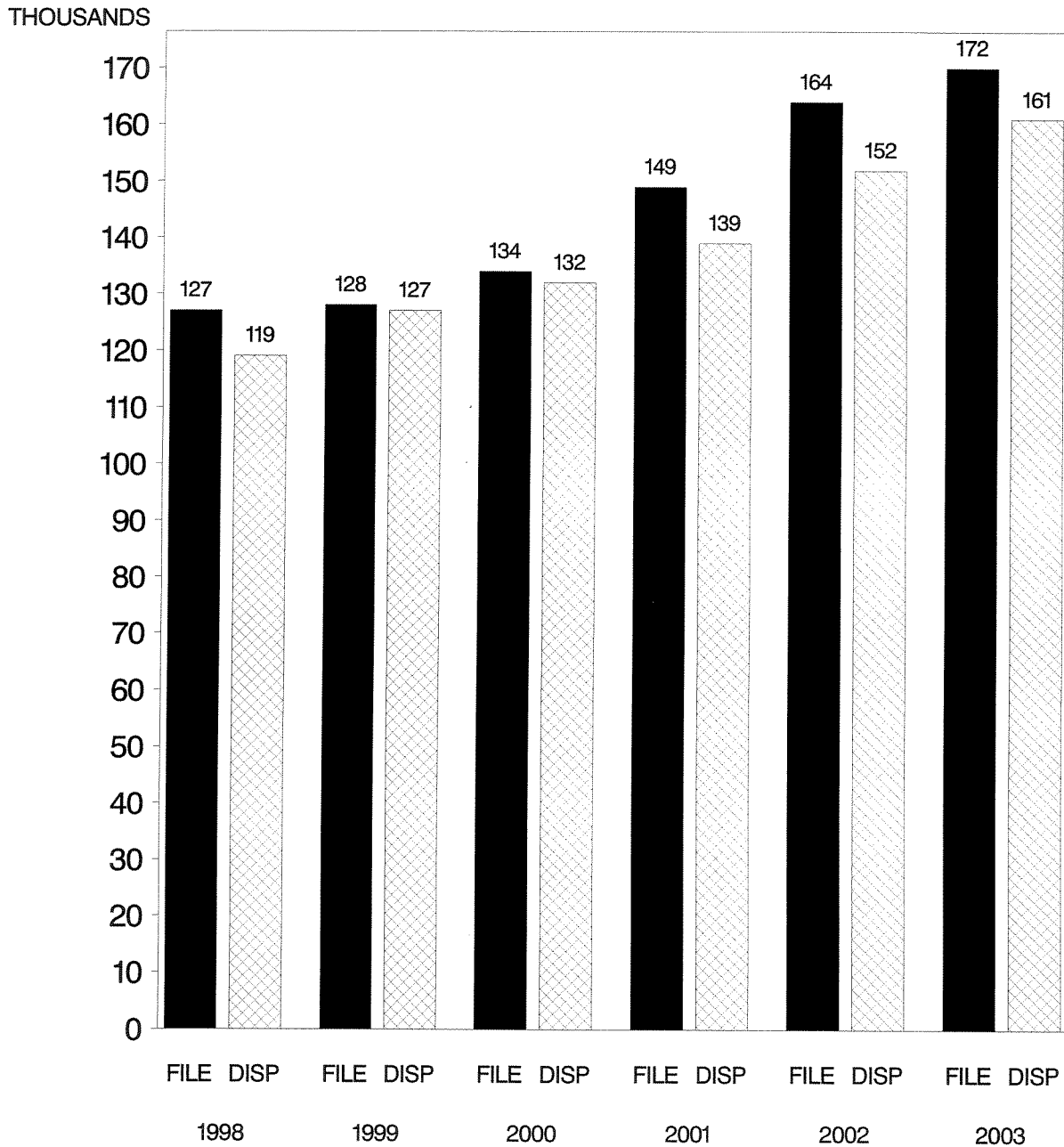

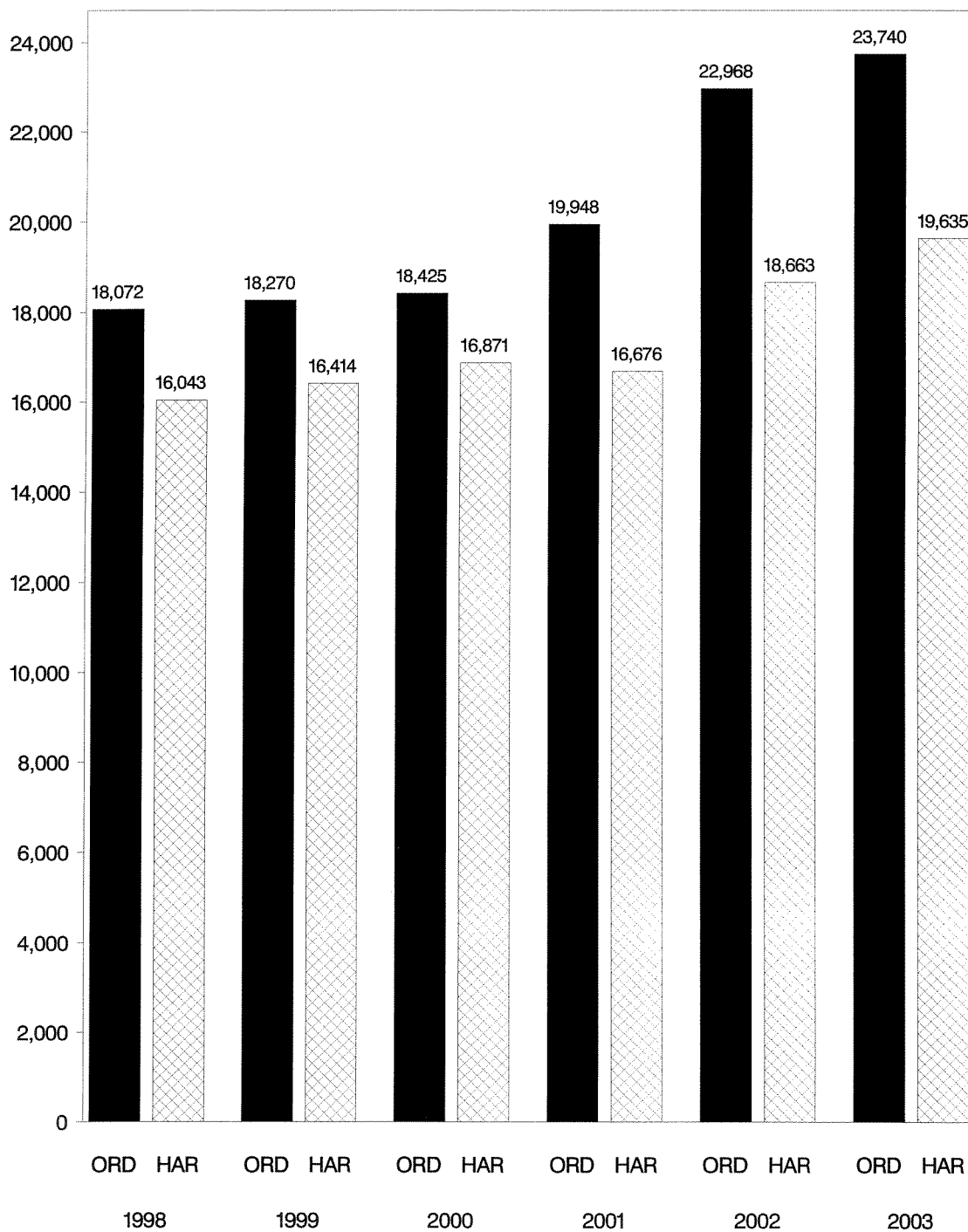
COMBINED CIVIL CASE ACTIVITY, FY 1998 – 2003 CASES FILED AND DISPOSED
