# Additional File Format Support

- eCourt products (eBench, eFiling, and eAccess) will require the use of the **DOCX** and **ODT** file formats
  - Local OnBase systems have been updated to support these file types
- The Case Management Systems will also be updated to support the new file formats

# OnBase Desktop Client

- Reminder: The Desktop Client is no longer supported in OnBase 17
  - The Desktop Client is the primary method for document retrieval for AZTEC
- The AOC is developing integration with the OnBase Unity Client as a replacement
  - This will include replacing Disconnected Scanning with the Unity Client which will enable real-time scanning

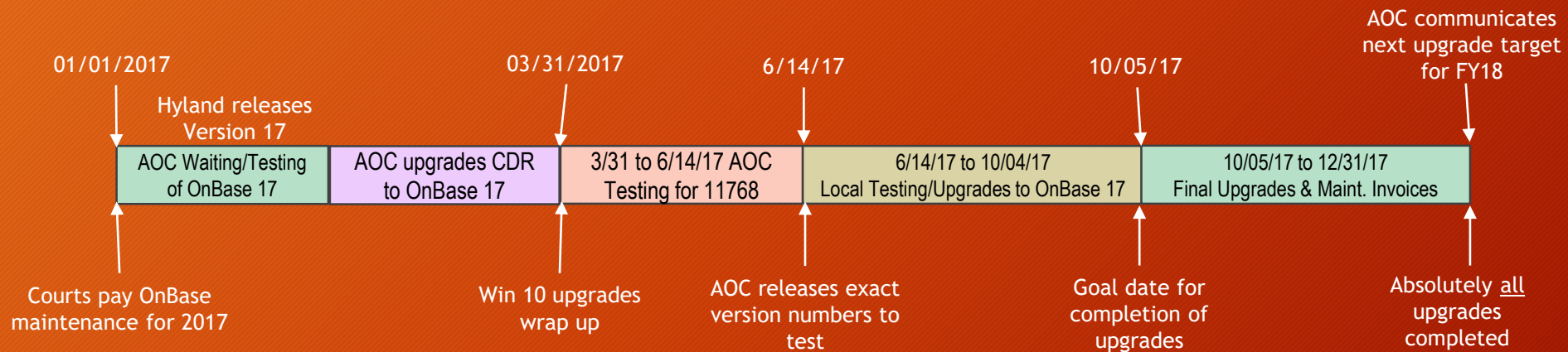


# Upgrade to OnBase 15

- All 13 of the Superior Courts have completed the upgrade
- OnBase 15 is the official version support by Hyland for Windows 10
  - All Courts are now ready for the PC upgrade
- OnBase version 15 is currently the minimum version required to participate in any of the eCourt products
  - eAccess, eBench, and eFiling

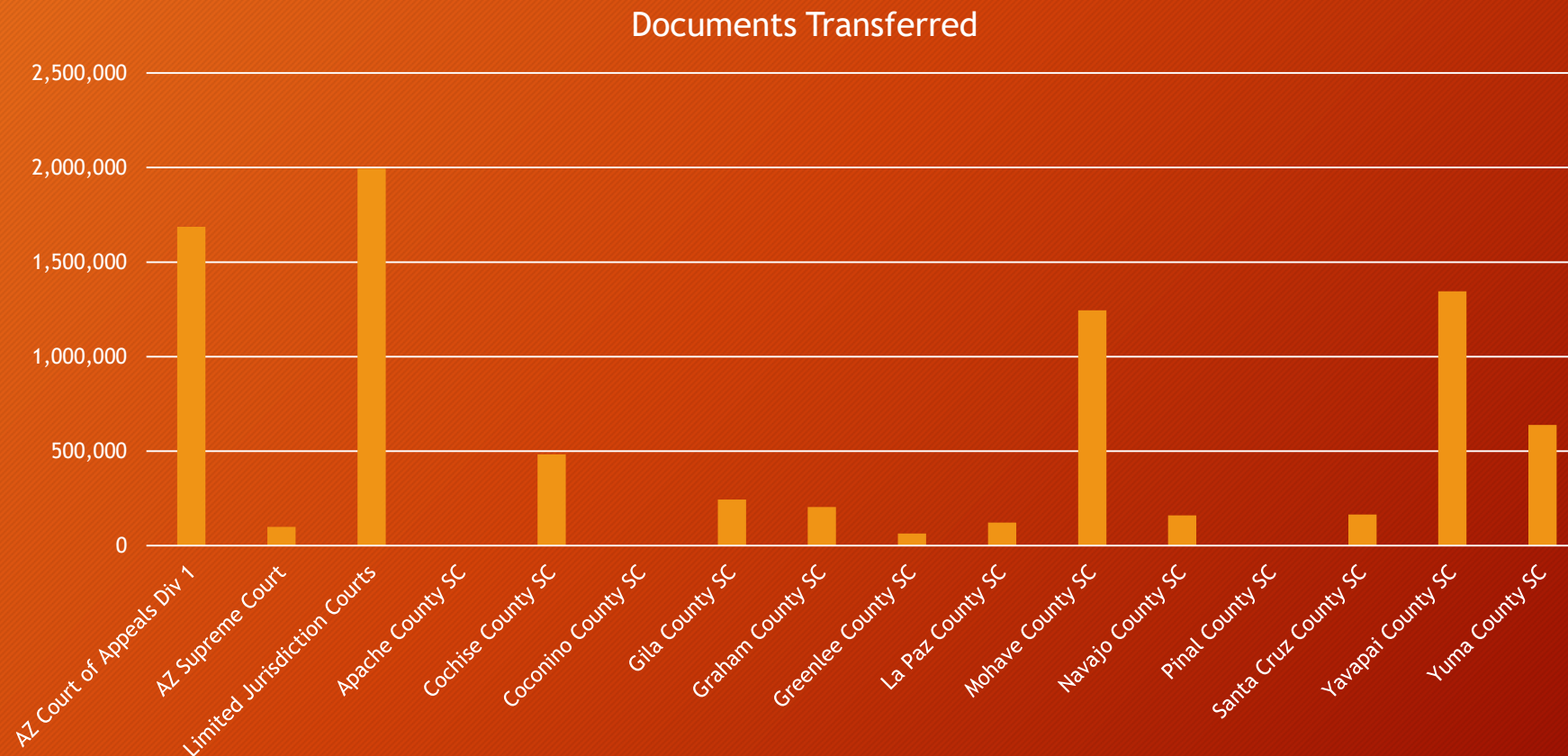
# Upgrade to OnBase 17

## Document Transfer Module

- Flaw in the DTM design prevents “locked” documents from transferring to the CDR

  - This includes the Doc StorageID keyword that is used for retrieval by eCourt products
- AOC will assist the Courts with cleanup before any eCourt products go live

# Central Document Repository

## Missing Keywords

- Some of the documents are missing keywords
  - Case Number, Sequence, Doc StorageID, Restricted, and Sealed
- The AOC suggests making these keywords 'Required Keywords' in OnBase
  - This will prevent keyword values from being empty in the future
  - AOC will create instructions to mark keywords as 'Required Keywords'
- The AOC will work with OnBase administrators to update keywords
  - You're already licensed for Keyword Updater
