Staff further recommends that the certifications of the above named schools be suspended for two months (prohibiting the registration of new students and removing them from the IVR and the website) and thereafter that the schools further be placed on probation (prohibiting the registration of new students and removing them from the IVR and webpage) until such time as (i) the Board has approved the sale of the assets to a third party including a demonstration that the third party has implemented sufficient procedures to assure state and limited jurisdiction court fees are properly paid and deposited, or (ii) Ms. Christos has demonstrated the schools have implemented sufficient procedures to assure state and limited jurisdiction court fees are properly paid and deposited.
