

ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive)** Case Activity, the second covers **Standard Adult Probation** alone, and the third only **Intensive Adult Probation**. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second table concerns **Probationers with Petitions to Revoke**, and the third table summarizes **Additional Probation Activity**.

There were a total of 46,634 individuals added to **standard and intensive** probation during FY 2002, including 9,858 absconders. During the same period, 43,932 probationers were terminated, of which 9,345 were absconders. As of the end of FY 2002, there were 38,594 active standard and intensive probationers and 10,635 absconders in Arizona, a total of 49,229 individuals. There were 16,795 petitions to revoke probation filed during the year, 16,149 terminated, and 2,495 pending at the end of the year. Additionally, probationers completed 1,605,816 community service hours in FY 2002 (3.8% less than last year), and probation officers completed 30,940 presentence reports (down 4.8% over FY 2001) and collected \$48,451,859 in restitution, fines, surcharges, fees, reimbursements, and taxes from probationers (a 41.1% rise from FY 2001). FY 2002 collections included a \$10 million settlement in Maricopa Superior Court.

There were 38,922 persons placed on **standard** probation in FY 2002, which includes 8,331 absconders. During the year, 35,912 standard probationers were terminated, including 7,809 absconders. On June 30, 2002, 35,509 people were on active standard probation and 9,680 were absconders from standard probation, equaling a total of 45,189 individuals. A total of 13,285 petitions to revoke probation were filed in FY 2002; 12,580 petitions were terminated, and 2,062 were pending on the last day of the fiscal year. In addition, standard probationers completed 775,624 community service hours and paid a total of \$43,503,699 monies owed to the court.

Additions to **intensive** probation numbered 7,712 during FY 2002, of which 1,527 were absconders. Also during FY 2002, 8,020 intensive probationers were terminated, including 1,536 absconders. At the close of the fiscal year, there were 3,085 active intensive probationers and 955 intensive probation absconders, totaling 4,040 persons. In all, 3,510 petitions to revoke probation were filed and 3,569 petitions were terminated during the year, leaving 433 pending at the end of the year. Intensive probationers completed 830,192 hours of community service and paid \$4,948,160 in fines, restitution, and other monies.
