

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were up by 6.5%, from 192,129 in FY 2003 to 204,681 this fiscal year. Superior Court's largest category, criminal filings, experienced an increase of 5.4%, from 53,198 in FY 2003 to 56,078 in FY 2004. The next largest category, domestic relations, increased by 11.2%, from 48,067 in FY 2003 to 53,434 in FY 2004. Civil case filings increased by 3.6%, from 50,711 in FY 2003 to 52,523 in FY 2004. These three categories account for 79.2% of the Superior Court total filings.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2004, these petitions together decreased by .4 %, from 9701 in FY 2003 to 9,660 in FY 2004. Separately, orders of protection were down by 4.1% from FY 2003 while injunctions against harassment increased by 14.2% in FY 2004. Juvenile delinquent and incorrigible filings increased, from 18,530 to 19,434 or 4.9%.

Total dispositions (including transfers) were up from 183,355 in FY 2003 to 207,485 in FY 2004, an increase of 13.2%. Domestic relations dispositions experienced an increase of 7.1%, from 49,374 in FY 2003 to 52,884 in FY 2004. Civil dispositions increased by 8.9%, from 50,624 in FY 2003 to 55,114 in FY 2004. Criminal dispositions increased in FY 2004, from 45,647 in FY 2003 to 49,248 in FY 2004, a decrease of 7.9%. These three categories account for 75.8% of the dispositions in Superior Court.

Total end of year pending cases showed a decrease of 5,588 or 2.5%, from 220,197 in FY 2003 to 214,609 in FY 2004.

**In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.**

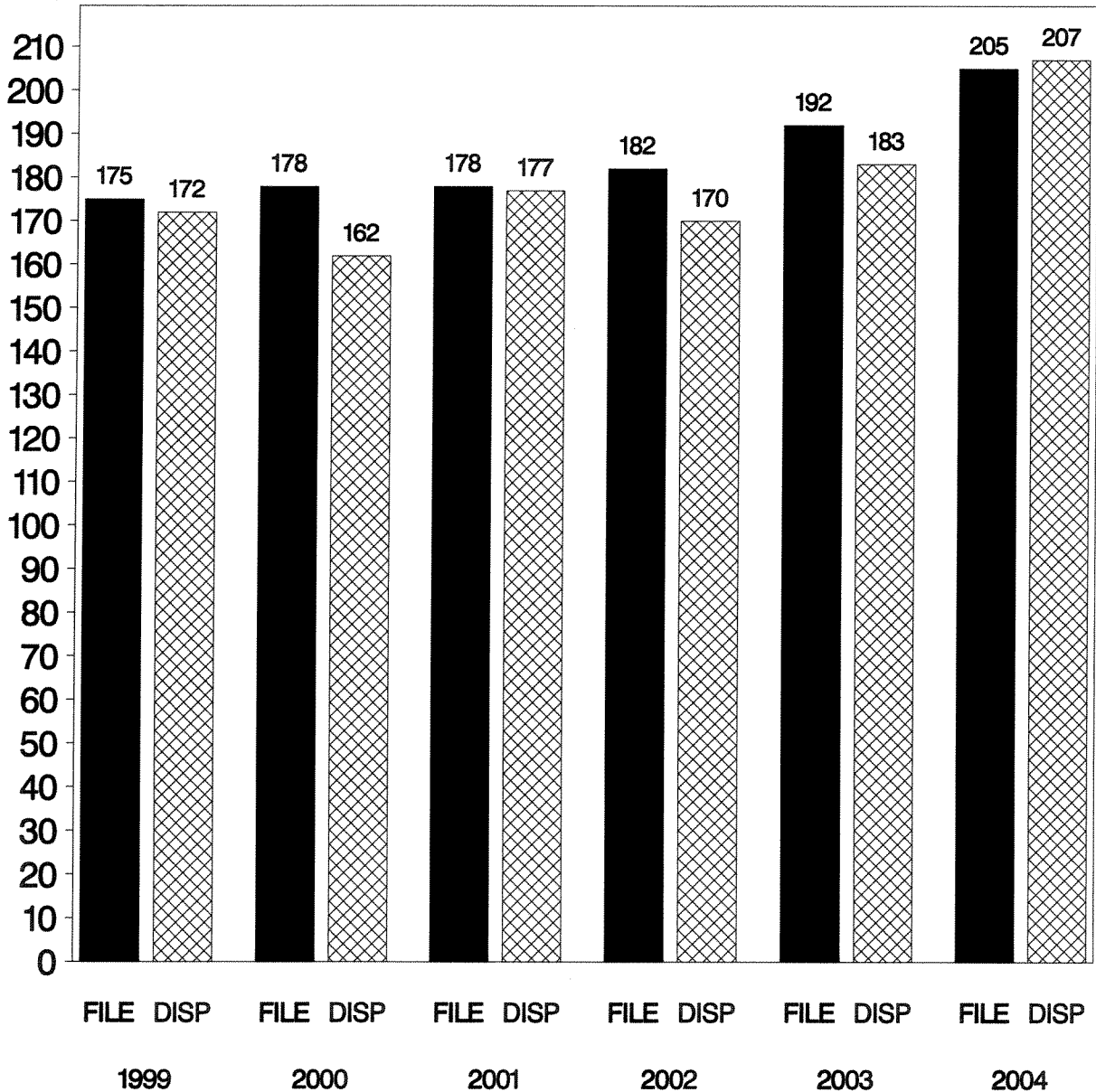

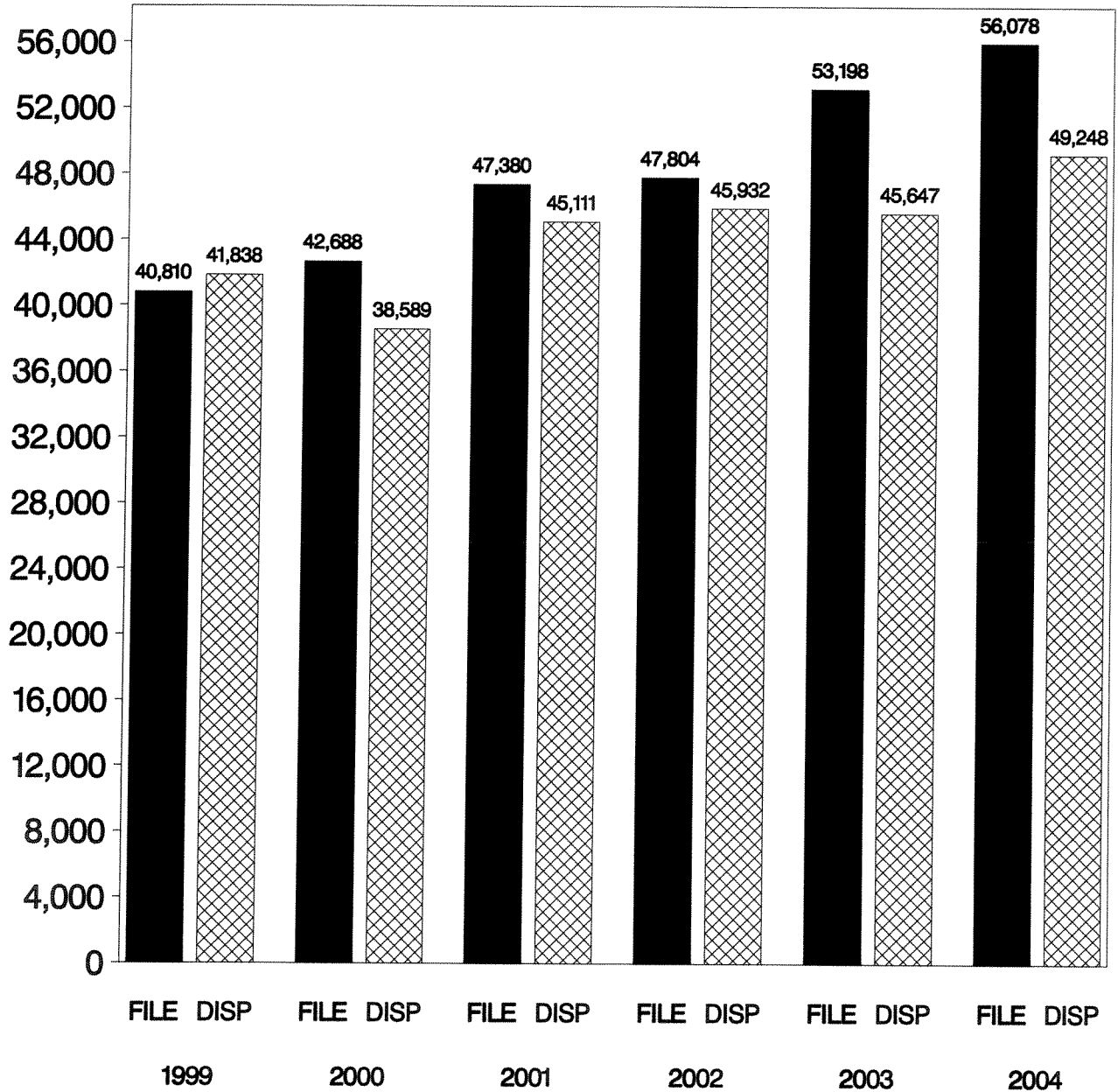

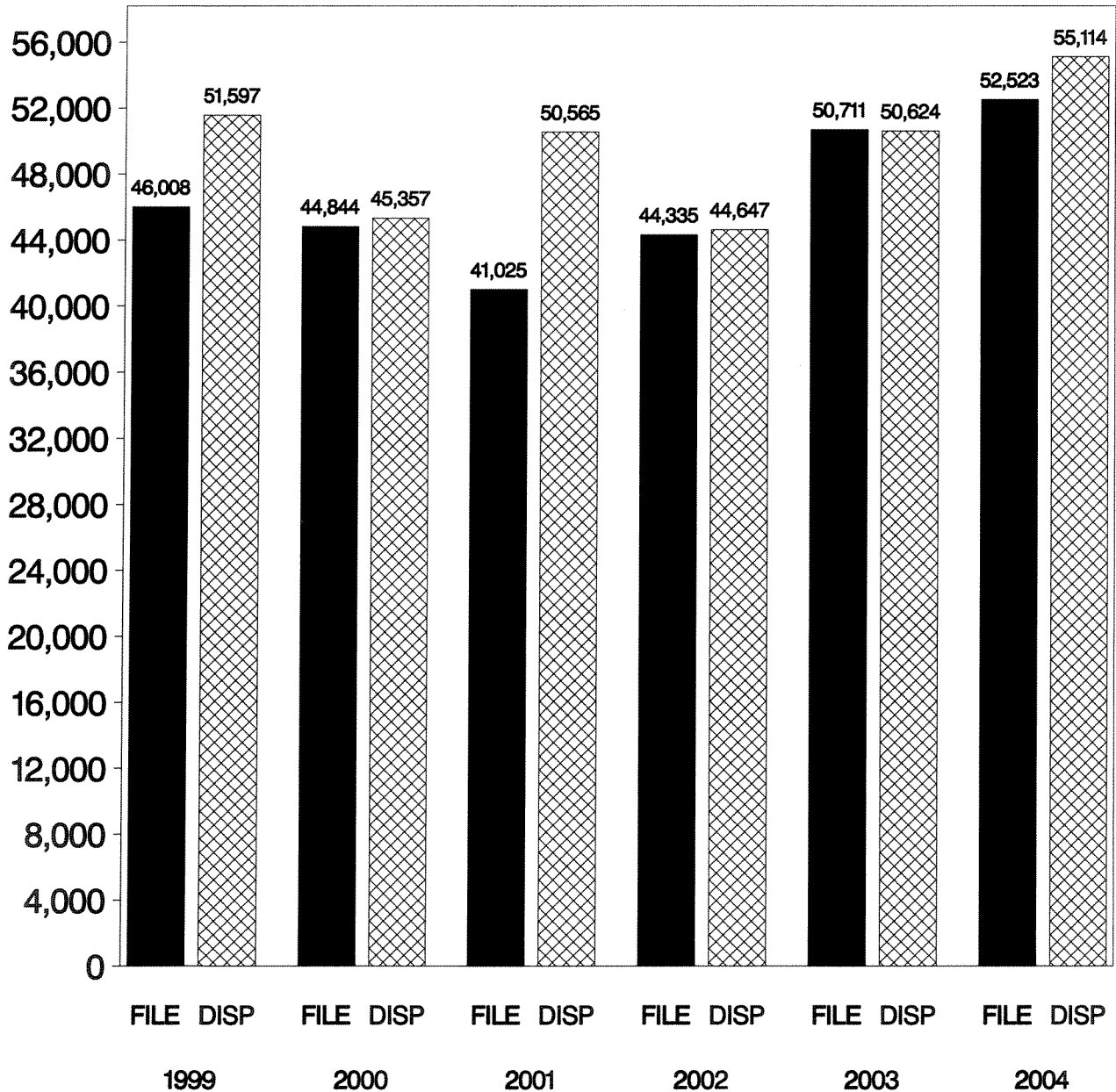

### CASES FILED AND DISPOSED

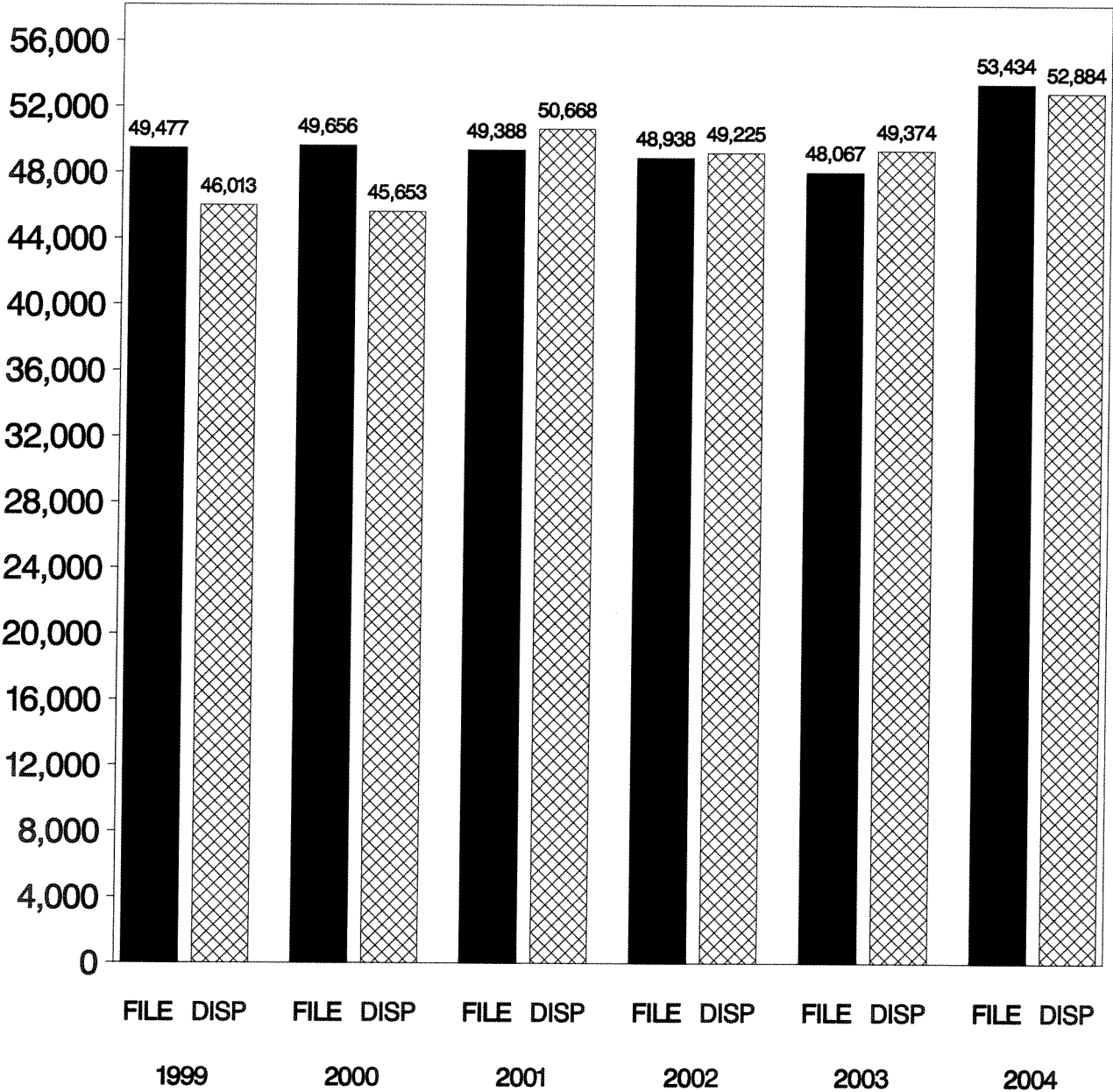
