

ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive)** Case Activity, the second covers **Standard** Adult Probation alone, and the third only **Intensive** Adult Probation. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second Probationers with **Petitions to Revoke**, and the third summarizes **Additional Probation Activity**.

There were a total of 32,601 individuals added to **standard and intensive** probation during FY 2000, including 7,046 absconders. During the same period, 32,447 probationers were terminated, of which 6,763 were absconders. As of the end of FY 2000, there were 36,188 active standard and intensive probationers and 8,455 absconders in Arizona, a total of 44,643 individuals. There were 14,334 petitions to revoke probation filed during the year, 20,755 terminated, and 2,435 pending at the end of the year. This number reflects the removal of absconders from this category. Additionally, probationers completed 1,741,161 community service hours in FY 2000 (17.5% over last year), and probation officers completed 25,749 presentence reports (down 1.9% over FY 1999) and collected \$32,982,395 in restitution, fines, surcharges, fees, reimbursements, and taxes from probationers (a 14.8% rise from FY 1999).

There were 25,441 persons placed on **standard** probation in FY 2000, which includes 5,783 absconders. During the year, 25,323 standard probationers were terminated, including 5,558 absconders. On June 30, 2000, 32,809 people were on active standard probation and 7,591 were absconders from standard probation, equaling a total of 40,400 individuals. A total of 10,503 petitions to revoke probation were filed in FY 2000; 16,055 petitions were terminated, and 2,137 were pending on the last day of the fiscal year. In addition, standard probationers completed 743,738 community service hours and paid a total of \$27,532,737 monies owed to the court.

Additions to **intensive** probation numbered 7,160 during FY 2000, of which 1,263 were absconders. Also during FY 2000, 7,124 intensive probationers were terminated, including 1,205 absconders. At the close of the fiscal year, there were 3,379 active intensive probationers and 864 intensive probation absconders, totaling 4,243 persons. In all, 3,831 petitions to revoke probation were filed and 4,700 petitions were terminated during the year, leaving 298 pending at the end of the year. Intensive probationers completed 997,423 hours of community service and paid \$5,449,658 in fines, restitution, and other monies.
