

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were down by 1.9%, from 177,891 in FY 98 to 174,494 this year. Superior Court's largest category, domestic relations, dropped from 49,540 in FY 98 to 49,477 in FY 99, a decrease of 0.1%. The next largest category, civil, decreased by 2.5%, from 47,166 in FY 98 to 46,009 in FY 99. Total criminal filings decreased by 3.9%, from 42,424 in FY 98 to 40,788 in FY 99. These three categories account for 78.1% of the Superior Court total filings.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 1999, these petitions together decreased by 0.2%, from 4,102 in FY 98 to 4,094 in FY 99. Separately, orders of protection declined by 0.4% from FY 98 whereas injunctions against harassment increased by 5.0% from 116 in FY 98 to 122 in FY 99. Juvenile services revised FY98 delinquent and incorrigible filings downward from 19,876 to 19,004 or 4.4%. Using the revised numbers, Juvenile delinquent and incorrigible filings decreased from 19,004 to 18,622 or 2.0%.

Total dispositions (including transfers) were down from 174,145 in FY 98 to 170,610 in FY 99, a decrease of 2.0%. Domestic relations dispositions decreased by 2.8%, from 47,337 in FY 98 to 46,019 in FY 99. Civil dispositions increased by 7.2%, from 48,131 in FY 98 to 51,596 in FY 99. Criminal dispositions decreased by 0.4%, from 40,893 in FY 98 to 40,724 in FY 99. These three categories account for 81.1% of the dispositions in Superior Court.

Total end of year pending cases showed an increase of 1,348 or 0.8%, from 166,797 in FY 98 to 168,145 in FY 99.

A third page of tables details dispositions of criminal defendants and appeals from limited jurisdiction courts.

In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.

Court trial statistics for some courts may not be comparable to previous years due to differences in data collection techniques.

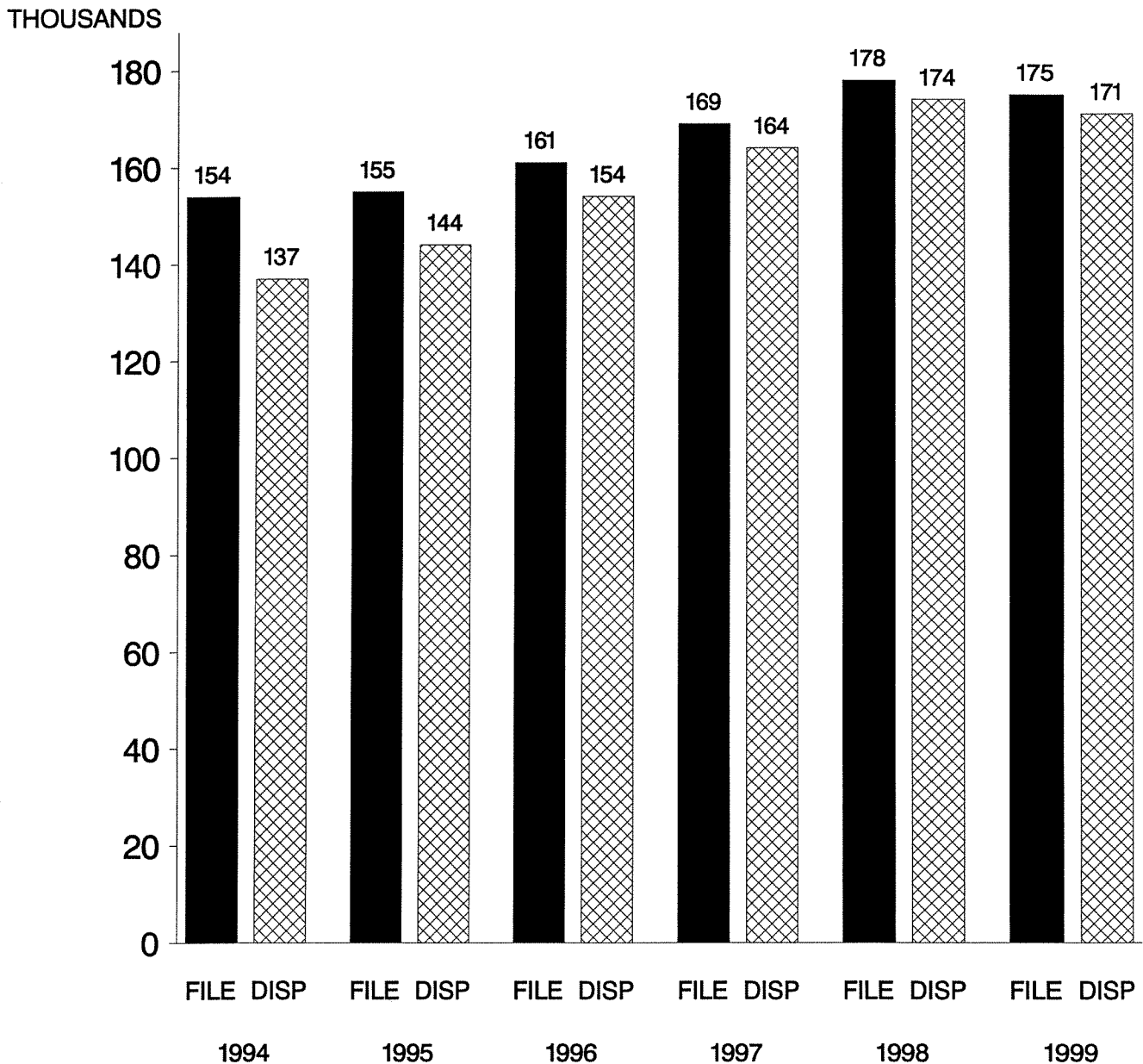

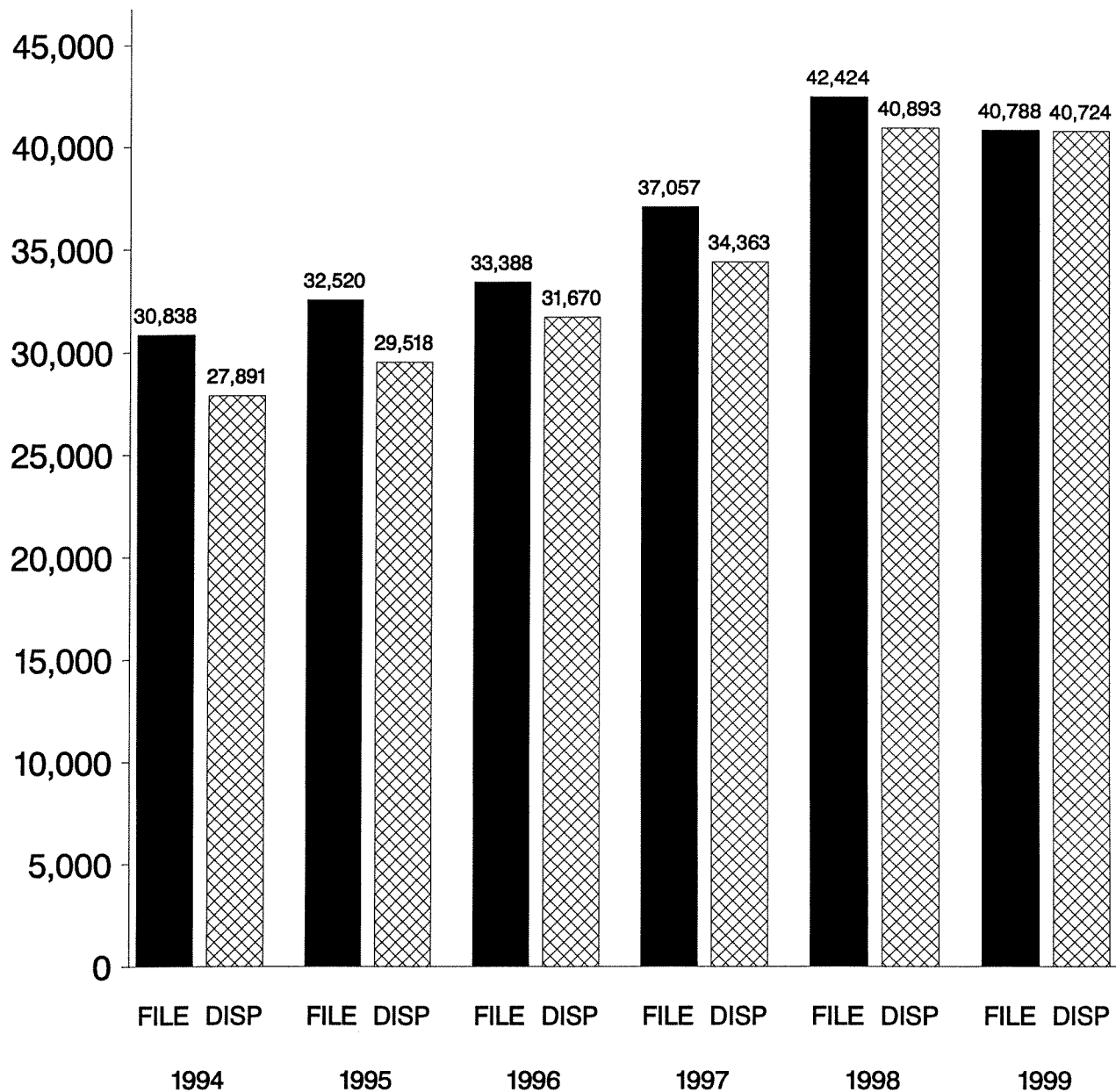
## ANNUAL CASE ACTIVITY, FY 1994 – 99 CASES FILED AND DISPOSED

## CRIMINAL CASE ACTIVITY, FY 1994 – 99 CASES FILED AND DISPOSED

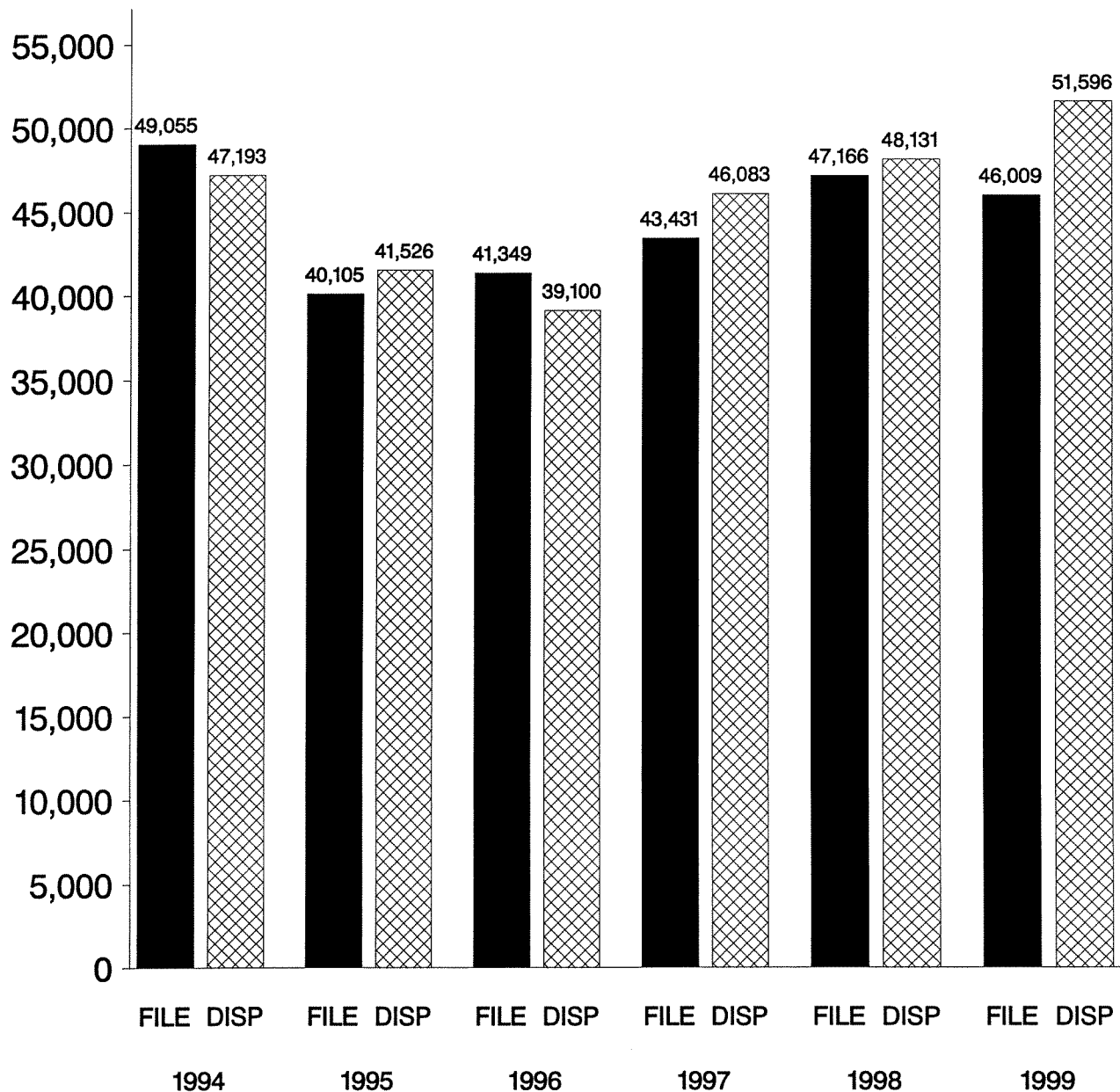

### CASES FILED AND DISPOSED

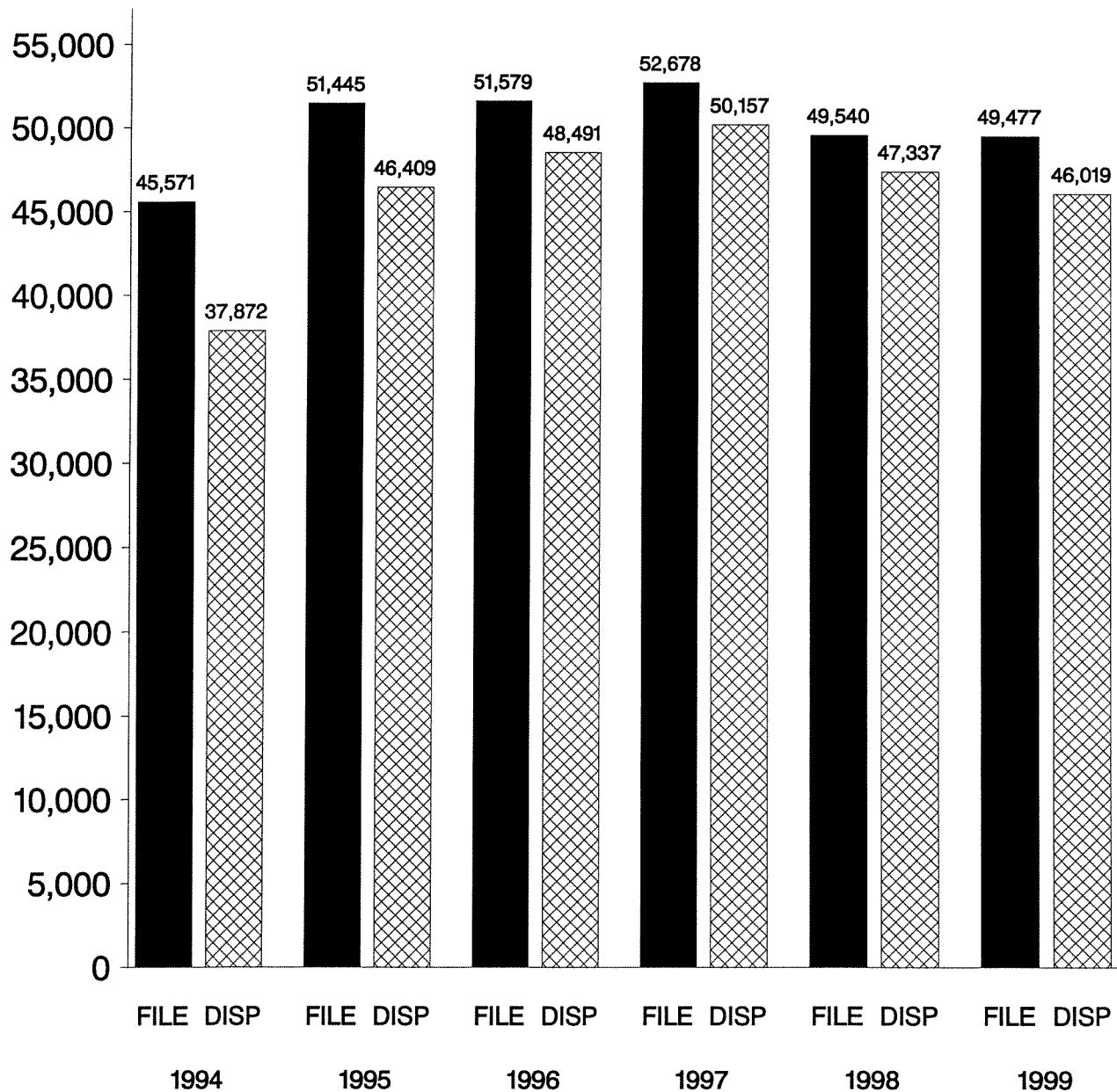
