

## **LIMITED JURISDICTION COURTS**

### **Narrative Summary**

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) increased 1.4% in FY 2000, from 2,236,994 last year to 2,269,396. Traffic cases comprised the majority (70.2%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) increased by 2.2%, from 1,558,133 last year to 1,593,025 in FY 2000. Criminal filings (misdemeanors and felonies) decreased by 3.5%, from 392,416 in FY 1999 to 378,509 in FY 2000.

Continuing the upward trend from the last two years, petitions for orders of protection in domestic violence increased from 18,270 in FY 1999 to 18,425 in FY 2000, an increase of 0.8%. Petitions for injunctions against harassment increased by 2.8%, from 16,414 in FY 1999 to 16,871 in FY 2000.

Total dispositions (including transfers) decreased by 2.9%, from 2,132,062 last year to 2,069,899 in FY 2000. Traffic dispositions (criminal and civil) decreased by 4.2% while criminal dispositions (misdemeanor and felony) declined by 0.7% from last year. Only 7.8% of the orders of protection and 11.4% of the harassment petitions ruled upon were denied.

Total end of year pending cases increased from 1,245,412 in FY 1999 to 1,426,321 in FY 2000, an increase of 14.5%. Most of the increase was in civil traffic which increased from 295,571 in FY 1999 to 381,543 in FY 2000, an increase of 29.1%.

**Note: Data for orders of protection and injunctions against harassment in some courts may not be comparable to previous years due to changes in computer systems and data entry requirements.**

**Some of the FY 1999 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.**

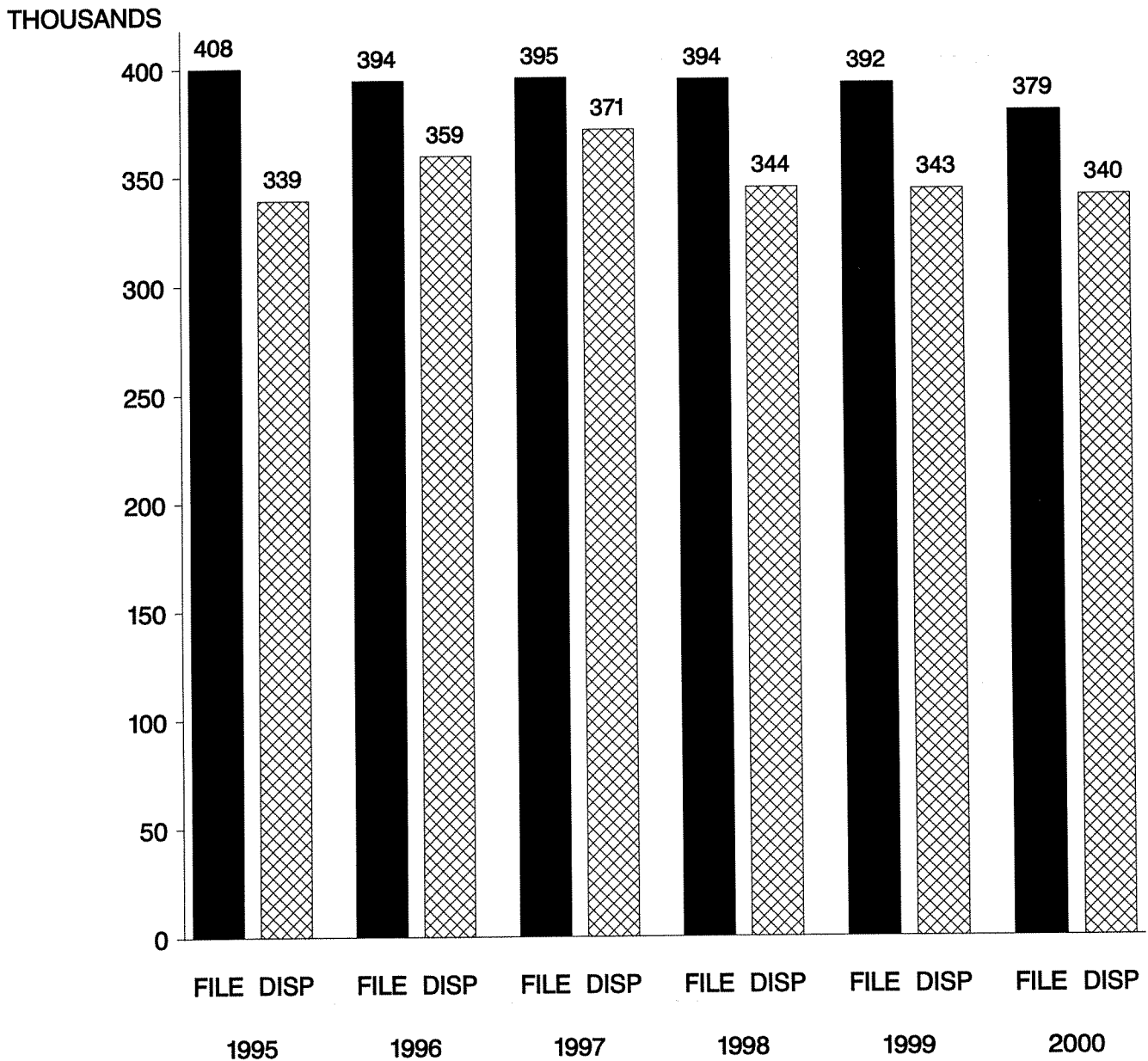

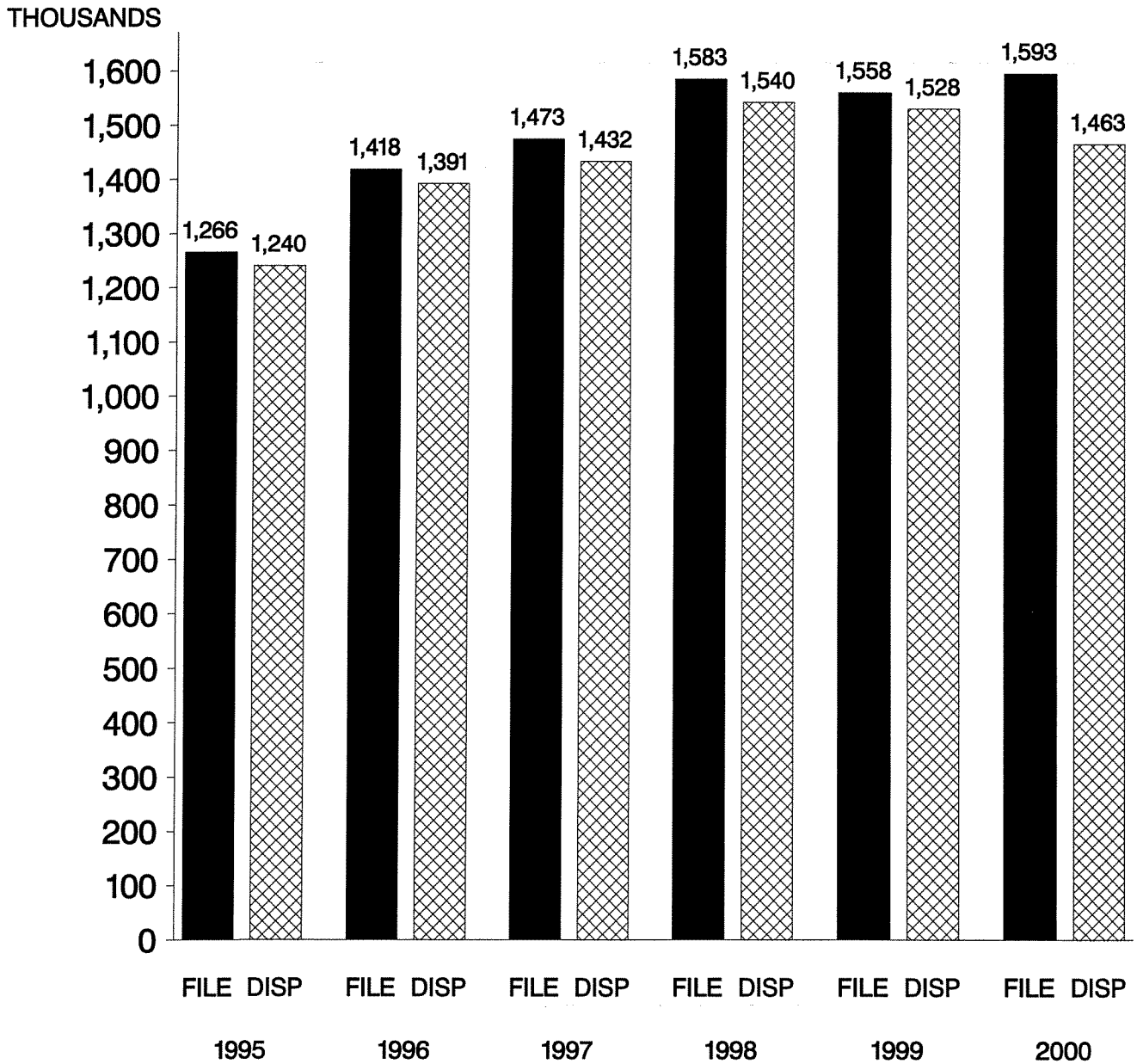

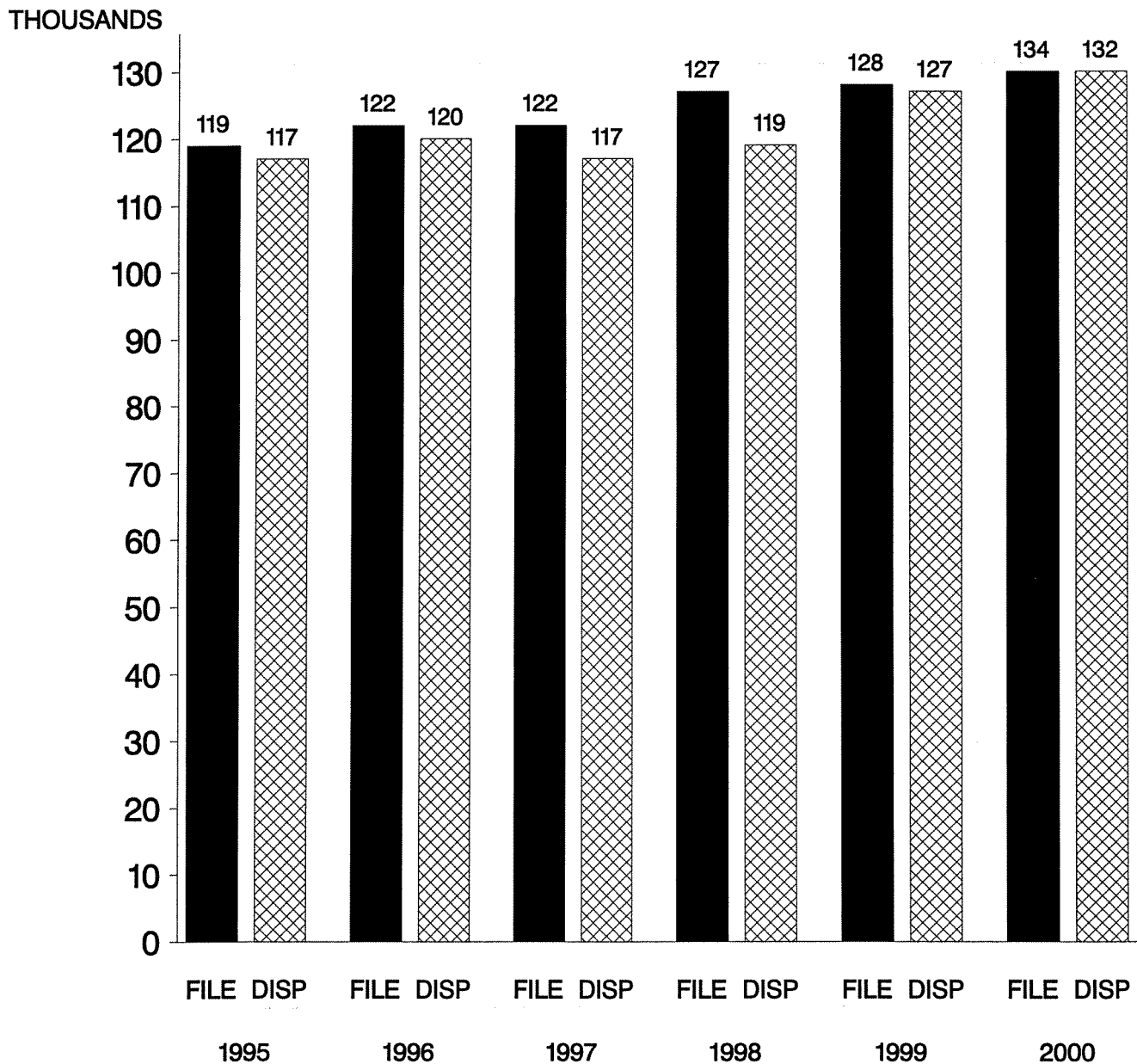

### CASES FILED AND DISPOSED



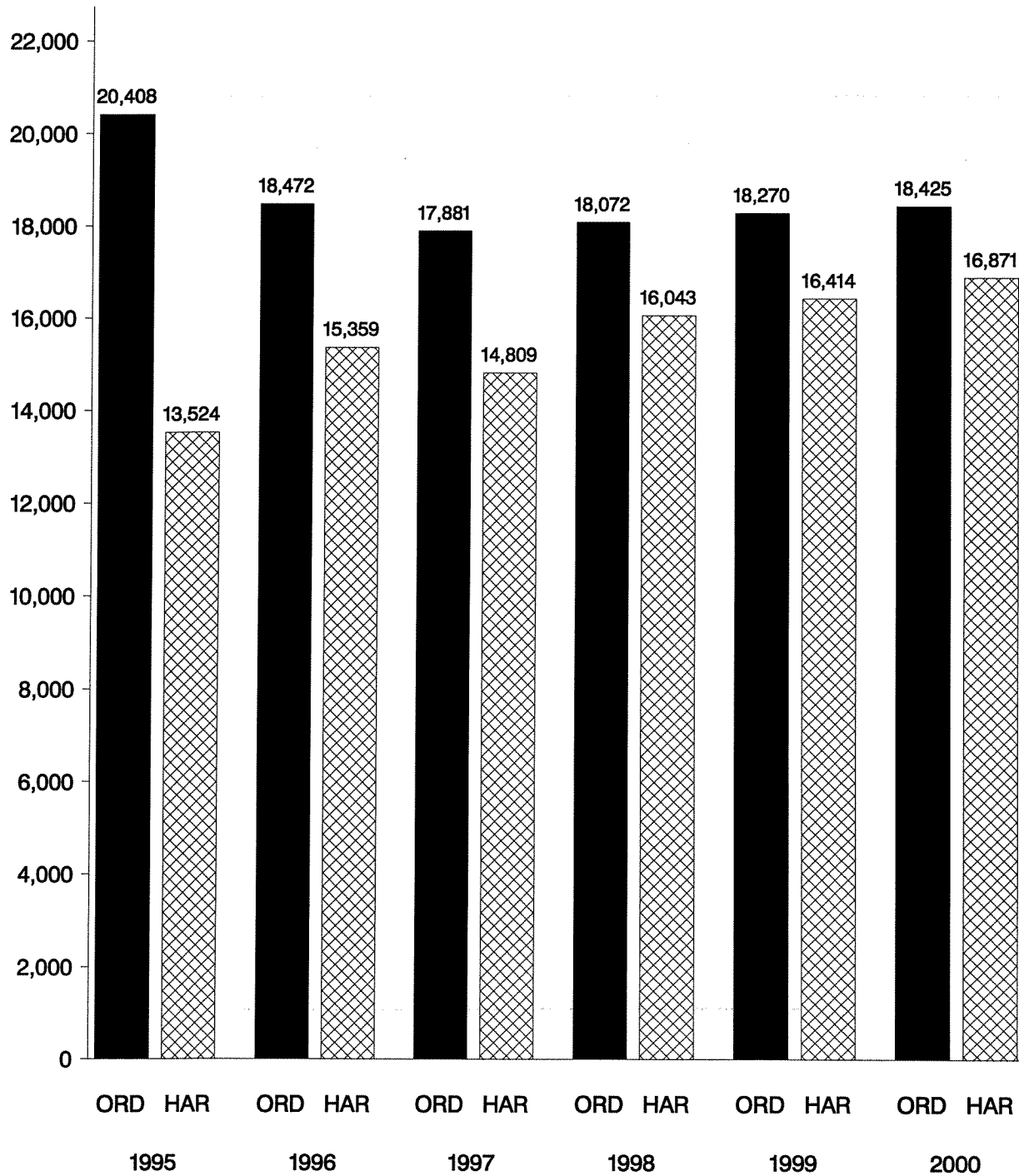
