

## **JUSTICE OF THE PEACE COURTS**

### **Narrative Summary**

Justice Courts experienced an increase in total filings (including transfers in) in FY 2000, from 788,669 to 848,713, this is an increase of 7.6%. Beginning in FY 1996, Justice Courts reported Non-Criminal Local Ordinances as a separate category. Many of these were reported as part of other categories in the previous years, but their numbers are not comparatively large.

Traffic filings (criminal and civil), which accounted for 64.0% of the workload in Justice Courts, went from 493,184 to 543,158, a 10.1% increase from FY 1999 to FY 2000. Non-Traffic criminal filings (misdemeanors and felonies) increased 2.7%, from 161,624 last year to 165,991 in FY 2000. Civil filings were up slightly from 128,437 in FY 1999 to 134,026 this year, an increase of 4.4%.

Petitions for orders of protection relating to domestic violence increased this year by 2.7%, from 7,932 in FY 1999 to 8,147. Last year the trend showed a decrease of 3.2% from FY 1998 to FY 1999 in this case type. In FY 2000 petitions for injunctions against harassment increased from 8,252 in FY 1999 to 8,569 in FY 2000, an increase of 3.8%.

Total dispositions (including transfers out) increased by 6.7%, from 737,669 last year to 786,836 in FY 2000. Criminal and civil traffic dispositions together increased by 7.4%, from 470,025 to 504,861. Criminal dispositions (misdemeanors and felonies) increased by 6.6%, from 135,453 in FY 1999 to 144,344 in FY 2000. Civil dispositions increased by 4.1%, from 126,897 to 132,068.

Total end of year pending cases increased from 528,776 in FY 1999 to 555,389 in FY 2000, an increase of 5.0%. Most of the increase was in civil traffic, which increased from 123,363 in FY 1999 to 135,119 in FY 2000, an increase of 9.5%.

**Note: Data for orders of protection and injunctions against harassment in some courts may not be comparable to previous years due to changes in computer systems and data entry requirements.**

**Some of the FY 1999 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.**

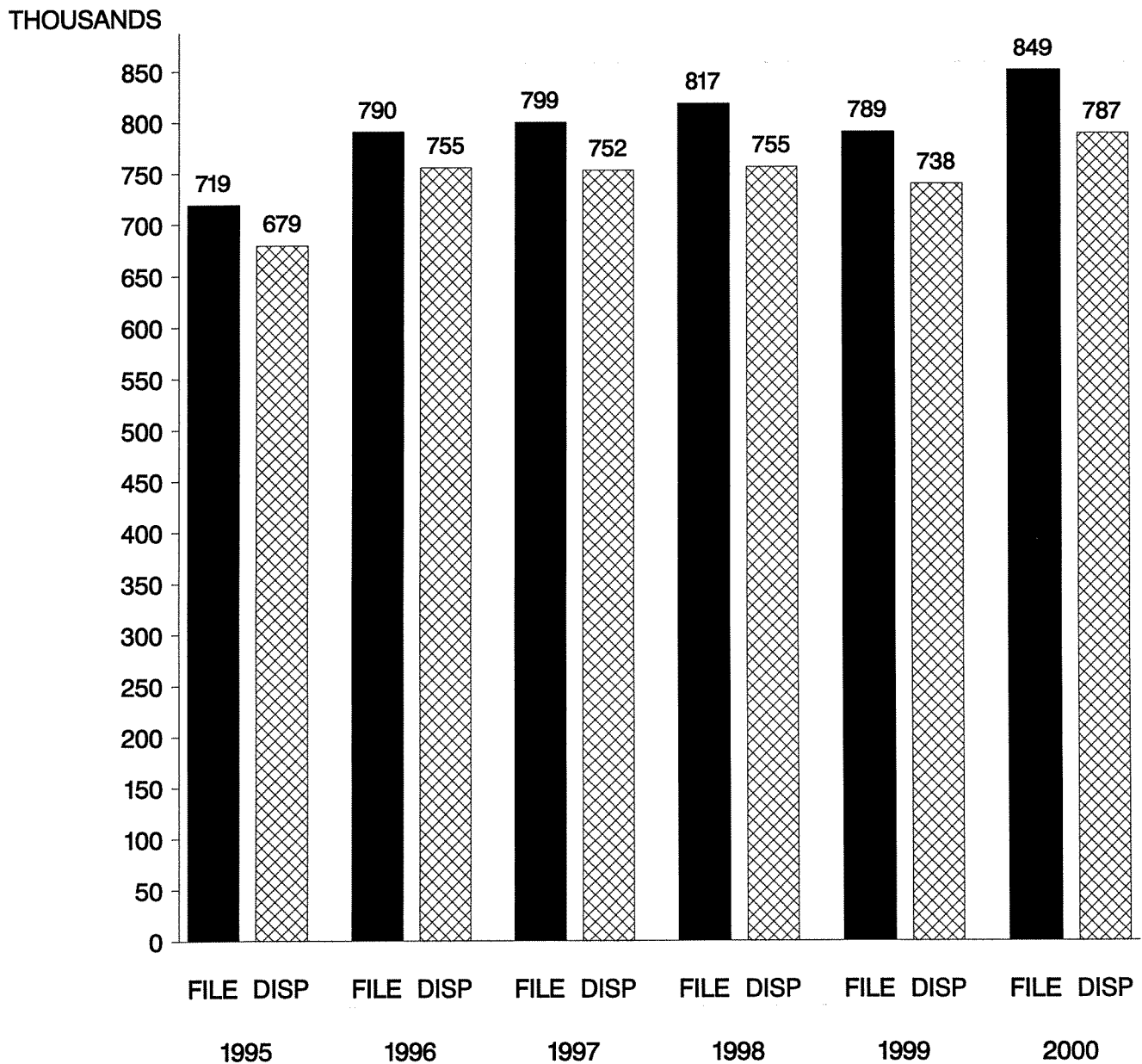

## ANNUAL CASE ACTIVITY, FY 1995 – 2000

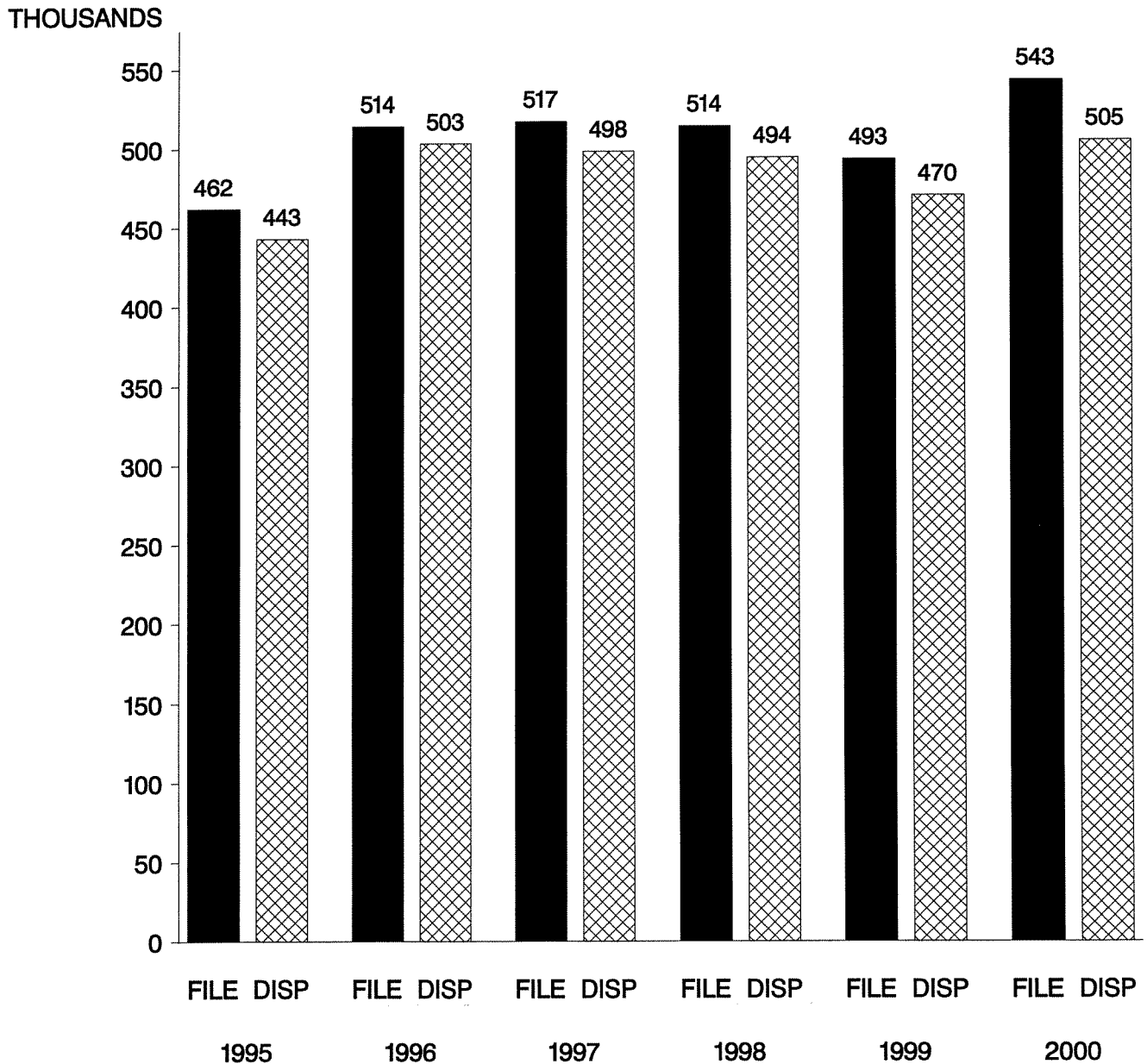

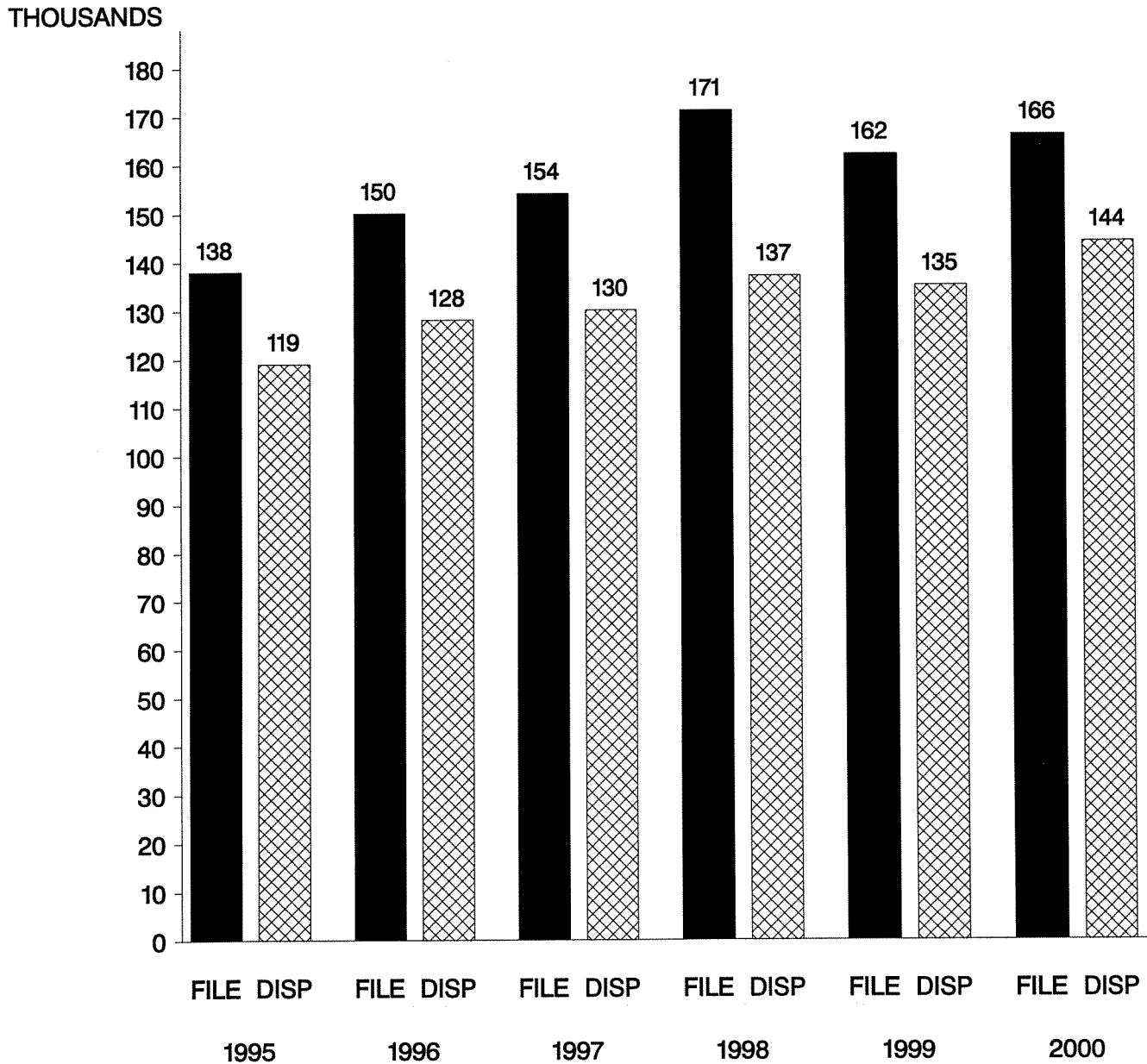
## TRAFFIC CASE ACTIVITY, FY 1995–2000 CASES FILED AND DISPOSED

## CRIMINAL CASE ACTIVITY, FY 1995 – 2000 CASES FILED AND DISPOSED

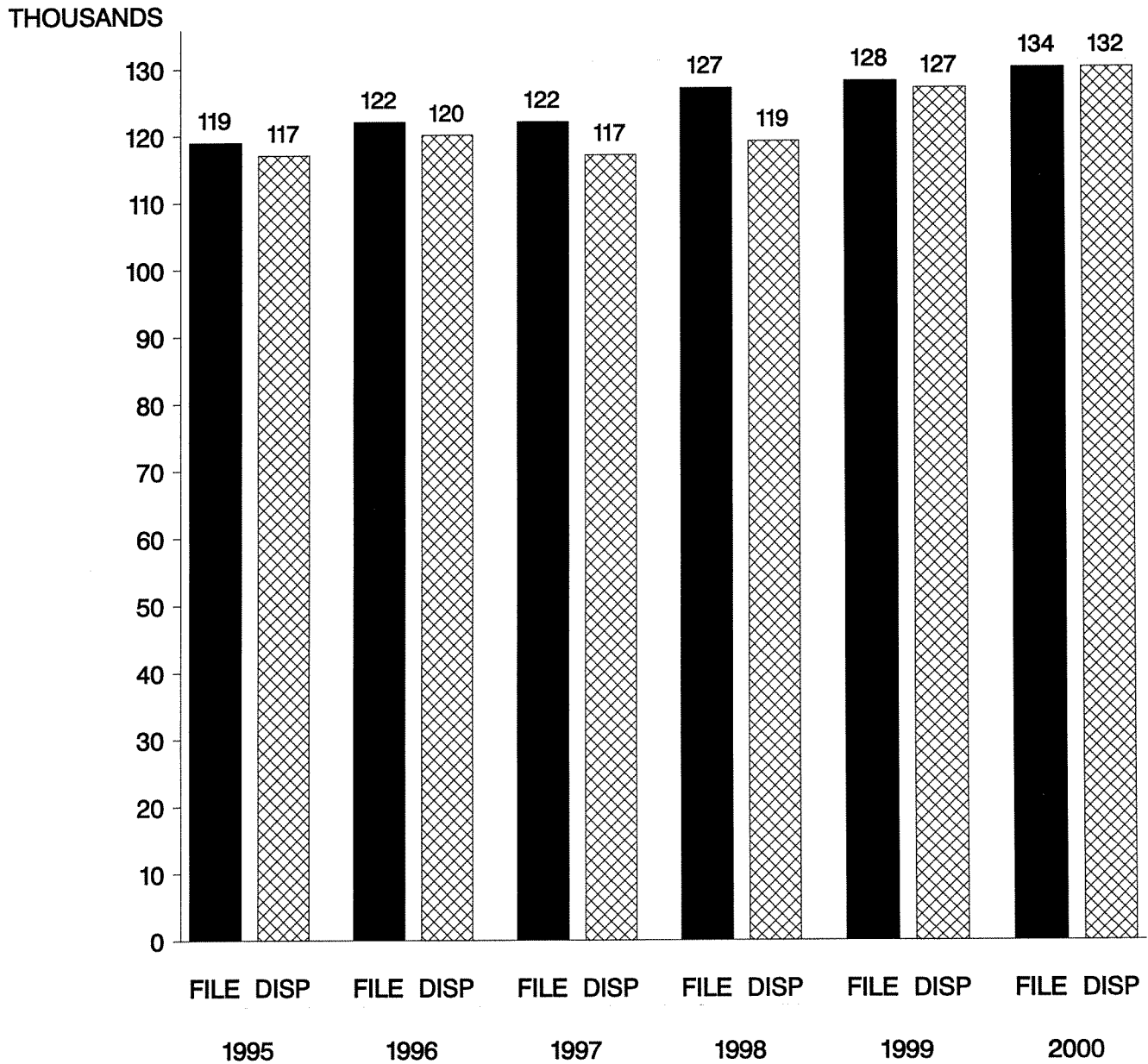

### CASES FILED AND DISPOSED

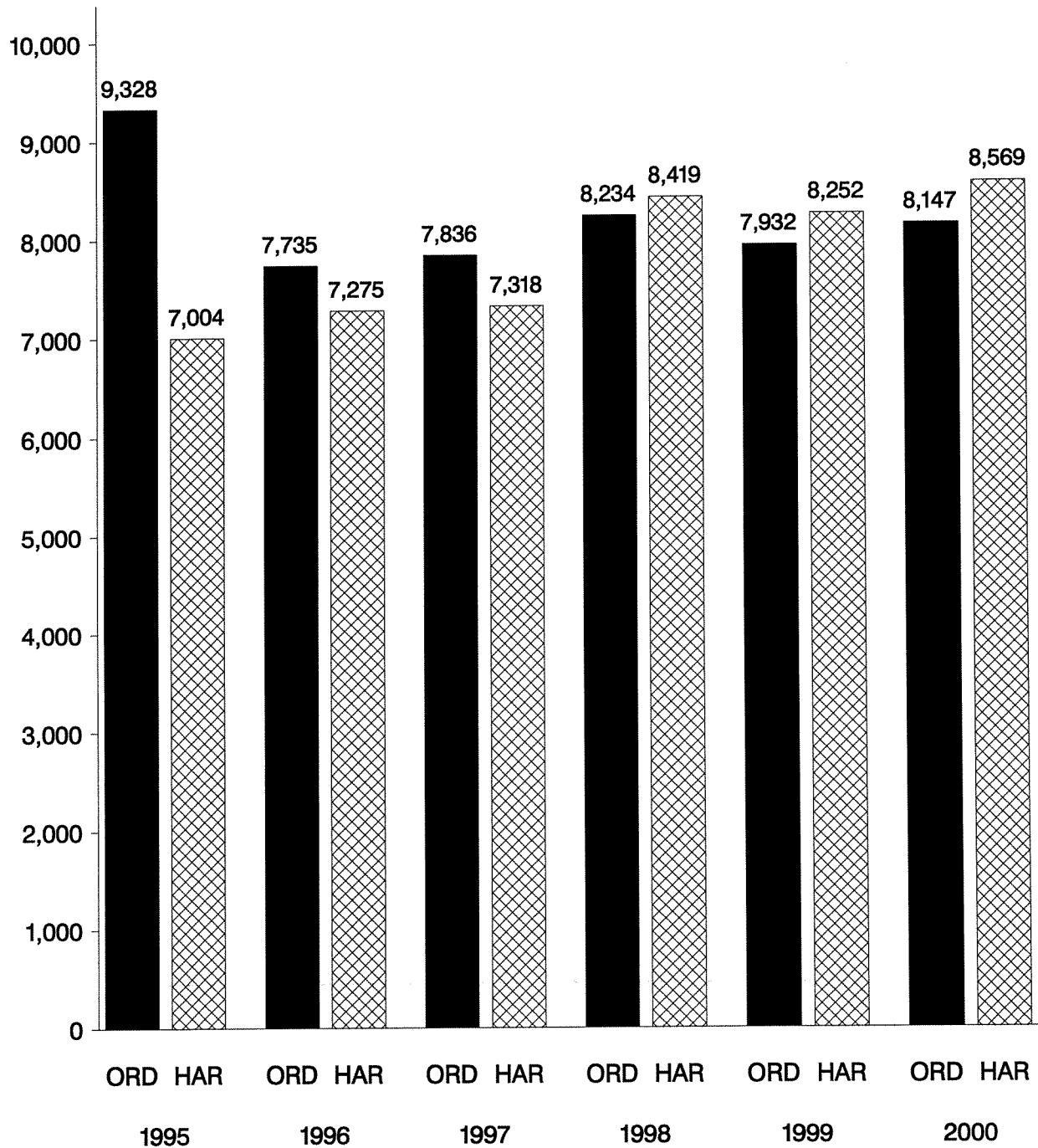
