

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 1.8% in FY 2004, from 2,331,276 last year to 2,288,173. Traffic cases comprised the majority (68.5%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 2.9%, from 1,613,092 last year to 1,566,407 in FY 2004. Criminal filings (misdemeanors and felonies) decreased by 1.3%, from 382,607 in FY 2003 to 377,729 in FY 2004.

Continuing the upward trend from the last six years, petitions for orders of protection in domestic violence cases increased from 23,740 in FY 2003 to 24,420 in FY 2003, an increase of 2.9%. Petitions for injunctions against harassment decreased slightly, from 19,635 in FY 2003 to 19,509 in FY 2004, a decrease of .6%.

Total dispositions (including transfers) increased by .3%, from 2,279,900 last year to 2,286,572 in FY 2004. Traffic dispositions (criminal and civil) decreased by 1.3% while criminal dispositions (misdemeanor and felony) increased by .3 % from last year. Only 11.9% of the orders of protection and 18.0% of the harassment petitions ruled upon were denied.

Total end of year pending cases decreased from 1,491,095 in FY 2003 to 1,479,669 in FY 2004, an increase of .8%. Most of the decrease was in the civil and criminal traffic category, which decreased from 1,613,092 in FY 2003 to 1,566,407 in FY 2004, a decrease of 2.9%.

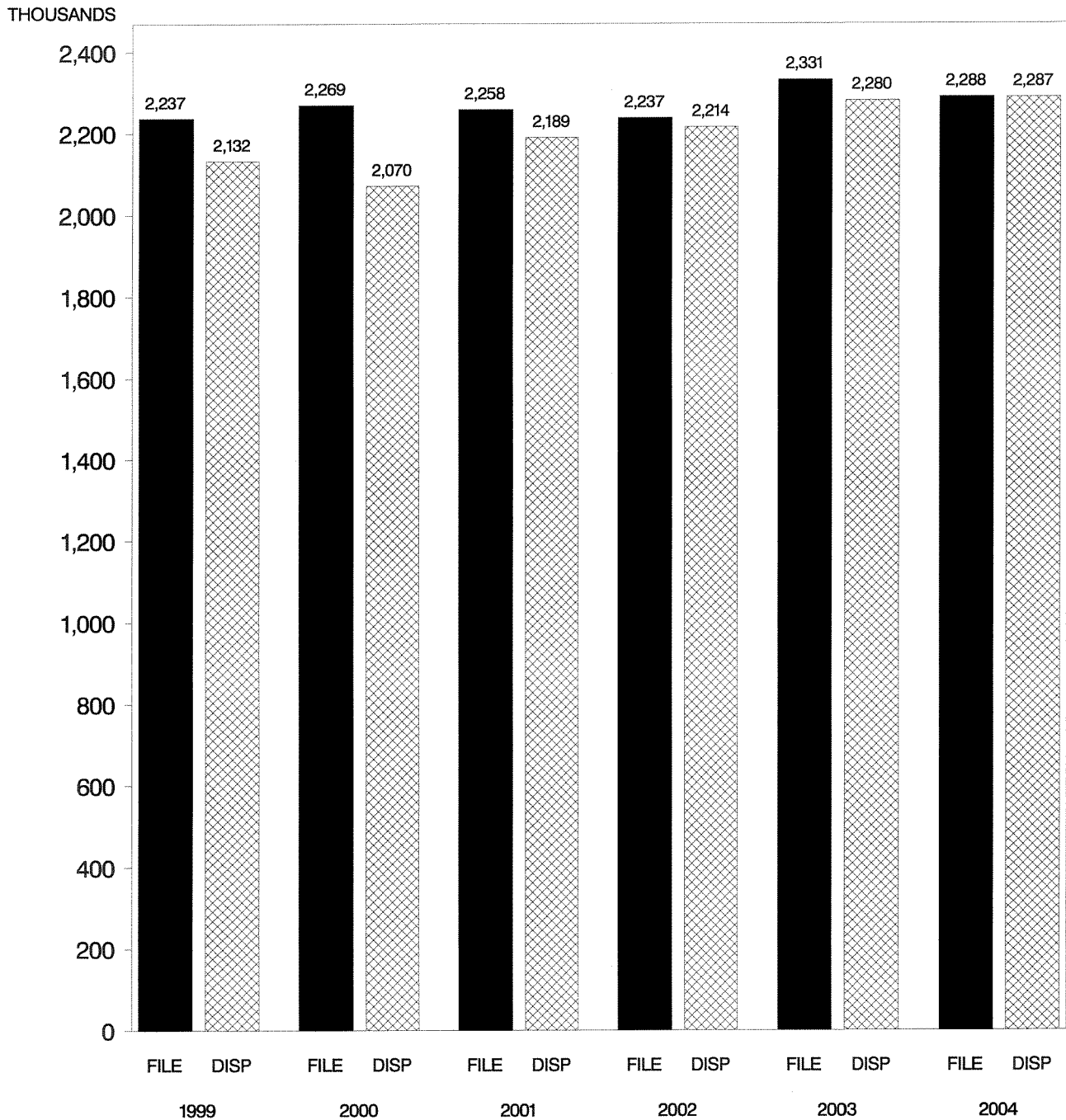

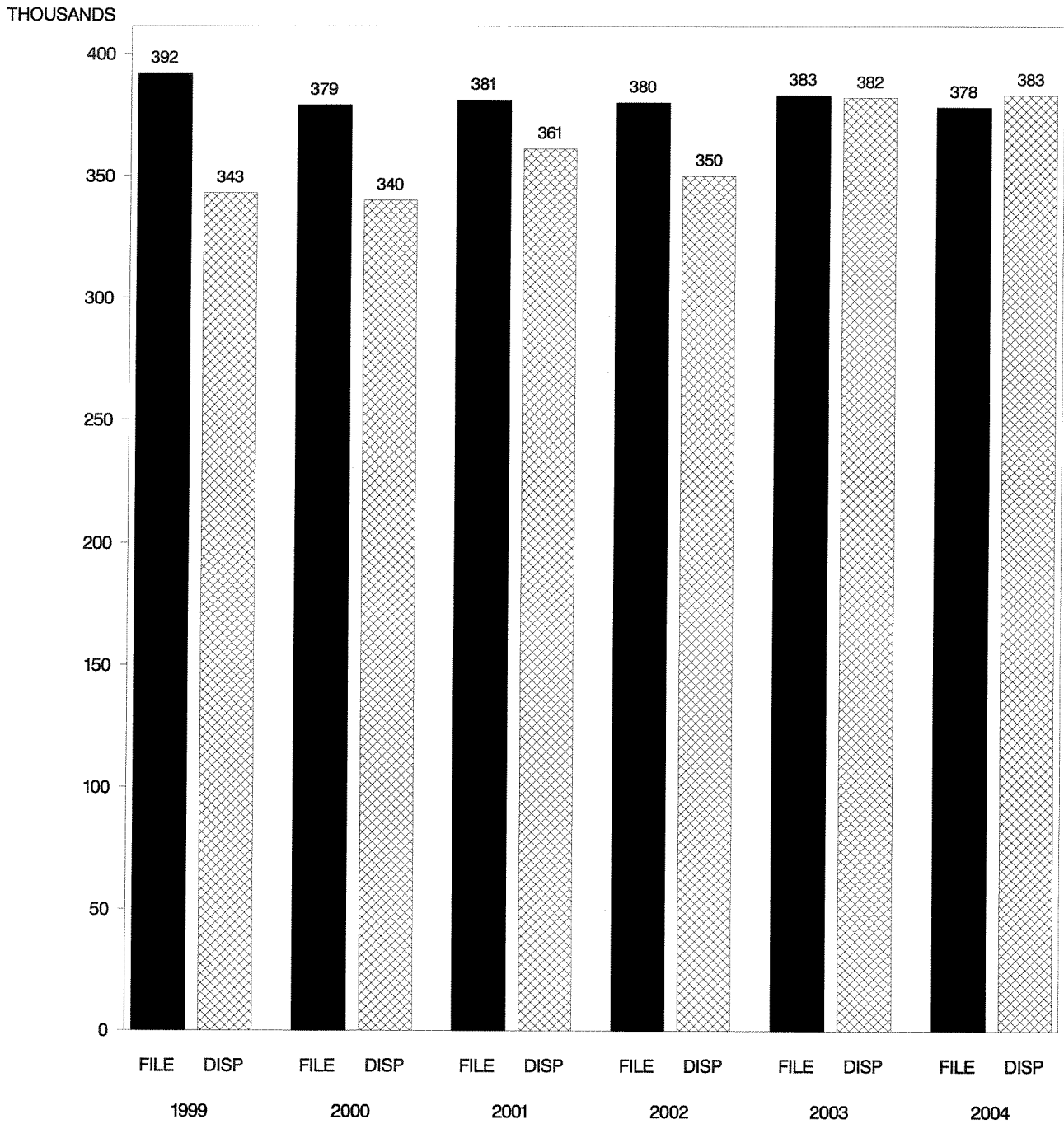

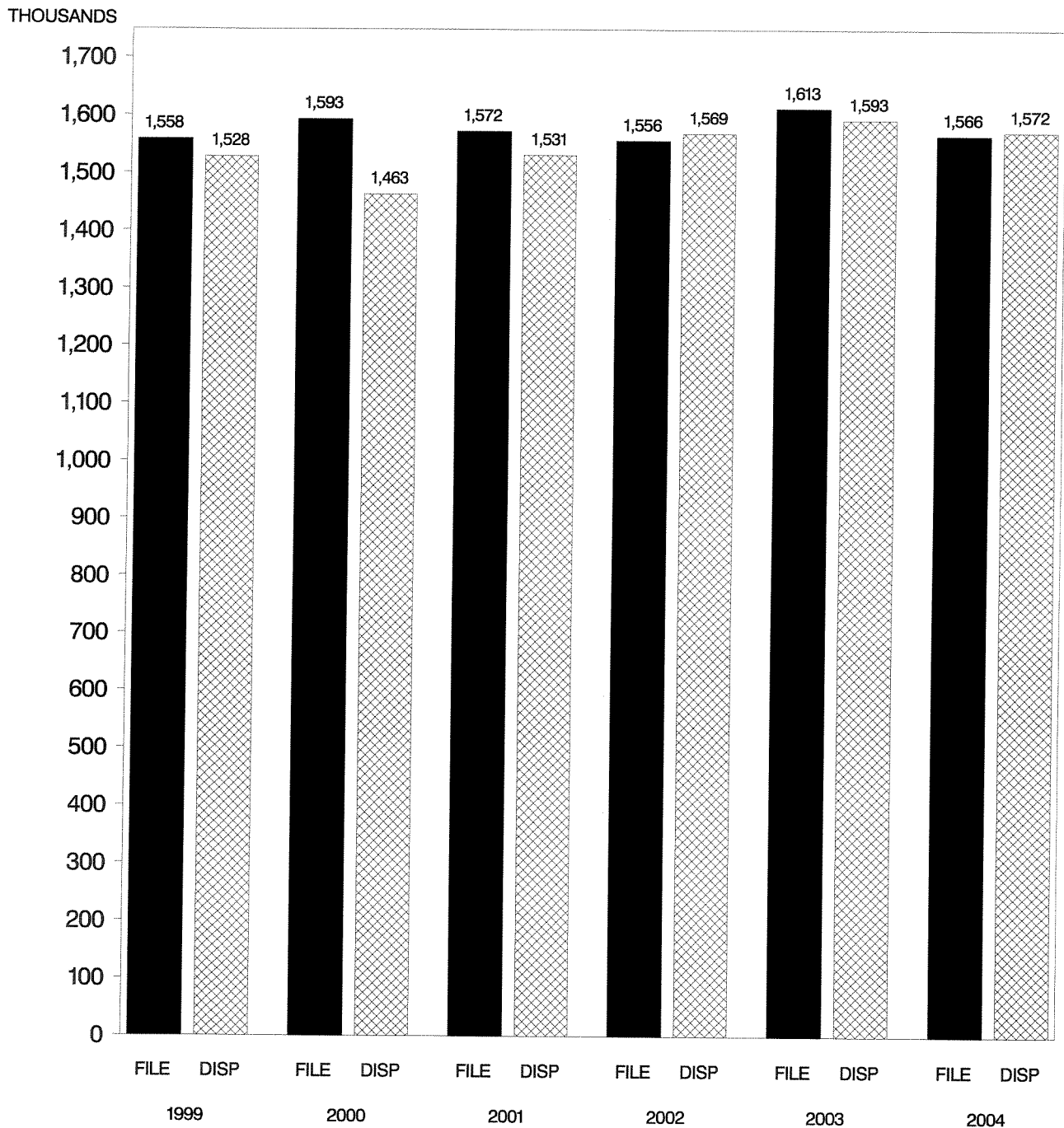

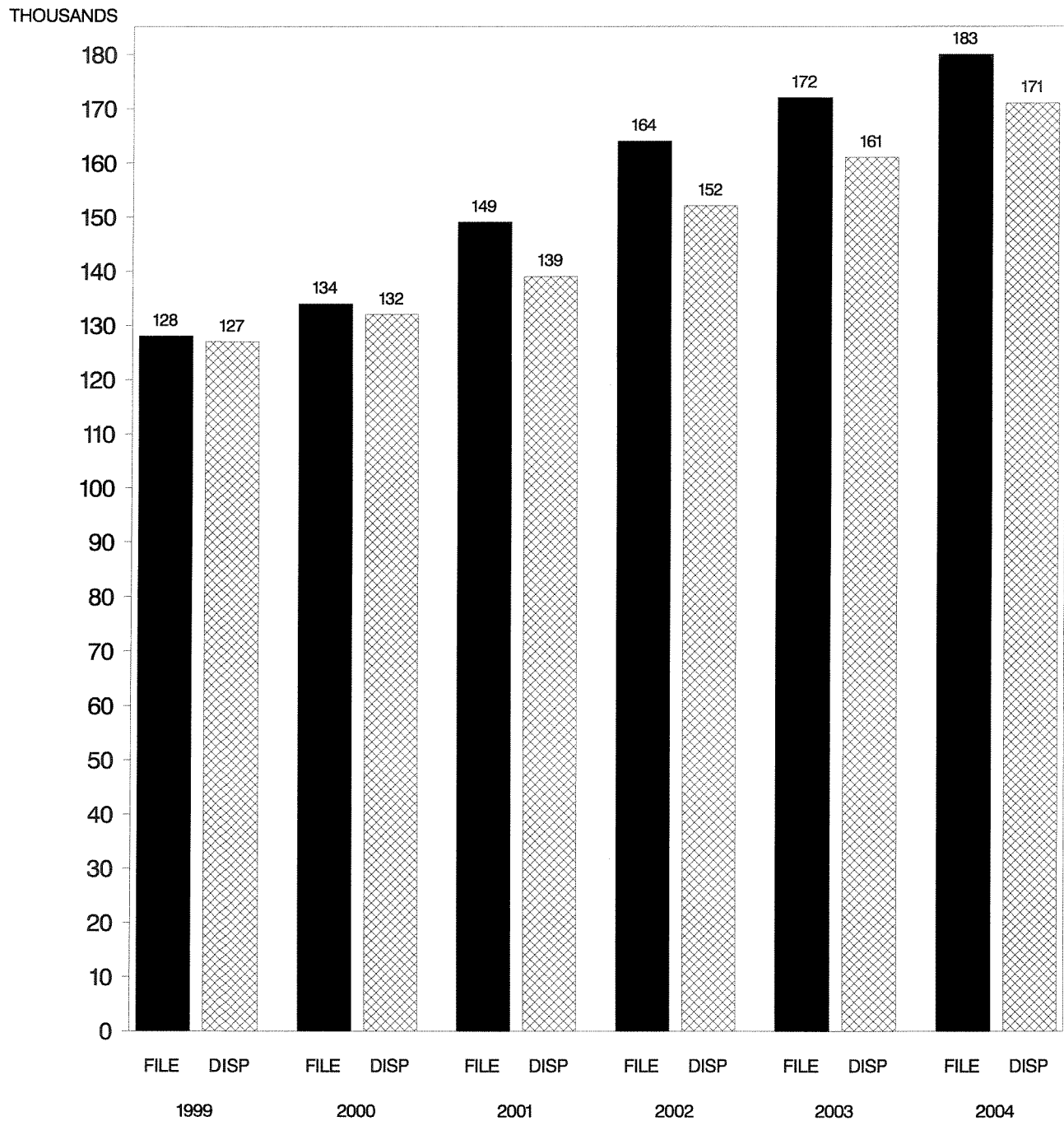

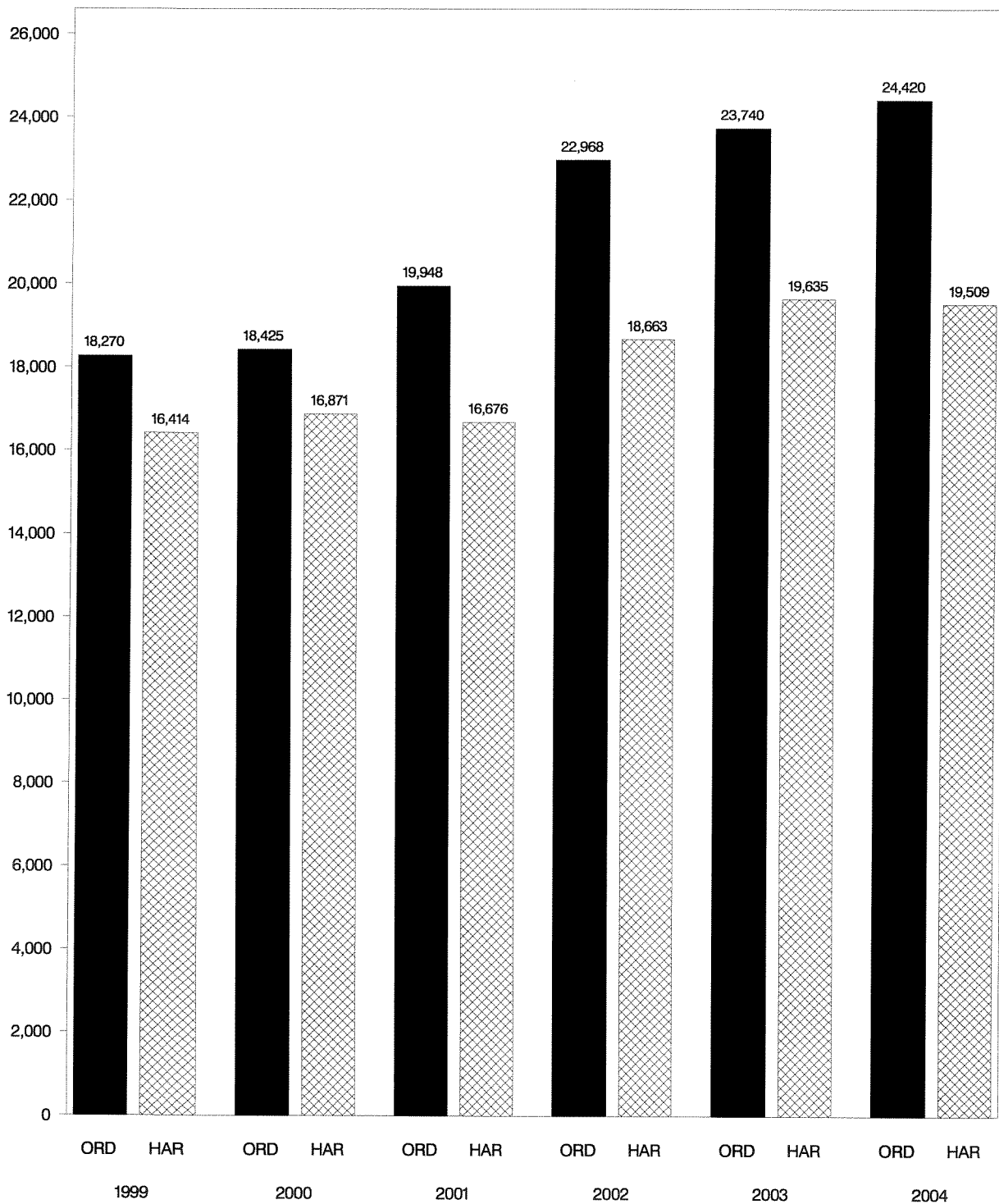
