

## **SUPERIOR COURT Narrative Summary**

Total filings (including transfers in) were up by 5.8%, from 181,680 in FY 2002 to 192,129 this year. Superior Court's largest category, criminal filings, experienced an increase of 11.3%, from 47,804 in FY 2002 to 53,198 in FY 2003. The next largest category, civil cases, increased by 14.4%, from 44,335 in FY 2002 to 50,711 in FY 2003. Domestic relations filings decreased by 1.8%, from 48,938 in FY 2002 to 48,067 in FY 2003. These three categories account for 79.1% of the Superior Court total filings.

Prior to 1996, petitions for orders of protection and injunctions against harassment in Superior Court were reported together under domestic violence petitions. In FY 2003, these petitions together increased by 24.5%, from 7,795 in FY 2002 to 9,701 in FY 2003. Separately, orders of protection were up by 24.6% from FY 2002 and injunctions against harassment increased by 23.9% in FY 2003. Juvenile delinquent and incorrigible filings decreased moderately, from 19,863 to 18,530 or 6.7%.

Total dispositions (including transfers) were up from 169,721 in FY 2002 to 183,355 in FY 2003, an increase of 8.0%. Domestic relations dispositions experienced a slight increase of 0.3%, from 49,225 in FY 2002 to 49,374 in FY 2003. Civil dispositions increased sharply by 13.4%, from 44,674 in FY 2002 to 50,624 in FY 2003. Criminal dispositions decreased slightly in FY2003, from 45,932 in FY 2002 to 45,647 in FY 2003, a decrease of 0.6%. These three categories account for 79.4% of the dispositions in Superior Court.

Total end of year pending cases showed an increase of 13,990 or 6.8%, from 206,254 in FY 2002 to 220,244 in FY 2003.

**In 1996, two additional categories were added to the Superior Court report, Adult Adoption, previously reported in the probate category, and Mental Health. In this report, criminal filings and juvenile petition statistics represent the number of persons; all other statistics represent cases.**

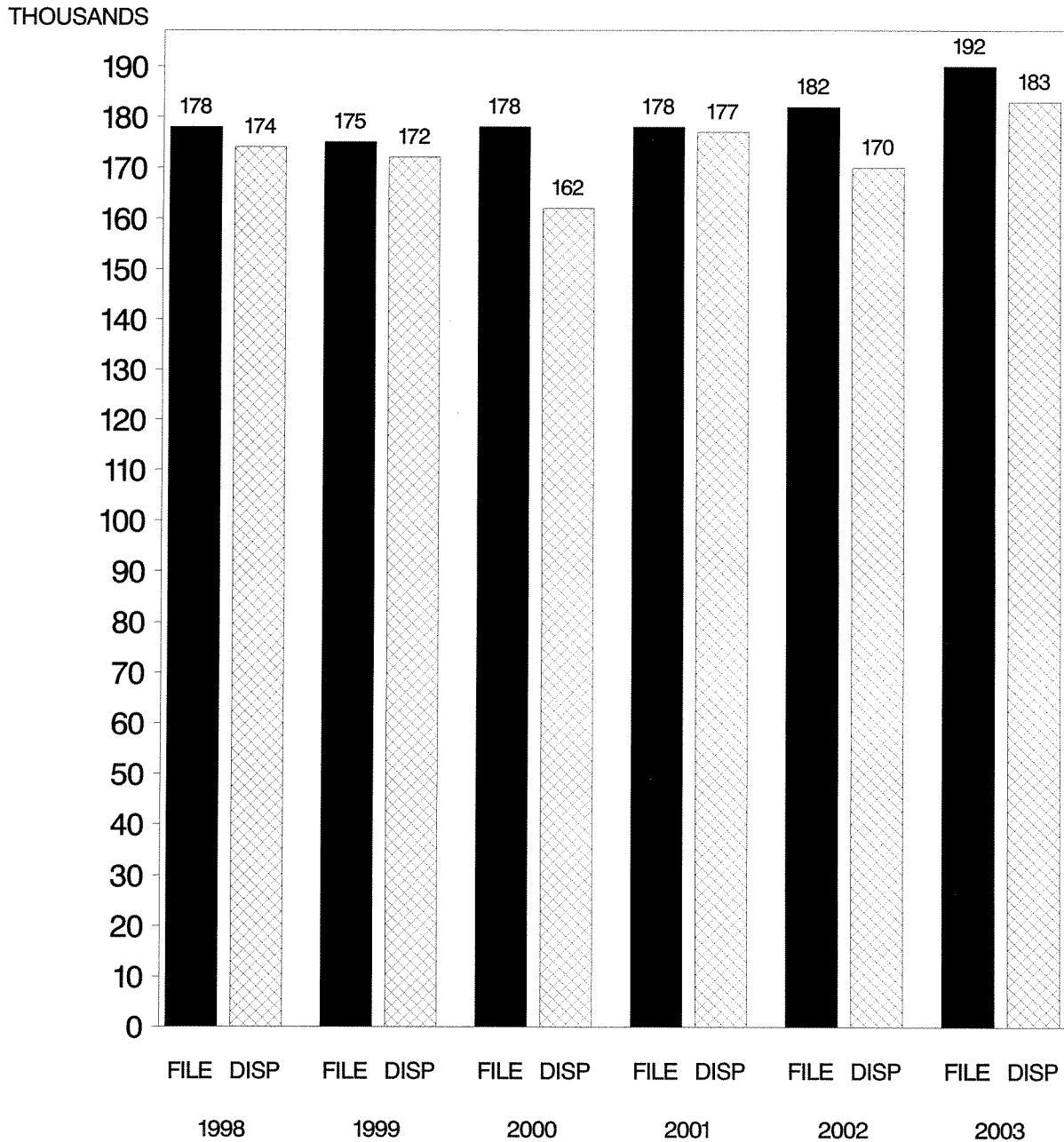

## ANNUAL CASE ACTIVITY, FY 1998 – 2003

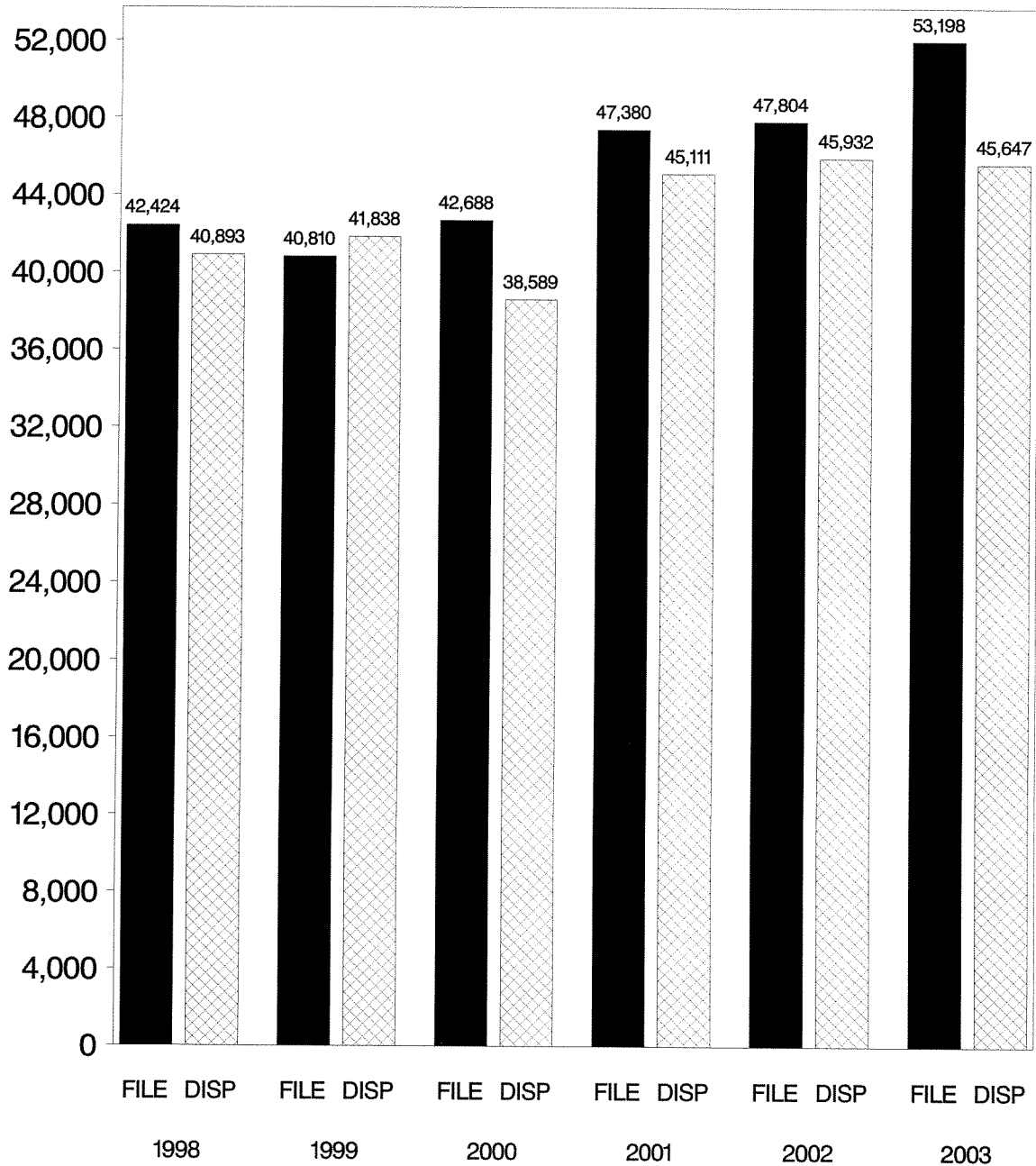

## CRIMINAL CASE ACTIVITY, FY 1998 – 2003 CASES FILED AND DISPOSED

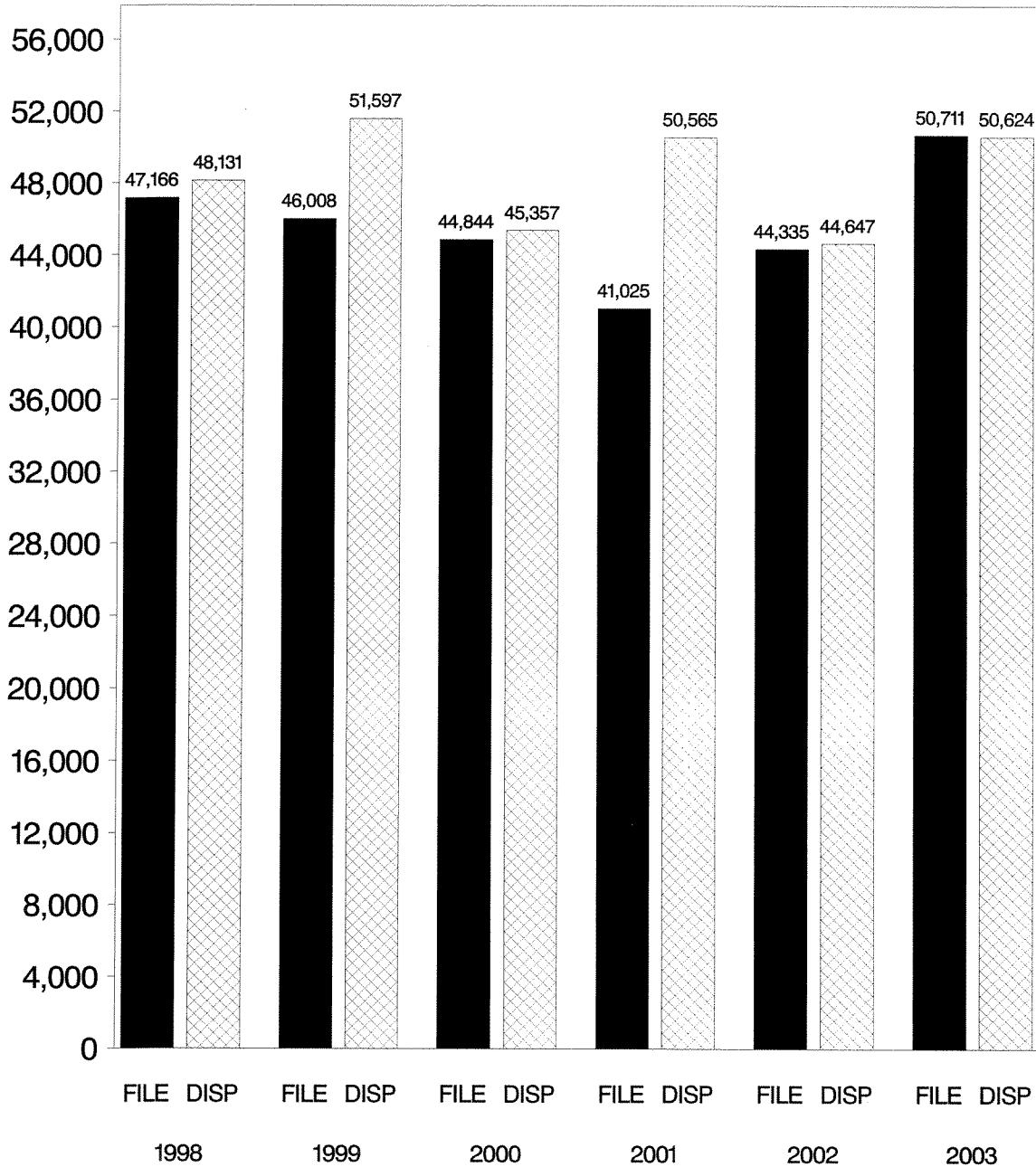

### CASES FILED AND DISPOSED

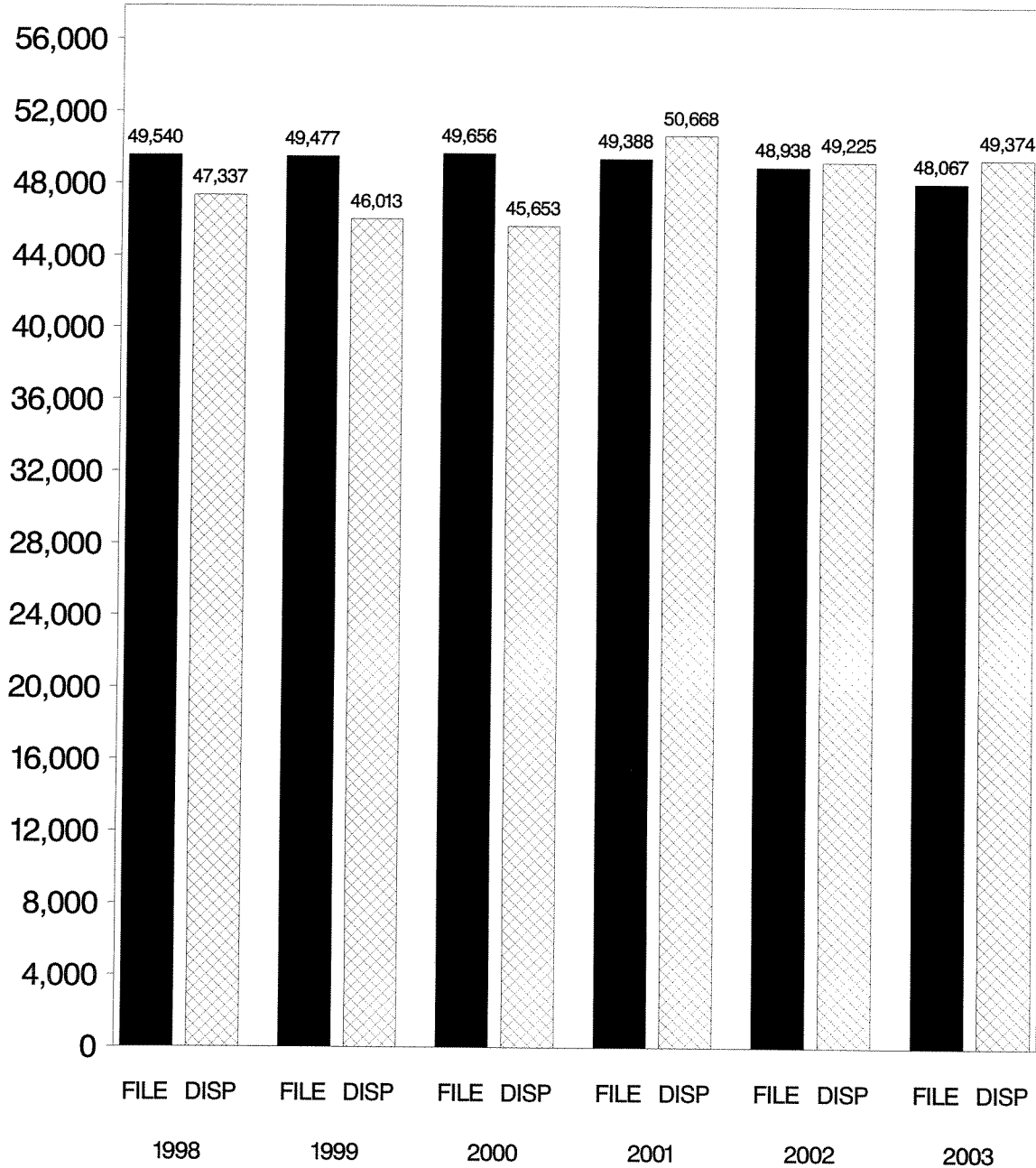
