

JUSTICE OF THE PEACE COURTS

Narrative Summary

Justice courts experienced a decrease in total filings (including transfers in) in FY 99, from 816,775 to 790,234. This is a decrease of 3.2%. Beginning in FY 96, justice courts reported Non-Criminal Local Ordinances as a separate category. Many of these were reported as part of other categories in the previous years, but their numbers are not comparatively large.

Traffic filings (criminal and civil), which accounted for 62.5% of the workload in justice courts, went from 514,146 to 493,957, a 3.9% decline from FY 98 to FY 99. Non-Traffic criminal filings (misdemeanors and felonies) decreased 5.3%, from 171,488 last year to 162,321 in FY 99. Civil filings were up slightly from 126,715 in FY 98 to 128,540 this year, an increase of 1.4%.

Petitions for orders of protection relating to domestic violence decreased this year by 3.2%, from 8,234 in FY 98 to 7,969. Last year the trend showed an increase of 5.1% from FY97 to FY98 in this case type. In FY 98 petitions for injunctions against harassment decreased from 8,419 in FY 98 to 8,264 in FY 99, a decrease of 1.8%.

Total dispositions (including transfers out) decreased 1.9%, from 755,154 last year to 740,842 in FY 99. Criminal and civil traffic dispositions together decreased by 4.5%, from 494,266 to 472,076. Criminal dispositions (misdemeanors and felonies) decreased by 0.6%, from 137,192 in FY 98 to 136,417 in FY 99. Civil dispositions increased by 6.5%, from 119,265 to 127,051.

Total end of year pending cases increased from 496,737 in FY98 to 528,576 in FY99, an increase of 6.4%. Most of the increase was in misdemeanors, which increased from 193,049 in FY98 to 210,229 in FY 99, an increase of 8.9%.

Court trial statistics for some courts may not be comparable to previous years due to differences in data collection techniques.

Some of the FY 98 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

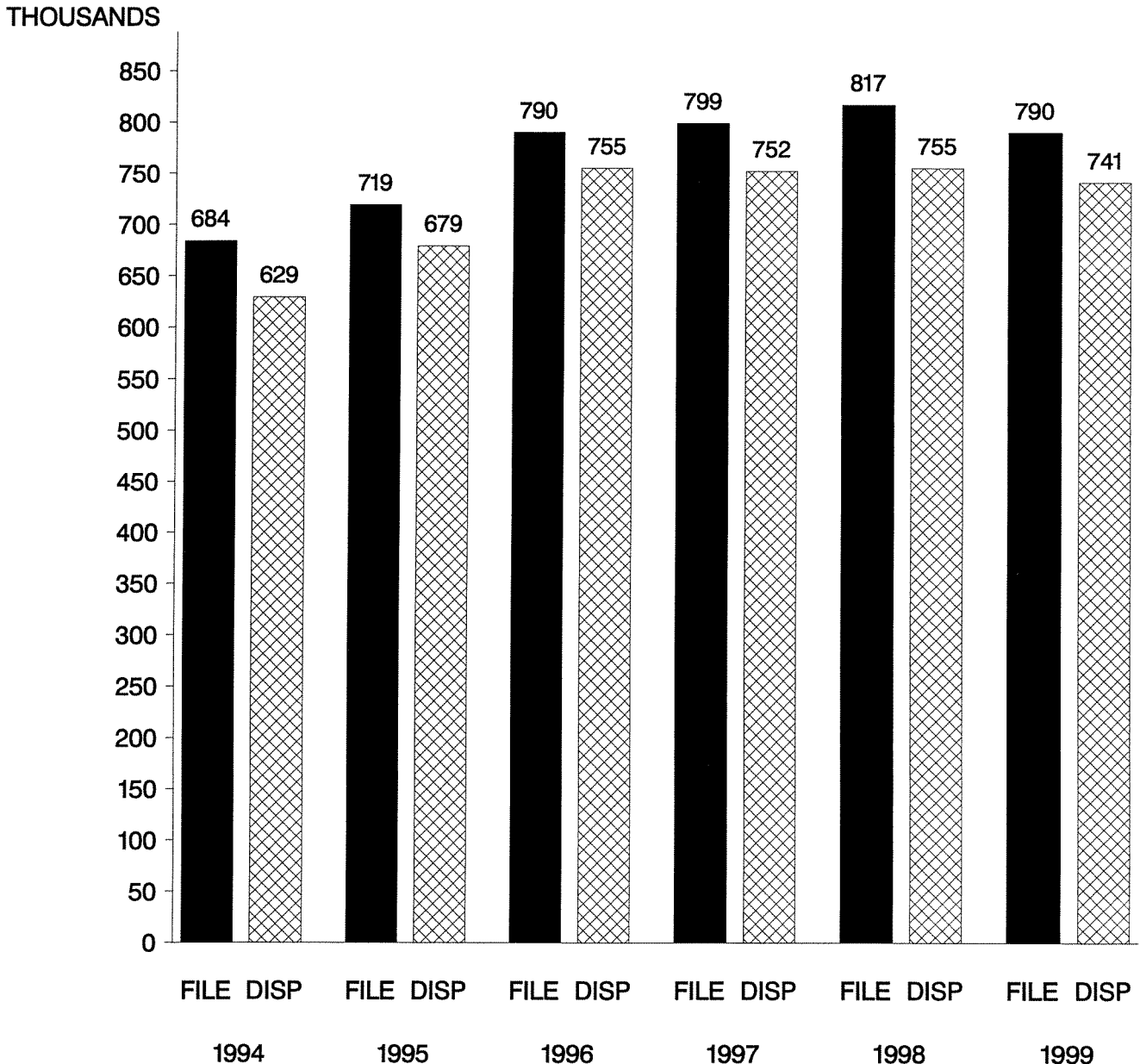

ANNUAL CASE ACTIVITY, FY 1994 – 99

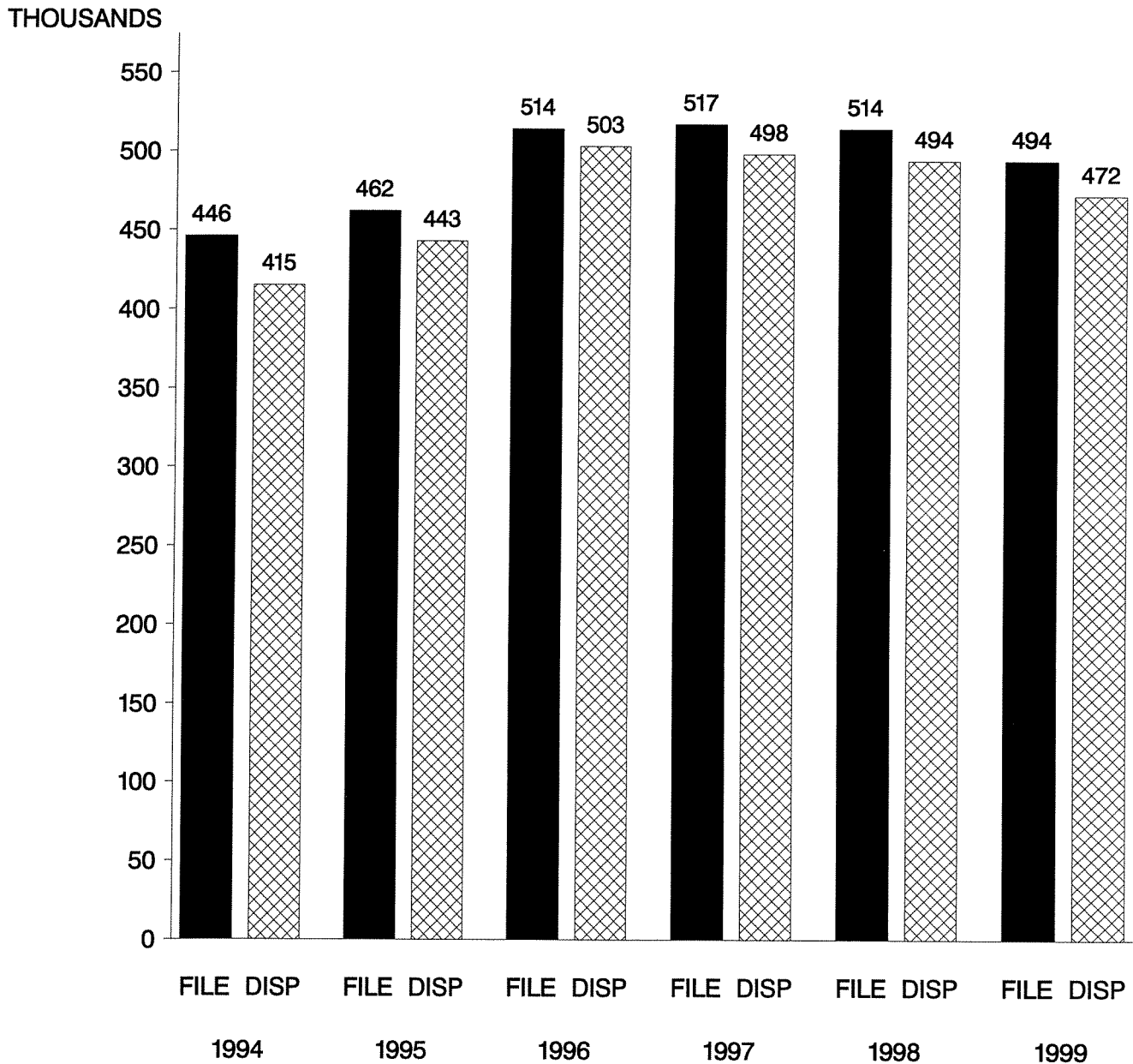

TRAFFIC CASE ACTIVITY, FY 1994 – 99 CASES FILED AND DISPOSED

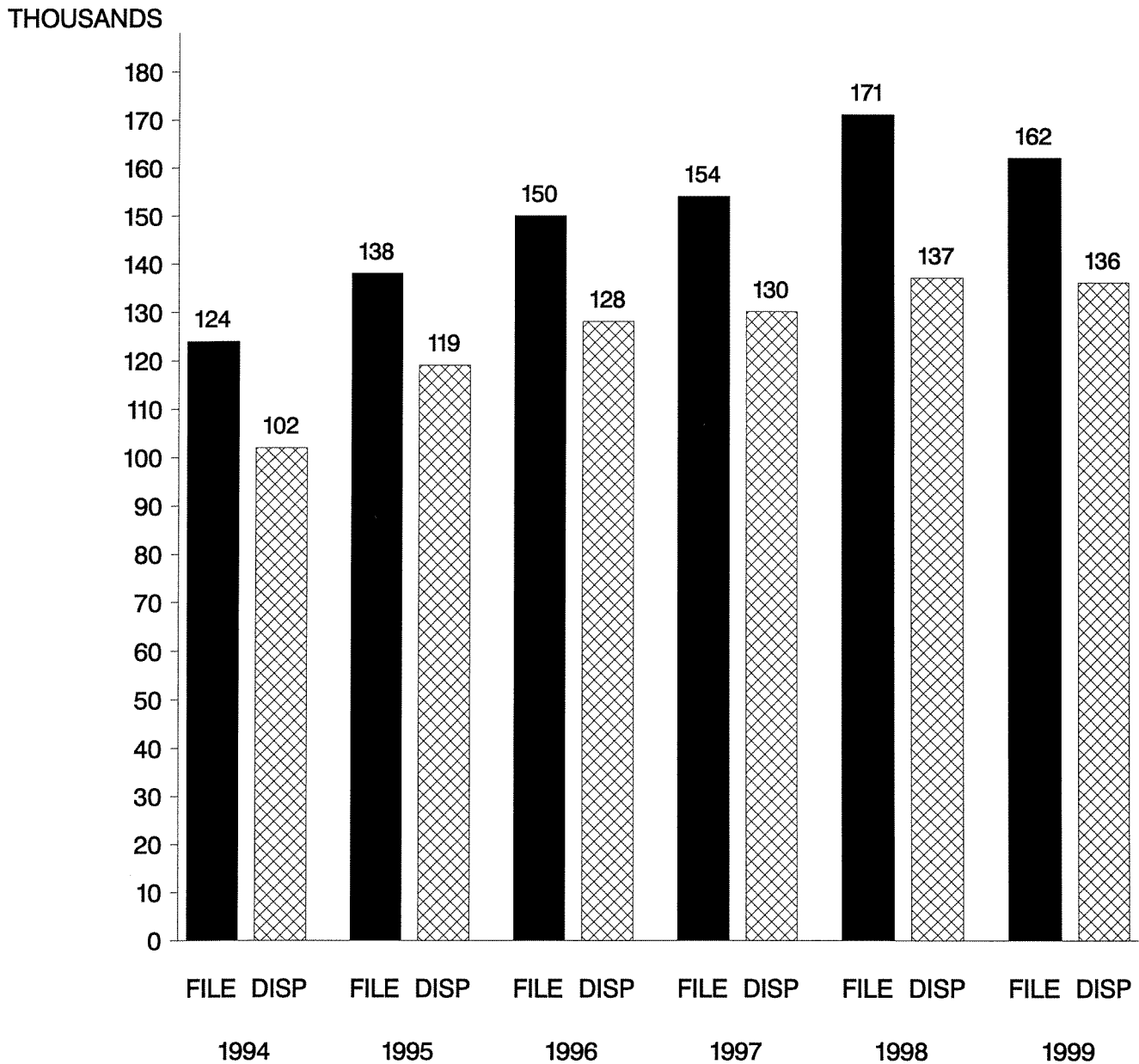

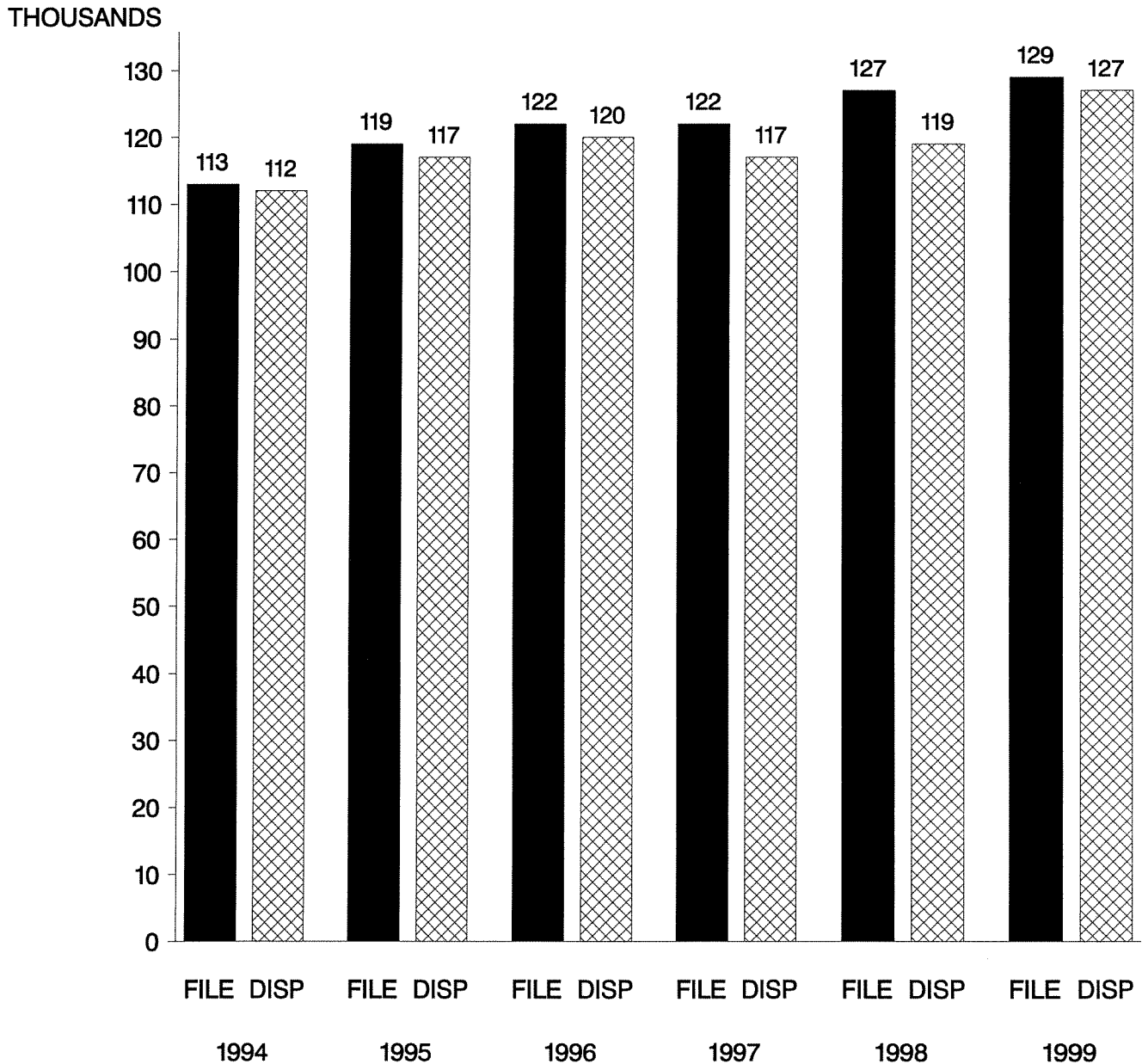

CIVIL CASE ACTIVITY, FY 1994 – 99

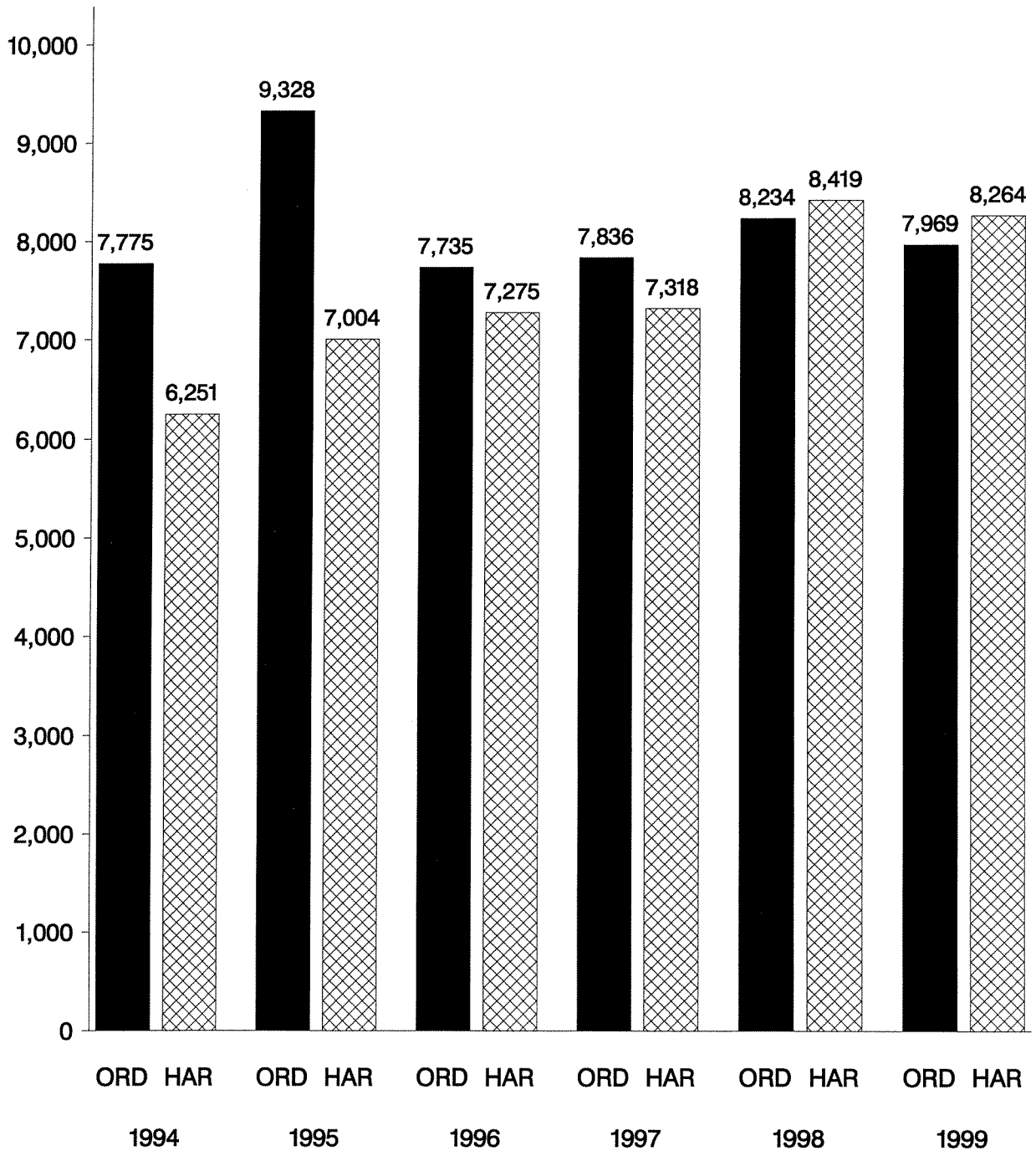
CASES FILED AND DISPOSED
