

ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive)** Case Activity, the second covers **Standard Adult Probation** alone, and the third only **Intensive Adult Probation**. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second table concerns **Probationers with Petitions to Revoke**, and the third table summarizes **Additional Probation Activity**.

There were a total of 43,071 individuals added to **standard and intensive** probation during FY 2001, including 8,957 absconders. During the same period, 41,188 probationers were terminated, of which 7,291 were absconders. As of the end of FY 2001, there were 36,405 active standard and intensive probationers and 10,121 absconders in Arizona, a total of 46,526 individuals. There were 14,337 petitions to revoke probation filed during the year, 14,924 terminated, and 1,849 pending at the end of the year. Additionally, probationers completed 1,687,206 community service hours in FY 2001 (3.1% less than last year), and probation officers completed 29,816 presentence reports (up 15.8% over FY 2000) and collected \$34,272,233 in restitution, fines, surcharges, fees, reimbursements, and taxes from probationers (a 3.9% rise from FY 2000).

There were 35,464 persons placed on **standard** probation in FY 2001, which includes 7,448 absconders. During the year, 33,685 standard probationers were terminated, including 5,881 absconders. On June 30, 2001, 33,021 people were on active standard probation and 9,158 were absconders from standard probation, equaling a total of 42,179 individuals. A total of 10,630 petitions to revoke probation were filed in FY 2001; 11,410 petitions were terminated, and 1,357 were pending on the last day of the fiscal year. In addition, standard probationers completed 759,643 community service hours and paid a total of \$29,300,464 monies owed to the court.

Additions to **intensive** probation numbered 7,607 during FY 2001, of which 1,509 were absconders. Also during FY 2001, 7,503 intensive probationers were terminated, including 1,410 absconders. At the close of the fiscal year, there were 3,384 active intensive probationers and 963 intensive probation absconders, totaling 4,347 persons. In all, 3,707 petitions to revoke probation were filed and 3,514 petitions were terminated during the year, leaving 492 pending at the end of the year. Intensive probationers completed 927,563 hours of community service and paid \$4,971,997 in fines, restitution, and other monies.

Some of the FY 2000 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.
