

## MUNICIPAL COURTS Narrative Summary

After a five year rise in filings, Municipal Courts showed a decrease in filings in FY 2000. Total filings (including transfers in) decreased from 1,448,325 in FY 1999 to 1,420,683 in FY 2000, a decrease of 1.9%.

Traffic filings (criminal and civil), which comprise 73.9% of Municipal Court case activity, dropped 1.4% from last year, from 1,064,949 to 1,049,867. Within the traffic category, criminal filings increased while civil filings decreased from FY 1999 to FY 2000. Misdemeanors (excluding criminal traffic) dropped from 230,792 to 212,518 in FY 2000, a decrease of 7.9%.

From FY 1999 to FY 2000, Municipal Courts experienced an increase in the number of petitions filed for injunctions against harassment and a decrease in orders of protection filed. During FY 2000, a total of 10,278 petitions were filed for an order of protection, compared with 10,338 last year, a decrease of 0.6%. In contrast, petitions for an injunction against harassment rose from 8,162 last year to 8,302 in FY 2000, an increase of 1.7%.

Total dispositions (including transfers out) dropped sharply from 1,394,393 last year to 1,283,063 in FY 2000, a decrease of 8.0%. Total traffic dispositions (criminal and civil) decreased by 9.4% from 1,057,603 in FY 1999 to 957,956 in FY 2000. Misdemeanor dispositions decreased by 5.5%, from 207,438 in FY 1999 to 195,979 in FY 2000.

Non-criminal local ordinances case filings increased by 3.7% from 152,584 in FY 1999 to 158,298 in FY 2000. Non-criminal local ordinances terminations showed only a slight decrease of 0.2%, from 129,352 in FY 1999 to 129,128 in FY 2000.

Finally, the total end of year pending increased sharply from 716,636 in FY 1999 to 870,932 in FY 2000, an increase of 21.5%. The largest increase was reported in civil traffic which increased from 172,208 in FY 1999 to 246,424 in FY 2000, an increase of 43.1%.

**Note: Data for orders of protection and injunctions against harassment in some courts may not be comparable to previous years due to changes in computer systems and data entry requirements.**

**Some of the FY 1999 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.**

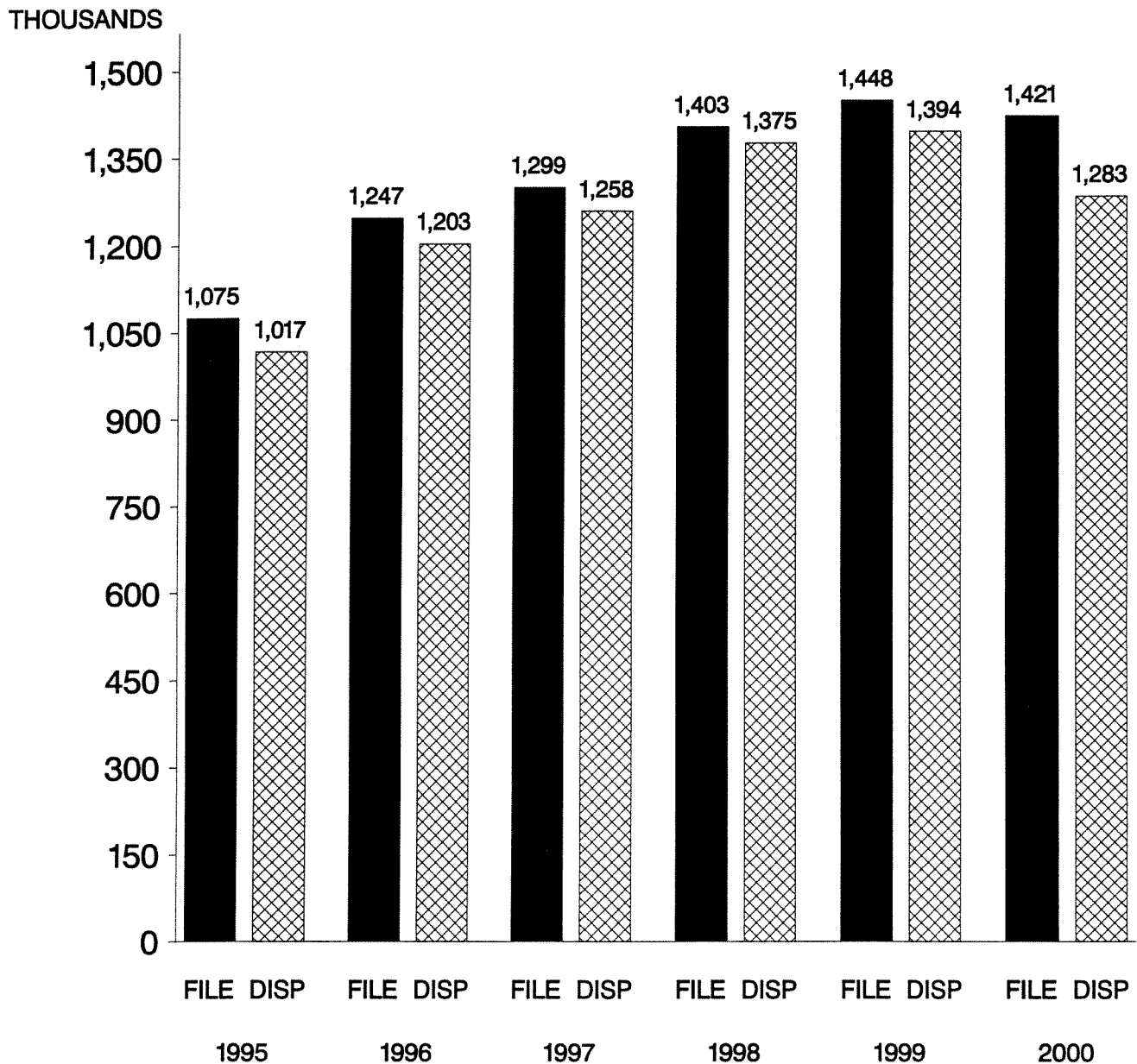

## ANNUAL CASE ACTIVITY, FY 1995 – 2000

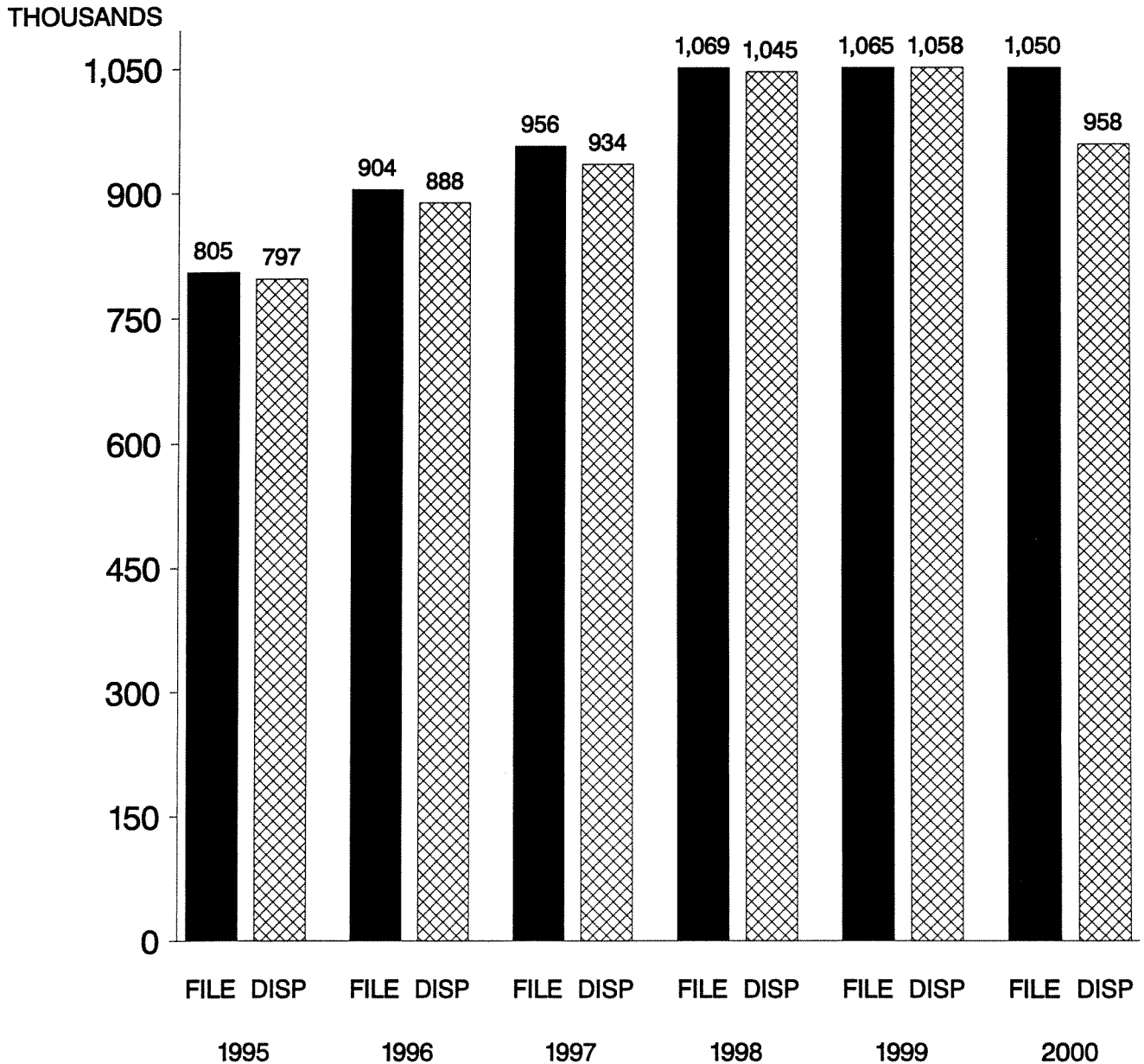

## TRAFFIC CASE ACTIVITY, FY 1995 – 2000 CASES FILED AND DISPOSED

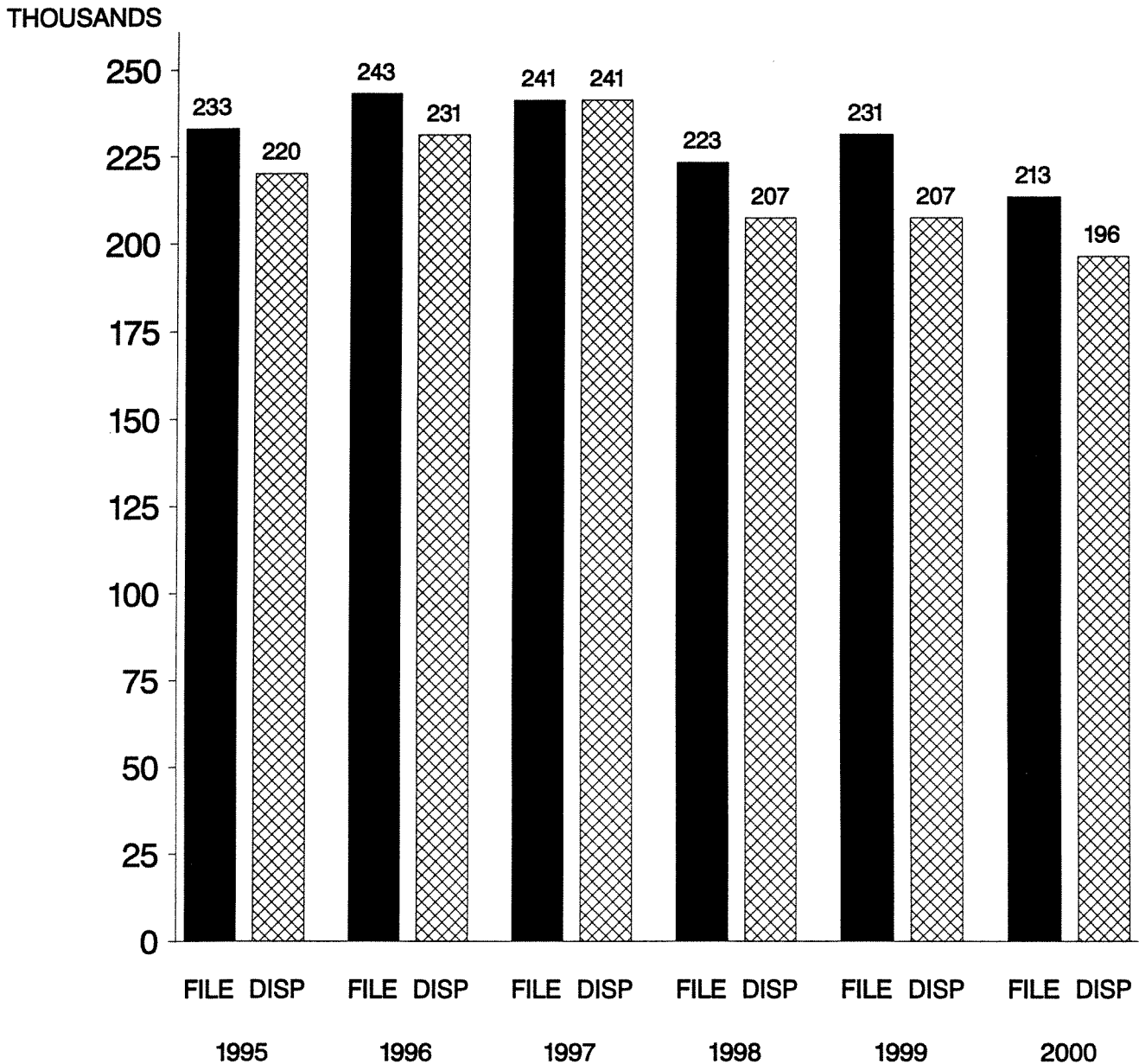

### CASES FILED AND DISPOSED

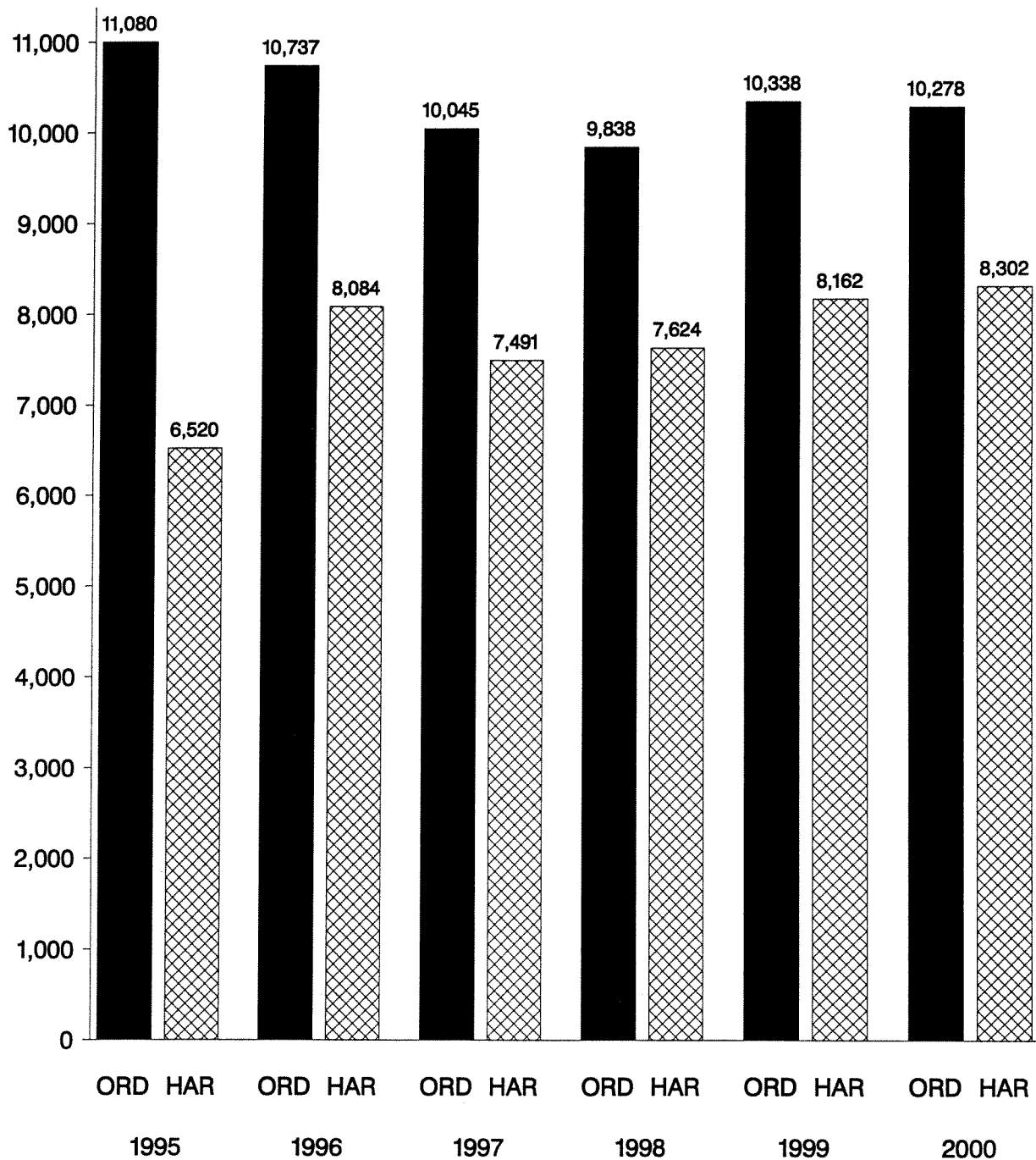
