

LIMITED JURISDICTION COURTS

Narrative Summary

This section combines data from both Justice of the Peace and Municipal Courts and presents them statewide and by county. These data are intended for users who are concerned only with types of limited jurisdiction cases, irrespective of the specific court in which they occurred. Justice of the Peace and Municipal Courts are examined individually in subsequent sections.

Total filings (including transfers in) decreased 0.5% in FY 2001, from 2,269,396 last year to 2,257,790. Traffic cases comprised the majority (69.6%) of the filings in Limited Jurisdiction Courts. Total traffic filings (criminal and civil) decreased by 1.3%, from 1,593,025 last year to 1,572,450 in FY 2001. Criminal filings (misdemeanors and felonies) increased by 0.6%, from 378,509 in FY 2000 to 380,926 in FY 2001.

Continuing the upward trend from the last three years, petitions for orders of protection in domestic violence cases increased from 18,425 in FY 2000 to 19,948 in FY 2001, an increase of 8.3%. Petitions for injunctions against harassment decreased slightly, from 16,871 in FY 2000 to 16,676 in FY 2001, a decrease of 1.2%.

Total dispositions (including transfers) increased by 5.7%, from 2,069,899 last year to 2,188,547 in FY 2001. Traffic dispositions (criminal and civil) increased by 4.7% while criminal dispositions (misdemeanor and felony) rose by 6.0% from last year. Only 8.7% of the orders of protection and 13.5% of the harassment petitions ruled upon were denied.

Total end of year pending cases increased from 1,426,618 in FY 2000 to 1,468,661 in FY 2001, an increase of 2.9%. Most of the increase was in civil traffic, which increased from 381,498 in FY 2000 to 435,874 in FY 2001, an increase of 14.3%.

Note: Data for orders of protection and injunctions against harassment in some courts may not be comparable to previous years due to changes in computer systems and data entry requirements.

Some of the FY 2000 figures may not correspond to figures published in last year's Data Report due to corrected information received subsequent to publication of the Report.

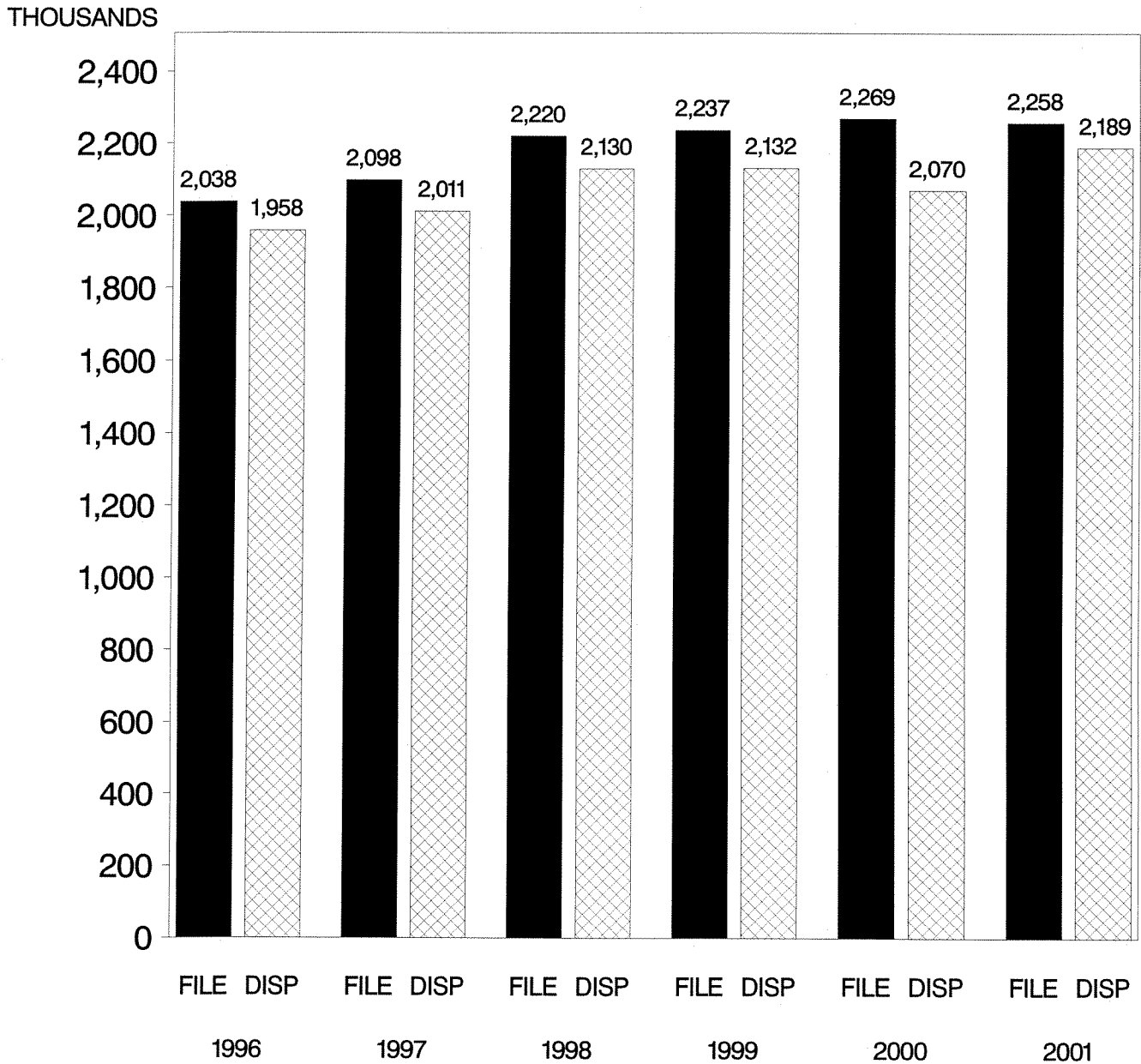

CASES FILED AND DISPOSED



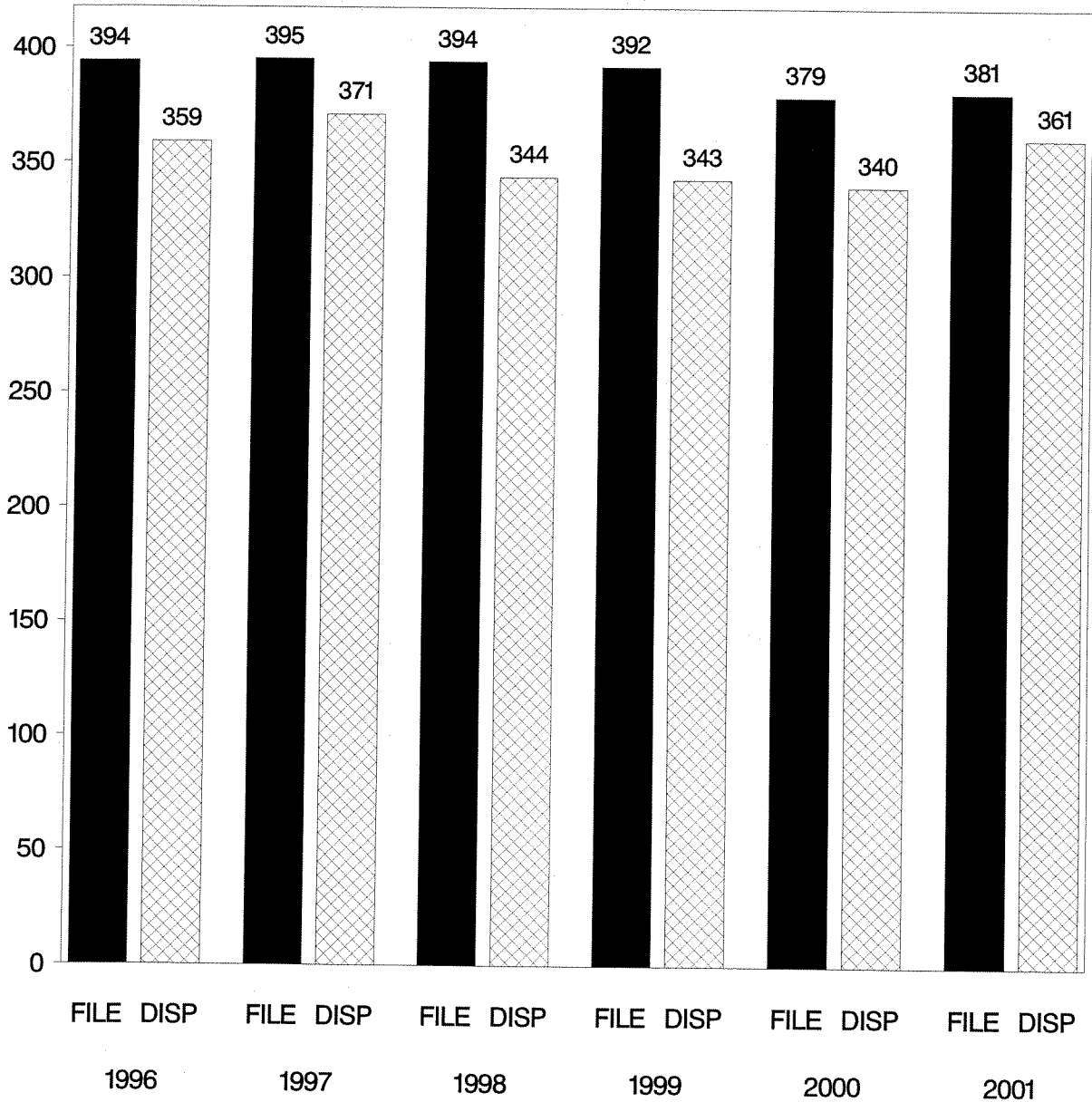

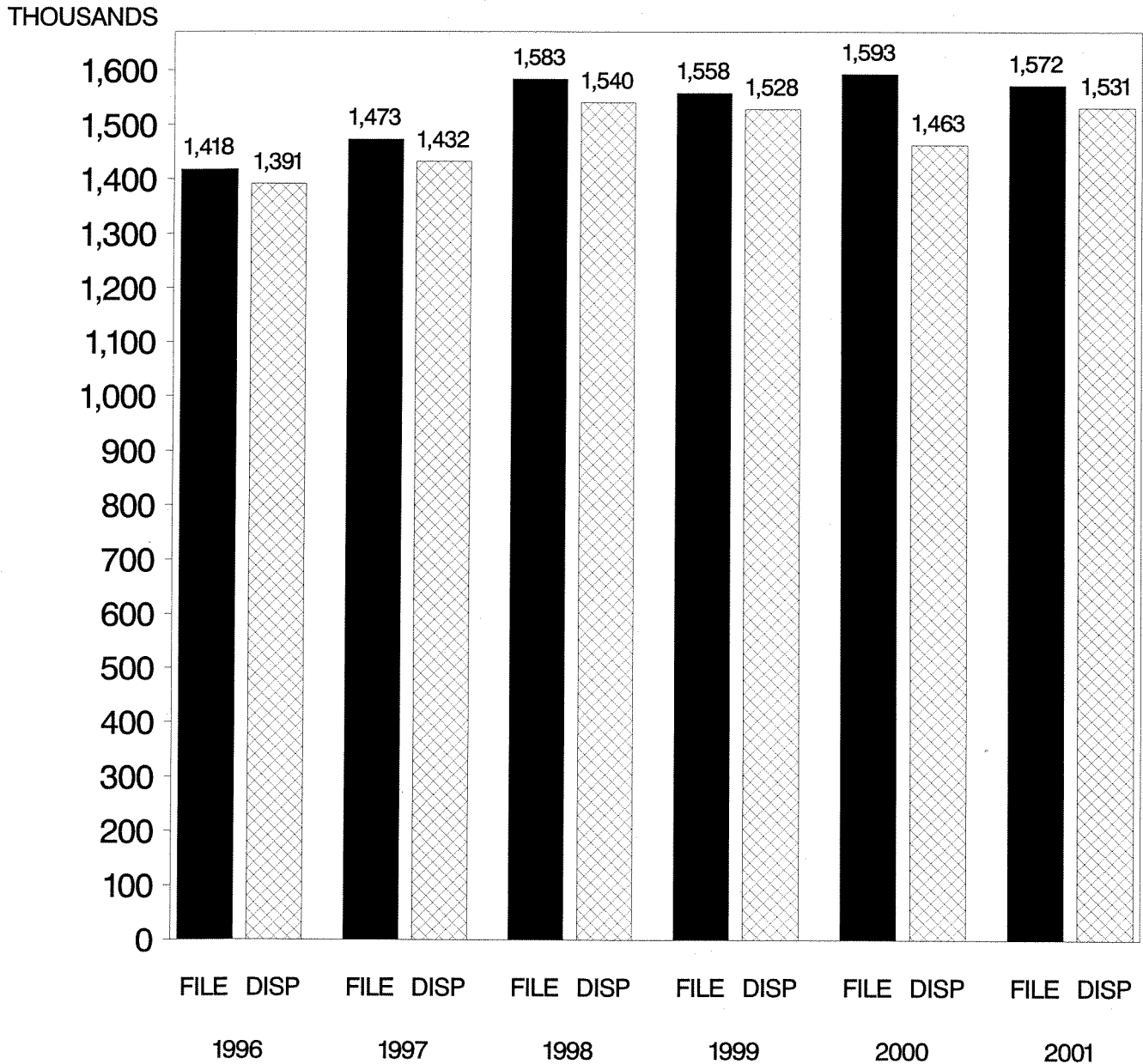

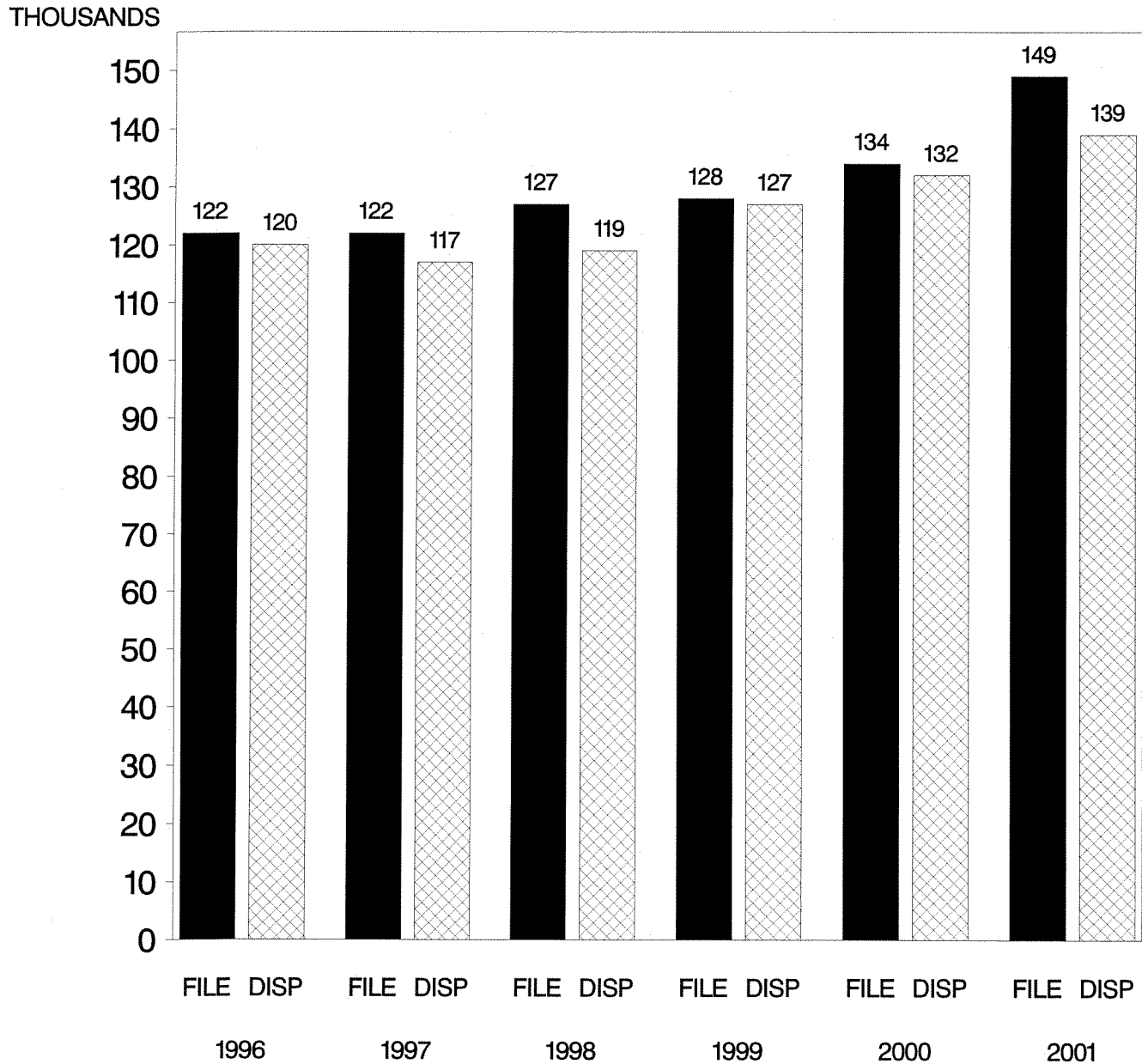

COMBINED CIVIL CASE ACTIVITY, FY 1996–2001

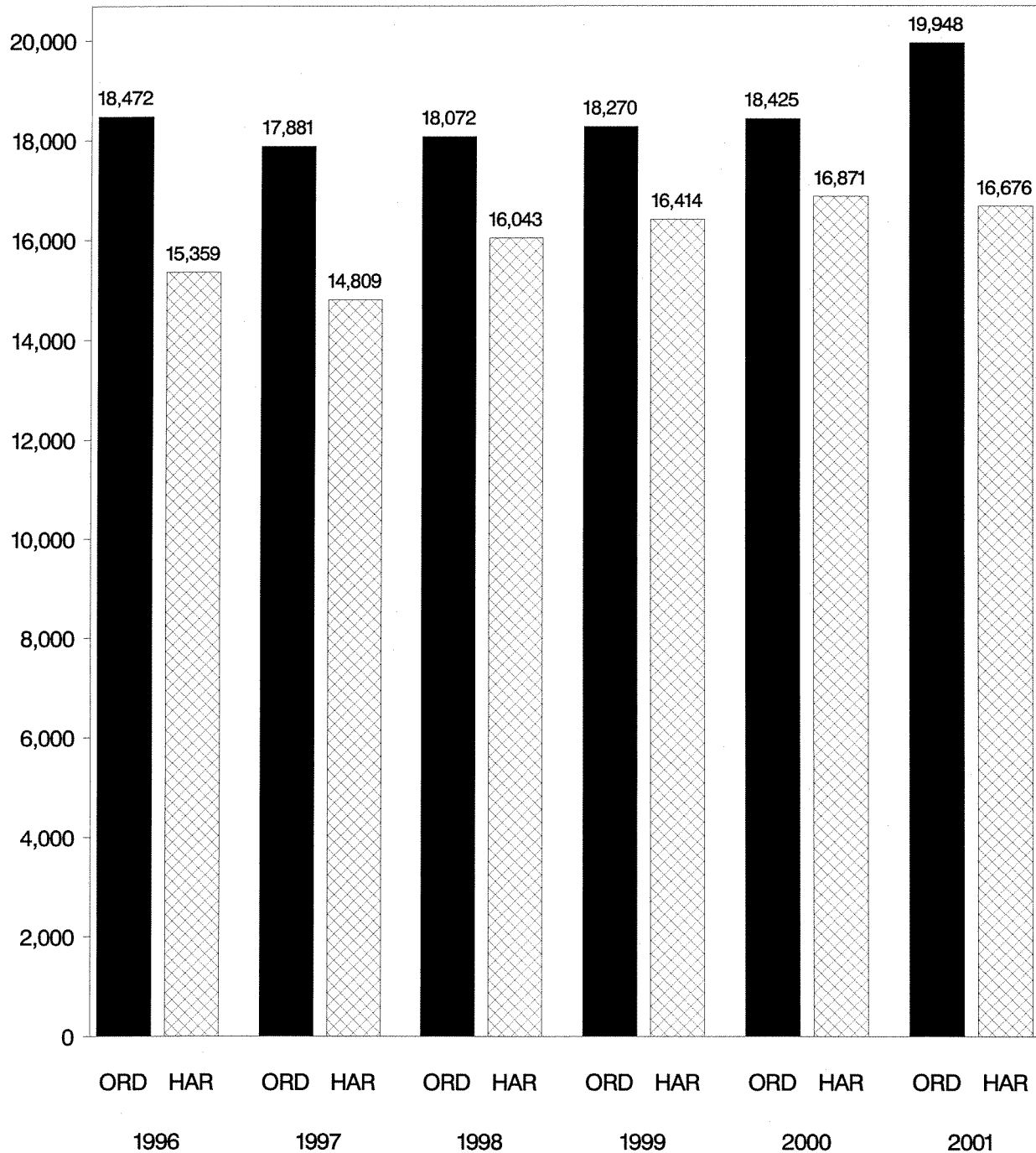
