

ADULT PROBATION Narrative Summary

There are **three pages** of tables for statewide and county adult probation activity. The first page is the **Total Adult Probation (Standard and Intensive)** Case Activity, the second covers **Standard** Adult Probation alone, and the third only **Intensive** Adult Probation. On each page there are **three tables**. The first table concerns the general **Probation Population** (active and absconders), the second Probationers with **Petitions to Revoke**, and the third summarizes **Additional Probation Activity**.

There were a total of 32,066 individuals added to **standard and intensive** probation during FY 1999, including 6,787 absconders. During the same period, 28,047 probationers were terminated, of which 5,370 were absconders. As of the end of FY 1999, there were 36,317 active standard and intensive probationers and 8,172 absconders in Arizona, a total of 44,489 individuals. There were 13,533 petitions to revoke probation filed during the year, 17,474 terminated, and 8,856 pending at the end of the year. Additionally, probationers completed 1,482,350 community service hours in FY 1999 (20.1% over last year), and probation officers completed 26,243 presentence reports (down 5.3% over FY 1998) and collected \$28,733,030 in restitution, fines, surcharges, fees, reimbursements, and taxes from probationers (a 29.0% rise from FY 1998).

There were 26,118 persons placed on **standard** probation in FY 1999, which includes 6,110 absconders. During the year, 22,718 standard probationers were terminated, counting 5,027 absconders. On June 30, 1999, 32,916 people were on active standard probation and 7,366 were absconders from standard probation, giving a total of 40,282 individuals. A total of 9,812 petitions to revoke standard probation were filed in FY 1999, 14,466 petitions terminated, and 7,689 pending on the last day of the year. In addition, standard probationers completed 488,695 community service hours and collected a total of \$23,308,833 owed the court.

Additions to **intensive** probation numbered 5,948 during FY 1999, of which 677 were absconders. Also during FY 1999, 5,329 intensive probationers were terminated, including 343 absconders. At the close of the fiscal year, there were 3,401 active intensive probationers and 806 intensive probation absconders, totaling 4,207 persons. In all, 3,721 petitions to revoke intensive probation were filed and 3,008 petitions terminated during the year, leaving 1,167 pending at the end of the year. Intensive probationers also completed 993,655 hours of community service and collected \$5,424,198 in fines, restitution, and other monies.
