#### **ORDER**

May 17, 2024

The Complainant alleged a superior court judge pro tem made improper rulings in a civil case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Michael J. Brown did not participate in the consideration of this matter.

The following week on the Courts Clerk violated my rights to due process when they refused to file my motion for a Change of Venue if I didn't pay the filing fee in advance. I told the clerk under Arizona law I had to pay it after transmittal of record, She went to ask about it in the back office and when she came she said they said that's the way we do it here. I paid it and filed my motion. During this time I had to deal with the county offices after I filed a complaint against my brother for two illegal septic systems in the and a complaint with code enforcement. After all this time neither department has done their job, pushing me off each time I contact them by saying they have to talk to their lawyer. I also had to deal with the County Attorney's office on several occasions after I was assaulted by my brother. He also damaged my personal property, at that time I got an Order of Protection against my brother. which he broke. I contacted the sheriffs office and the deputy refused to come out and take photographic evidence that I told him I had. When I talked to the deputy again I was very angry and remarked that the county attorneys office didn't need another investigation referring to an incident when a murder suspect was released after the county attorney violated his constitutional rights. It seems I really pissed of this county who happens to be all are related and and the Judge
