**ORDER**

May 31, 2024

The Complainants alleged improper rulings by a municipal court judge in a post-conviction relief case and contempt proceeding.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Regina L. Nassen and Christopher P. Staring did not participate in the consideration of this matter.

We began a custody case concerning my grand daughter and her mother . wanted to gain full custody of her daughter after sharing custody with my son and I after years for the freedom of this teenager to have no type of guidance from her father and grandparent and for to gain funds from a car accident fraudulently.

ignored all of the truth; at times if you opposed and brought up the true issues of the matters she would send you out of the court room like a child and bring you back in when she wanted to intimidate you more. We went thru years of that battle. We have not seen or heard of this child now for years, the Mother promotes no type of communication from the child, no school, no medical records, and no type of phone calls. caused us alot of hardship and most of all heartbreak.

This court battle lasted during covid in which all communication per the court was all thru emails.

then filed for an Order of Protection; the court not paying any attention of order and it recites parties are to communicate about the child thru emails. She then files a police report saying there's a violation due to an email. When did this she called Officer to her home; during their conversation they mention a death threat regarding myself and my son of which the provided the video which I can furnish. then gets involved so they can collect a fine against my son. Because of this death threat there is a

Police Department refused to enforce the prior court order but got involved anyway in fact violating by a death threat that's recorded and received.

The additional hell and journey begins.

The case ends up with Judge , I was in the court room, actually brought up this incident to him. He totally ignored it; just like he did with every motion filed for my son's case. He sentenced my son and with a fine; brought him into court several times later just to see if he could violate him. The court assigned legal counsel who did nothing to represent my son and of which ignores the attorney. at this point should have never been involved.

Instead of either court seeking the truth and justice and how fraudulent is and has been; Judge then continues to abuse and harrass my son.

practices no type of law or ethics during his court room sessions. He shows nothing but bias and prejudice toward my son. From what I see he has violated my son's First Amendment Rights, Fifth and Sixth Amendment rights as well. He sent this recent contempt and summons without discovery. Double jeopardy!

I find the Presiding Judge at fault as well since he is supposed to be presiding over the court and in charge.

The so called Prosecutors of the are a joke as well; they sling garbage to the so called Judges and hope it sticks just to cause harm to families and collect money from the population of the who are already dying to survive with the high costs of living. My son has a family and struggles each month to pay per month in rent and yet this Judge threatens him with jail time and contempt.

Every single motion that was filed with the court was NEVER answered or addressed; in fact acted like they were never filed but mentioned them in his hearings. ALL MOTIONS ARE IGNORED!!

maintains and enforces high standards of conduct and observes those standards and that the integrity and independence of the judiciary be preserved. All ethics, judicial conduct and codes of conduct are violated and violations are pursued by Judge and Judge of County Court.
